Subject: Fire Chief's Report - Commission Meeting November 19, 2024

The following is the Fire Chief's report for the upcoming commission meeting. The report highlights information pertinent to the city's main public safety concerns: Fire Rescue Incidents, Fire Apparatus / Station concerns, Fire Prevention, Community Outreach, and CERT.

I. FIRE / RESCUE INCIDENT REPORT FOR OCTOBER 2024.

Longest Emergent Response Time: 13:19 Average Response Time: 05:42

The longest emergent response was recorded as 13:19 seconds but the delay was in noting the actual arrival time of the rescue unit. The second longest response was 11:58 which was due to the distance to the incident (Sheridan Street and Pine Island Road) and midday traffic. There were two (2) other outliers with delays of 9:45 which were due to distance (Sheridan Street and University Drive) and rush hour traffic and 9:26 which was due to a mechanical issue which caused the unit to swap out into a reserve rescue unit for necessary repairs.

I. FIRE APPARATUS / STATION REPORT

Rescue 228 was swapped into a Reserve to affect repairs. To date, Cooper City Rescue 228 is still in for repairs, waiting on a gear for the onboard air compressor and the installation of a shore "umbilical" air connection to keep the unit's air reservoir at capacity.


