RESOLUTION NO. R 2025-189

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, APPROVING THE COOPER CITY RESIDENTIAL OR COMMERCIAL WATER SERVICE AGREEMENT AND STATEMENT OF UNDERSTANDING; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town and Cooper City have been in discussion concerning Cooper City, on a case by case basis, being authorized to provide water service to select Town of Davie properties;

WHEREAS, certain Town of Davie property owners not currently being serviced by the Town of Davie Utility Department have reached out to the Town to be allowed to receive Cooper City water;

WHEREAS, the Town Council deems it in the best interest of its residents to allow select properties, on a case by case basis, request to receive water from Cooper City.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE THAT:

Section 1. Legislative Findings/Recitals. The above recitals are hereby adopted by the Town Council of the Town of Davie as its legislative findings relative to the subjects and matters set forth in this Resolution.

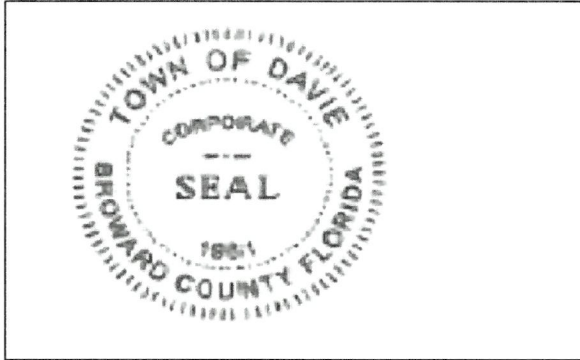
Section 2. The Town Council of the Town of Davie does hereby approve the Cooper City Residential or Commercial Water Service Agreement and the Statement of Understanding. The Town Administrator, or designee, is hereby authorized to approve and execute the Cooper City Residential or Commercial Water Service Agreement on behalf of the Town and any ancillary documents.

Section 3. Severability. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, it is the intent of the Town Council that such invalidity shall not affect other provisions or applications of the Resolution which can be given effect without the invalid provision or application and, to this end, the provisions of this Resolution are declared severable.

Section 4. Conflicts. All resolutions or parts of resolutions in conflict with any of the provisions of this Resolution are hereby repealed.


Section 5. Effective Date. This Resolution shall take effect on effect immediately upon its passage and adoption.
