SECTION 1. The recitations set forth in the above "WHEREAS" clauses are true and correct and incorporated herein by this reference.

SECTION 2. CONTRACTOR shall be compensated at a rate of \$150 per hour, in accordance with the compensation and payment method set forth in Section 4.1 of the Original Agreement. The total compensation for this Second Amendment shall not exceed \$45,000.

SECTION 3. The terms and conditions of the Original Agreement shall remain in full force

and effect, except as specifically amended herein. In the event of any conflicts between this Second Amendment, the First Amendment and the Original Agreement, this Second Amendment shall prevail.
