SUBJECT: Franklin Agreement for School Traffic Use

CITY MANAGER RECOMMENDATION:

The City Manager is recommending a discussion and action to move forward with a renewal agreement with Franklin Academy Foundation, Inc. The agreement would be for purposes of Franklin Academy to utilize the parking lot at Flamingo West Park for school drop off and dismissal.

BACKGROUND OF ITEM:

Franklin Academy, is located at 6301 South Flamingo Road, Cooper City. Adjacent to the school is the city-owned facility, Flamingo West Park, 6201 South Flamingo Road. The traffic for the school, relative to drop off and pick up, has presented an impact to traffic flow on South Flamingo Road. At the recommendation of the Broward Sheriff’s Office, the school traffic flow has been staged through a traffic pattern in the parking lot of Flamingo West Park.

ANALYSIS:

Through the last two school years, the traffic pattern has been rerouted through Flamingo West Parking lot and this has greatly improved the flow of traffic on South Flamingo Road.

STRATEGIC PLAN:

Coordinating with the schools helps create a Strong Sense of Place, which is identified within the third priority. Working with the schools helps foster community pride and increases social interactions.

FISCAL IMPACT:

For the previous school years, there has been no fiscal monies received from the licensee and no fiscal monies paid from the City.
