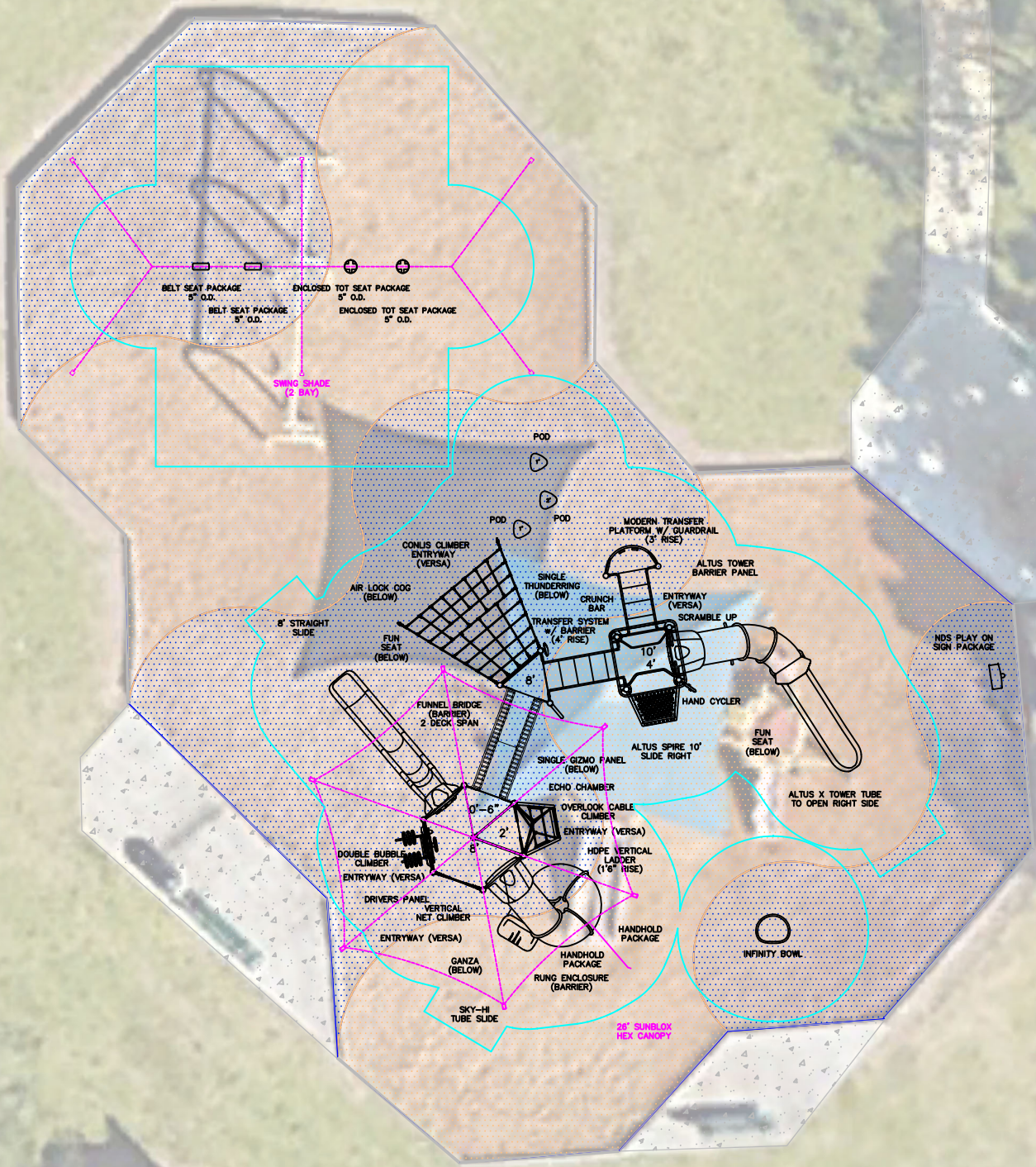
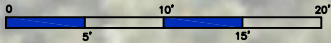

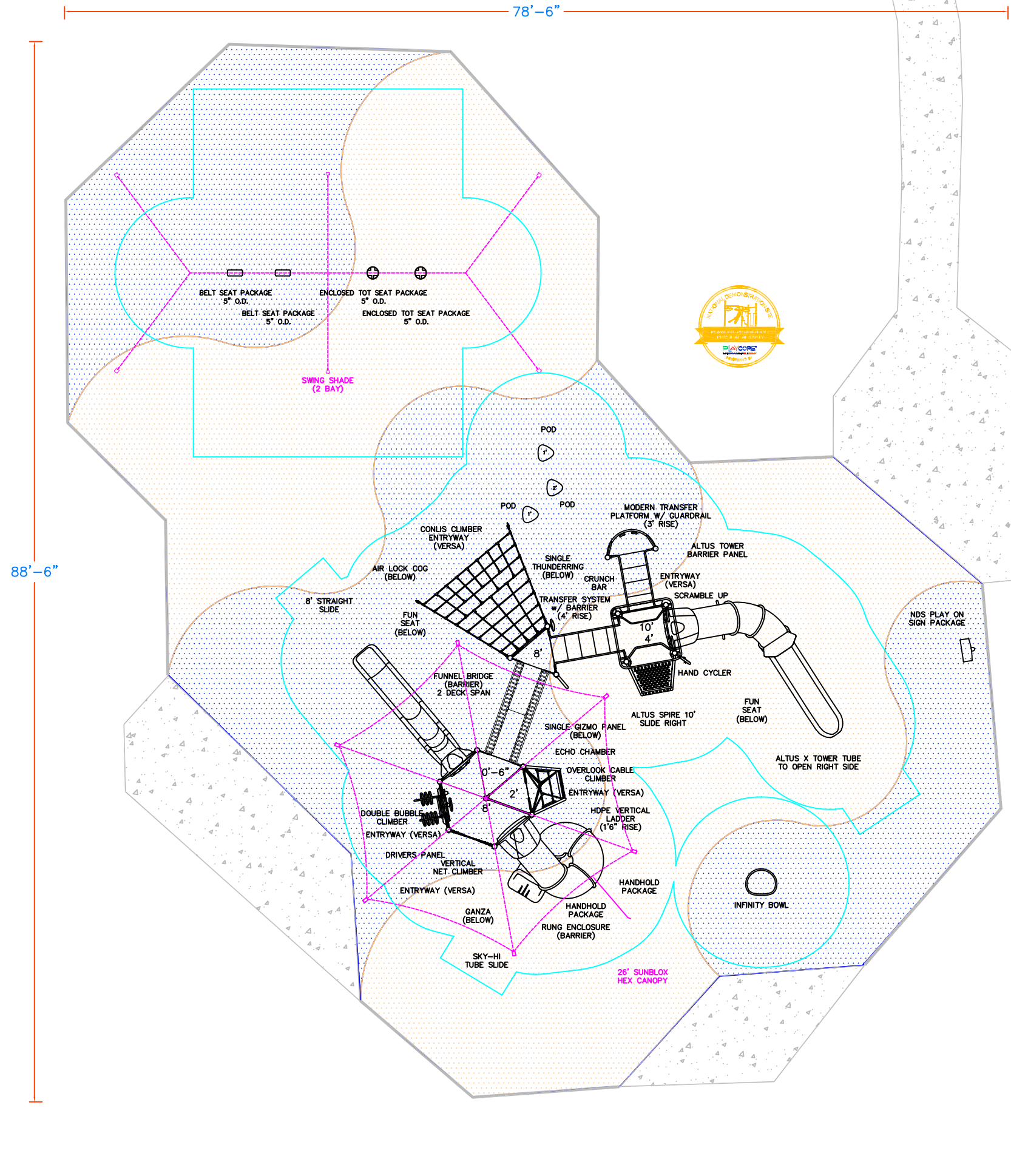

Orders from **governmental agencies, school districts, municipalities, and other public entities** may be accepted with a purchase order, signed quotation, or written authorization. Payment terms are Net 30 unless otherwise stated. Deposit requirements may apply for **custom or made-to-order products**, including Landmark Designs items.

When installation is included as a **turn-key project**, payment for installation-related work is due **upon completion and acceptance of the work**, unless otherwise stated. Installation Terms: Installation, when included, is performed by an **independent, certified installer** and is based on **standard installation conditions**. Installation assumes suitable soil, normal excavation conditions, proper sub-base, and unrestricted site access. The following are **excluded unless expressly stated**: drainage design or correction; soil remediation or import/export; rock, roots, debris, or concealed conditions; dewatering; erosion control; sod replacement; landscaping; irrigation repair; and site restoration. If unsuitable soil, drainage issues, high water table, or concealed conditions are encountered, **additional costs may apply**. The owner is responsible for site readiness, utility marking, site access, and protection of the work area before, during, and after installation.

Unitary Surfacing : Unitary surfacing (poured-in-place rubber, synthetic turf, or tiles) is installed by a **specialty surfacing contractor**. When included with playground installation, the playground installer will **coordinate scheduling** with the surfacing installer and will usually prepare the sub-base as part of the standard scope (quote will be noted if sub-base by others). The following are **excluded unless expressly stated**: drainage design or correction; base remediation due to unsuitable soils; security, fencing, or barricades; and protection of surfacing after installation. The owner is responsible for **site access and protection of the surfacing before, during, and after installation**, including preventing traffic, vandalism, or damage while materials cure. Repairs required due to damage, weather, or vandalism conditions are not included.

Shade Terms : Shade structures are engineered and manufactured for the actual project location, including applicable building codes and design wind loads based on the local codes. Shade installation is a **heavy construction activity** and may require **large concrete footings, excavation, and crane or specialty equipment access**. Adequate site access, staging area, and clearance must be provided by the owner. The following are **excluded unless expressly stated**: sod replacement; landscaping or irrigation repair; site restoration; drainage correction; removal of existing structures; and repair of access paths or staging areas impacted during installation.

Once installation is complete and the installer has **demobilized from the site**, the owner is responsible for **removal or securing of shade fabric** when hurricanes or wind events exceeding the designed wind load are anticipated. Shade structures do not include lightning protection systems or mitigation devices unless expressly stated. Electrical work, grounding beyond standard requirements, and site-specific electrical provisions are excluded.
