FIFTH AMENDMENT

TO THE

AGREEMENT FOR POLICE SERVICES

BY AND BETWEEN

THE CITY OF COOPER CITY

AND

GREGORY TONY, AS SHERIFF OF BROWARD COUNTY

THIS Fifth Amendment is made and entered into this _____ day of February, 2023 by and between the City of Cooper City, a municipal corporation organized and existing under the laws of the State of Florida, which municipality is fully located within the boundaries of Broward County, Florida (hereinafter referred to as "CITY") and Gregory Tony, as Sheriff of Broward County, Florida (hereinafter referred to as "SHERIFF").

WITNESSETH:

- **WHEREAS**, on or about October 1, 2020 the CITY contracted with the Sheriff of Broward County to provide law enforcement services to the CITY; and
- **WHEREAS**, on or about March 20, 2021 the parties entered into a First Amendment to add two CSA positions; and
- **WHEREAS**, the parties entered into a Second Amendment to add a deputy sheriff detective position; and
- **WHEREAS**, the parties entered into a Third Amendment to add a traffic deputy sheriff position; and
- **WHEREAS**, the parties entered into a Fourth Amendment to add a crime prevention deputy sheriff position; and
- **WHEREAS**, the SHERIFF and CITY are desirous of amending the staffing levels and the consideration as set forth herein.
- **NOW THEREFORE**, in consideration of the sums hereinafter set forth and for other good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, it is agreed as follows:
 - 1. The above recitals are true and correct and incorporated herein.

- 2. The staffing complement shall be increased by adding deputy sheriff sergeant position as reflected in the attached Exhibit A to this Fifth Amendment.
- 3. As a result of the above referenced staffing adjustment, the annual consideration payable by the CITY to BSO shall be increased \$221,450.00. The increase will be prorated for this Fiscal Year based on the start date of the sergeant. The new position will be included in calculating the consideration for next fiscal year pursuant to Article 6 D of the Agreement.
- 4. Except as herein amended, all other provisions of the Agreement shall remain in full force and effect.
