

# CITY COMMISSION ORDINANCE/RESOLUTION

## TITLE: Ordinance 22-3 (Commission)

**DESCRIPTION:** AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING CHAPTER 23, ARTICLE V OF THE CITY'S CODE OF ORDINANCES, ENTITLED "SUPPLEMENTARY REGULATIONS;" BY SPECIFICALLY AMENDING SECTION 23-90, ENTITLED "FENCES, WALLS AND HEDGES;" PROVIDING FOR THE REGULATION OF CERTAIN FENCE MATERIALS TO PROHIBIT WINDSCREENS; PROVIDING FOR CONFLICTS; PROVIDING FOR CODIFICATION; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

#### **RECOMMENDATION:**

Motion to approve amending Chapter 23 by amending section 23-90 providing for the regulation of certain fence materials to prohibit windscreens.

#### **BACKGROUND OF ITEM:**

Ordinance 22-3 was approved on 1<sup>st</sup> reading, March 22<sup>nd</sup>, for the regulation of certain fence materials to prohibit windscreens. The following materials shall not be attached to a fence or windscreen unless otherwise required by law; however, such materials may be used at government-owned facilities and recreational facilities in the City, subject to the approval of the chief building official:

- Cloth
- Fabric
- Canvas
- Silt Screens
- Mesh

### ANALYSIS:

The City Commission recognizes the potential need to utilize windscreens at certain recreational facilities, including tennis and pickle ball courts, and seeks to provide an exception to the windscreen prohibition for such facilities by regulating certain fence materials, this will enhance the community and neighborhood aesthetic of the City.
