SUBJECT: Motion Approving the Piggyback of Sourcewell Contract RFP #101221 for Sewer

Vacuum, Hydro-Excavation, and Municipal Pumping Equipment with Related Accessories and Supplies in an Amount not to Exceed \$650,000.00. - **Utilities**

CITY MANAGER RECOMMENDATION:

The City Manager recommends Commission approve the piggybacking of Sourcewell Contract No. RFP# 101221 for Sewer Vacuum, Hydro-Excavation, and Municipal Pumping Equipment with Related Accessories and Supplies to Great Southern Equipment, LLC (authorized distributor of Gradall Industries, LLC), in an amount not to exceed \$650,000.00; for the purchase of a new Vacall Vactor Truck. This agreement will run concurrently with the Sourcewell contract RFP# 101221, under terms and conditions acceptable to the City.

BACKGROUND OF ITEM:

The City currently owns a 14-year-old vacuum truck that is experiencing ongoing mechanical issues, which have affected its operational efficiency. Additionally, the truck is severely rusted and beyond repair.

ANALYSIS:

The proposal from Great Southern Equipment for a new Vactor truck, in the amount of \$621,717.92, will be used for wet well cleaning at lift stations, addressing sewer backups and main line blockages in manholes, and performing other tasks at the Water Plant.

PROCUREMENT:

Sourcewell advertised RFP #101221 under full and open competition on August 24, 2021 with a proposal due date of October 12, 2021. Sourcewell and Gradall Industries, LLC entered into a contract on November 29, 2021; with an expiration date of November 29, 2025. A contract extension was executed on February 6, 2025, extending the expiration date to November 29, 2026.

Pursuant to Sec. 2-258 (e) of Cooper City Procurement Code, it is financially advantageous for the City to piggyback Sourcewell Contract No. 101221-GRD. Contract No. 101221-GRD between Sourcewell and Gradall Industries, LLC. This contract allows municipalities to purchase Vacall machines, combination jet and vac machines hydro excavation machines and other machines from authorized dealers, distributors and/or resellers. Gradall Industries, LLC provided a letter

certifying that Great Southern Equipment, LLC is the sole authorized distributor for the Vacall line of equipment for certain products in Florida.

FISCAL IMPACT:

There is currently an available balance of \$650,000 in the Equipment & Machinery-Vehicles line which is 450-930-564400-535 for FY25.
