The Mobility Advancement Program's Administration reviewed communication from Cooper City (City) dated February 26, 2025, requesting to extend the term of the agreement for *COOP-024: Stirling Road Roadway and Drainage Improvement*, which is bundled with another adjacent project with otherwise the same scope (COOP-042) and a Rehabilitation and Maintenance project for the resurfacing of the section after drainage construction is complete (BC-COOPERC-FY2020-00001).

Based on the request and justifications provided by the City (attached), and pursuant to Section 4.2 of the project funding agreement, the County approves the City's request for an extension of the term in excess of one-year, through September 27, 2026. Surtax Legal will begin the PFA amendment process, please provide any additional information required to effectuate the amendment.



Pursuant to Article 4.2 and pursuant to Sec 5.9 of the Interlocal Agreement (ILA), this letter is to formally request an extension, from April 30, 2025 to September 27, 2026, for the Design Phase of the referenced project. This Request is essential to provide our Design Consultant with the necessary time to complete the scope of work and deliverables outlined in the ILA, as well as to allow 120 days after the proposed completion for project closeout. The City has encountered unforeseen staffing transitions within the project team and consultant contract negotiation delays, impacting our ability to complete the Design Phase within the original project schedule.
