#### PLEDGE OF ALLEGIANCE

Mayor Curran opened the meeting at 6:30 PM and led the assembly in the Pledge of Allegiance.

# PUBLIC SPEAKING

# **Open Public Meeting/Agenda Concerns**

Carmen Mure, thanked the City for allowing the pickle ball community to host a fundraising event for Relay For Life. She thanked Mike Cobelo, Parks and Recreation staff, sponsors and volunteers.

David Nall, asked that item 15 be moved up on the agenda. He also recommended extra patrols on 90<sup>th</sup> Avenue to address children riding their bicycles in the road during peak traffic hours. He also spoke on enforcing the City code on feeding nonnative species.

Robert Froehlich, asked the Commission to bring AT&T fiber into the City. City Manager Rey will work with Mr. Frohlich on addressing his concerns.

Brian Schafler, asked about barricades being placed in the area where the geese reside in the City. City Manager Rey advised they are placing fences in the area.

Yosen Rojas, spoke on his concerns with the code section regarding time and regulations for parking of boats. He also spoke on the no parking signs in front of Cooper City Elementary School but no enforcement of the cars parking there. He also addressed selective enforcement.

Brett Neiviller, spoke on the need to revise the code regarding the parking of RV's and boats to allow for parking during certain times.

Commissioner Mallozzi said the limit on swale parking was for the schools. She spoke to Mr. Neiviller and advised him she will address his concerns with the Commission.

Commissioner Smith asked City Attorney Horowitz to speak on code changes. City Attorney Horowitz advised any member of the Commission can place an item on the agenda to initiate code changes or policy changes. His office would draft an ordinance consistent with the policy change the Commission was looking to implement and that item would come back on a future agenda for two readings including one public hearing. If it were to pass each of those steps it would be codified to become part of the City code. Commissioner Smith asked if a code change could help a resident who had been cited previously. City Attorney Horowitz answered the code is a snapshot in time. If a resident is cited for violating the code, and they were, in fact, in violation of the code at that time a future change to the ordinance would not address a prior offense. Additionally, fiscal impacts for ordinance changes are also included for all that are applicable.

Commissioner Shrouder said the revision to the swale ordinance was done to address the citing of vehicles as opposed to the citing of properties. There was also an addition of the 36 hour rule to prevent individuals from parking in the swale of neighbors for long periods of time which was an issue. He has no issues addressing code sections that are a concern of the residents.

Commissioner Katzman asked if the mention of parking a vehicle for 36 hours for active loading and unloading in Code Section 25-10 contradicts with another section stating owners and or occupants of residences are permitted to park or store their boat or recreational vehicle in front of the residence for a period of not more than 24 hours within a 7 day period. City Attorney Horowitz said one provision speaks specifically to loading, unloading maintenance, and other opportunities. In the instance of any conflict between ordinances, we include language in each of our ordinances that the one adopted later in time will prevail. The 36 hours provision would prevail. Commissioner Katzman said with that provision it does seem that they do allow a time period of having a boat visible.

City Manager Rey recommends a workshop to address the code section. All code enforcement issues have two sides.

Mayor Curran said he believes there was a previous 72 hour rule to allow a boat to be visible. He would like to hold a special meeting or a workshop before a regular commission meeting to hear all sides and address concerns.

Commissioner Shrouder said the previous rule allowed the boat to be parked 24 hours, with Code Enforcement waiting 24 hours, before citing. The code was changed to 36 hours, and they can cite after 12 hours. Essentially it was the same timeframe but it did not make sense to have Code Enforcement return 24 hours later to a property. City Attorney Horowitz advised the previous code read "any boat or prohibited vehicle parked in a prohibited area for purposes of actual, active and uninterrupted loading or unloading repairs, deliveries, or maintenance between the hours of 6 AM and 7 PM.

Commissioner Smith said Code Enforcement would not know when the 36 hour time period started. Commissioner Shrouder said Code Enforcement would take a photo to start the 36 hour time period.

Commissioner Mallozzi said fines can be suspended while the Commission discusses the topic. She would like to address swale parking.

Consensus was reached to hold a Code Enforcement Workshop to address written language that is of concern.

City Attorney Horowitz reminded the Commission to be mindful of not addressing specific cases pending before the Magistrate.

#### 4. **Resolution 25-15 (Community Development)**

City Attorney Horowitz read "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, GRANTING SITE PLAN APPROVAL PURSUANT TO SITE PLAN PETITION SP# 1-1-24, ATTACHED HERETO AS EXHIBIT "A," FOR THE APPROXIMATELY 1.5 ACRES OF REAL PROPERTY KNOWN AS TACO BELL, GENERALLY LOCATED AT 2500 PINE ISLAND ROAD IN COOPER CITY, FLORIDA; PROVIDING FOR CONDITIONS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE" by title.

City Attorney Horowitz advised the owner/petitioner is Publix Supermarkets and Craig McDonald with Corporate Property Services.

City Attorney Horowitz swore in all individuals wishing to speak.

Community Development Assistant Director Jason Chockley advised the petition is a Site Plan for Taco Bell, located at 2500 Pine Island Road. This is located in out parcel 3 within the Cooper City Commons Shopping Plaza. This is the last remaining vacant out parcel for the center, which was constructed in 2001 and 2002. Accompanying this petition is a Sign Package and Sign Waiver. The proposed plans are for a single story, 2,521 square foot fast food restaurant, with a dual drive through ordering lanes converging into a single pickup window. There is a 60 person interior occupant load, plus an additional 215 square feet of an outdoor seating patio. The plans reflect a modern looking building with raised landscape berms along Pine Island Road. The building will incorporate some designs and details from the main Publix's building, as shown on sheet 4.2 in the plans. Access to the site is provided in the existing interior drive aisles within the center. The site will not have direct access to either Pine Island Road or Sheridan Street. The proposed parking counts exceed code requirements and will include two dedicated electric vehicle parking spaces and two mobile order parking spaces. The proposed Site Plan was reviewed and approved by Central Broward Water Control District on February 26, 2025. The Planning and Zoning Board had a recommendation of approval with a 9-0 vote. DRC recommends approval of the Site Plan petition pending items listed in the staff report. Relative to the Sigh Package and Sign Waiver, Taco bell is proposing their own branding package, consistent with the colors of black, white, light purple, and dark purple, which are part of the Taco Bell logo, and will be on all four sides of the building. The south and east elevation will have the words Taco Bell on two lines at 14 inches tall, and the bell at 3 feet 6 inches. The north elevation will have the bell only at 3 feet 6 inches. The west elevation will have the words Taco Bell at 12 inches tall. The Sign Waivers do comprise the south and east elevation, where the signs are to be at 2 thirds the size, since they are on all 4 sides. There are minor increases in the total square foot, most of which is due to the logos being of the bell alone and not having extra script. The south and east elevation allow the logo to be 20% of the total sign area. All signs still fit within the character and sizing of the building itself. Code stipulates that waivers may be granted with at least one of the following being met: physical site distinctions of the site which they do cite, the layout of the building, and the layout of the out parcel relative to the adjacent roadways. Architectural design of the structure itself, which they do cite, the building being all the way in the south corner, between the out parcel lines already depicted by Publix and the transmission corridor lines to the south. Literal enforcement would be unreasonable and undue hardship upon the petitioner, and again they cite the architectural design of the site layout prior to the petition being put forward. The Planning and Zoning Board had a recommendation of approval with a 9-0 vote.

Commissioner Shrouder asked if the applicant is willing to add a multi-sensor camera that ties into the Real Time Crime Center outside the building due to the late operation hours. Craig Mcdonald stated Taco Bell does not have the ability to tie into the Real Time Crime Center. Commissioner Shrouder clarified he is not referring to the inside cameras but a camera placed outside. Eduardo Carcaccian the architect and engineer for Taco Bell stated the IT Department for Taco Bell had security concerns with connecting the cameras. Commissioner Shrouder reiterated he is asking for a camera to be placed outside the restaurant.

Commissioner Shrouder wants the Site Plan to be approved contingent to the addition of a multi-sensor camera being placed outside the restaurant as the establishment is open until 4:00 AM.

**MOTION:** Commissioner Shrouder moved to approve Resolution 25-15 subject to adding a multisensor camera outside the property connecting to the Real Time Crime Center. Mayor Curran seconded the motion which prevailed by a unanimous roll call vote. (5-0)

#### 5. Resolution 25-16 (Community Development)

City Attorney Horowitz read "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, APPROVING A SIGN PACKAGE (#SI 1-1-24) AND A SIGN WAIVER REQUEST (#SW 1-1-24) FOR THE TACO BELL AT COOPER CITY COMMONS, GENERALLY LOCATED AT 2500 PINE ISLAND ROAD IN COOPER CITY, FLORIDA; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY AND PROVIDING FOR AN EFFECTIVE DATE" by title.

Mayor Curran opened the public hearing.

David Nall, asked about impact fees for the project. He stated any business erected in Cooper City Commons will have a traffic impact.

Commissioner Shrouder asked if there will be impact fees. Community Development Assistant Director Jason Chockley answered building permit fees but impact fees were included when the Publix's master plan was approved originally.

Mayor Curran closed the public hearing.

**MOTION:** Commissioner Smith moved to approve Resolution 25-16. Commissioner Shrouder seconded the motion which prevailed by a unanimous roll call vote. (5-0)

#### Motion to Approve

13. Motion to approve Smart Camera Equipment - BSO - (Law Enforcement)

Commissioner Shrouder pulled item 13.

**MOTION:** Commissioner Katzman moved to approve the consent agenda with the exception of item 13. Commissioner Mallozzi seconded the motion which prevailed by a unanimous roll call vote. (5-0)

13. Motion to approve Smart Camera Equipment - BSO - (Law Enforcement)

Commissioner Shrouder said the Pool and Tennis Center cameras are \$100,000 dollars. He believes the cost is high and asked for approval of the item with the removal of the cameras for the Pool and Tennis Center and allocating those funds to cameras at the Utilities Plant or easements near the geese incident. Commissioner Shrouder said the initial intention for cameras were to capture perimeters.

Commissioner Mallozzi said there are individuals that are not sworn officers looking at the cameras. She indicated Commissioner Shrouder.

Commissioner Shrouder asked Lieutenant Tozzie when he comes over to view the cameras. Lieutenant Tozzie responded when there are tours the camera angles are changed. Only authorized individuals are allowed to view the cameras in all other instances.

Commissioner Shrouder clarified he has only viewed the cameras during tours of the facility.

Commissioner Katzman asked if the cameras on Stonebridge Parkway can view the parking lot of the Pool and Tennis Center. He would like to have at least one camera at the Pool and Tennis Center. Lieutenant Tozzie explained the cost for one camera is the same for multiple due to equipment needed.

Commissioner Shrouder said BSO can come back with suggestions on locations.

**MOTION:** Commissioner Shrouder moved to approve the smart camera equipment removing the location of the Pool and Tennis Center reallocating the funds for other locations as deemed necessary by staff. Mayor Curran the motion which prevailed by the following roll call vote. (4-1)

# 14. Discussion and possible action on Code Change allowing Carports within the required setback for properties adjacent to the Golf Course. – Commissioner Mallozzi

Commissioner Mallozzi advised a Town Hall was held a few months back looking for solutions to protect residents cars from golf balls. She prefers the permanent structure. She would like to allow a different allowance for homes adjacent to the golf course as they are being inundated with golf balls.

Commissioner Smith motioned to approve the option of the carport that meets the Florida Building Code standards.

Community Development Director Carlos Vega advised staff was asked to provide feasible options to provide the residents that live in the R1A zoning district, which are the homes that surround or that are adjacent to the golf course. They currently have a 25 foot setback requirement which means there needs to be 25 feet from the property line for a vertical structure to be installed. If the Commission agrees they can allow an exemption in the code that would allow the homes adjacent to the golf course, to be able to exceed the 25 foot front setback requirement and allow aluminum carports. Staff recommends carports that meet the Florida Building Code. Another option is a sunshade for the rear yard, screen enclosures and patio roofs.

City Attorney Horowitz advised an ordinance would need to be established creating a specific zoning district.

Commissioner Shrouder said the only issue currently is the setback requirement and residents can seek a variance. Establishing a specific zoning district is a significant process.

Commissioner Smith asked if the residents can install structures that are not approved by the Florida Building Code. Commissioner Smith asked if these recommendations were given during the agenda placement of the item.

Commissioner Shrouder reiterated the Commission can grant an administrative variance allowing staff to approve the variance request for this area.

Commissioner Mallozzi said residents need help to enjoy their backyards as golf balls are infiltrating properties causing damage. She advised this will not be every home in the area. She held a Town Hall and concerns need to be addressed.

Commissioner Shrouder asked that staff look into an administrative variance process.

Commissioner Smith asked that the variance cost be stated and possibly eliminated.

Consensus was reached for staff to develop an administrative variance process that the Commission can review for implementation.

#### 15. Motion to approve the City Manager's recommendation for Police Captain.

City Manager Rey stated he conducted three interviews of candidates sent by the Broward Sheriff's Office. He recommends Captain Andrea Tianga and believes she is the right individual to stay the course and continue to develop the technology and skills to enhance police services.

Commissioner Katzman advised he had the opportunity to meet with Captain Tianga and he was highly impressed. All three candidates were great but Captain Tianga has experience in the City and a great resume.

Commissioner Smith recognizes that Captain Tianga has Cooper City experience. Captain Tianga's work experience is what the City needs.

Commissioner Mallozzi asked how social media knew Captain Tianga was the recommended candidate. City Manager Rey advised the decision is not final until the Commission votes. The name was placed on the City agenda today. She stated while she believes Captain Tianga would do a great job she preferred another candidate. She asked City Manager Rey who advised him they would receive three years of service from Captain Tianga. City Manager Rey responded he spoke to command staff to confirm there were no plans to move Captain Tianga currently. Commissioner Mallozzi asked that command staff add language stating Captain Tianga will be committed to the City for three years.

Commissioner Smith asked if there would have been any reason to stalemate the previous Captain's progression through the organization. City Manager Rey answered no. Commissioner Mallozzi said Captain Tianga can be up for promotion any day. She wants a commitment. Commissioner Smith said our City looks to have a candidate that meets our needs, and if that candidate gets tapped for something bigger then that means that is the right candidate for this City. Commissioner Mallozzi wants commitment. Commissioner Smith asked why we would to handcuff the City and the candidate.

Commissioner Shrouder said statistically only 2% of Police Chiefs are woman and if Captain Tianga is approved that is something to be proud of. Having a Captain that has roots in Cooper City is what the

City has always wanted. He has enough experience with the Broward Sheriff's Office to know they will not put any commitments on staff.

Mayor Curran said his only fear is that she will get promoted soon. If approved tonight he will be her biggest fan in support of her and public safety.

Commissioner Smith stated the community has been greatly affected by incidents with the geese and the community needs closure.

Commissioner Shrouder said the de facto head of the Animal Cruelty Unit at the Broward Sheriff's Office is Captain Tianga.

**MOTION:** Commissioner Shrouder moved to appoint Captain Andrea Tianga as Police Chief of Cooper City. Commissioner Katzman seconded the motion which prevailed by a unanimous roll call vote. (5-0)

16. Commissioner Smith asked City Manager Rey to speak on exhibit 4 and the amount of funds only covering one field as opposed to two fields which was the original thought. City Manager Rey said not all fields were budgeted. He explained there was funds leftover from parking improvements for Suellen Fardelmann that can be used next year for updates.

Commissioner Mallozzi asked why we are having so many issues with our fields and why we are improving irrigation that is not needed. She receives numerous complaints that need addressed. City Manager Rey said they have a program and approach to address the condition of the fields. He said the fields were in bad condition when he arrived last June. That previous approach was a waste of money. He believes his approach is the correct method for our fields. The fields are being rested on the weekends as adults typically use the fields on the weekends as opposed to children. Commissioner Mallozzi asked why we need irrigation fixed if there is no issue. City Manager Rey said staff identified issues.

Commissioner Katzman asked if Bill Lips will have brand new sod if this item is approved. City Manager Rey said the west side will as the other fields have been addressed already. Commissioner Katzman asked if fields at Suellen Fardelmann will be updated. City Manager Rey said grass will be laid next year. Commissioner Katzman asked if we can do all upgrades and repairs now. City Manager Rey does not recommended closing five fields at once.

Commissioner Shrouder asked if the Pioneer Middle School fields can be redone and utilized.

Commissioner Smith asked what needs to happen for the fields at Pioneer Middle School to be updated for use. City Manager Rey said he has his first briefing on the final plan for the Parks Master Plan next week.

Mayor Curran said the total for all updates at Bill Lips is \$405,000. He agrees that we do not update all fields at one time. He stated the backup included fields at Suellen Fardelmann which are not being repaired now. He hopes Bill Lips can lead up to expectations and staff can maintain it.

City Attorney Horowitz stated about 8 weeks ago he had come to the Commission as part of the City Attorney's Report and asked for a conflict waiver on behalf of his law firm, given the representation that his law partner has of the Central Broad Water Control District. At the time the Commission was kind enough to grant the waiver, and asked him to bring to the Commission's attention when that item came before the Commission. This is the item that he was referring to, otherwise it's properly before the Commission for consideration.

City Attorney Horowitz read "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, APPROVING AND AUTHORIZING THE EXECUTION OF WATER AGREEMENT WITH 6591 RANCHES, LLC FOR TWO AND ONE HALF (2.5) WATER ERCS AT A TOTAL COST OF \$4,408.81, ATTACHED HERETO AS EXHIBIT "A" AND INCORPORATED HEREIN; AUTHORIZING AND DIRECTING THE APPROPRIATE CITY OFFICIALS TO TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE" by title.

City Attorney Horowitz advised here's been some general conversations regarding the manner in which we serve parcels outside of the City. Outside of the City there's been an ordinance that the Commission has adopted with regards to certain activity involving water service outside the City, ensuring that the use is in the City's best interests. This contract, as approved by the town, predates those conversations by this Commission. He has had some conversations with Commissioner Shrouder and what he would offer this evening if the Commission is open to it, is approving this agreement conditionally, and allowing the City administration and his office to go back and add some of the language to embrace the recent changes to the city code and some of the direction by this commission, again, to the extent the Commission sought to approve the item.

Commissioner Shrouder moved to approve Resolution 25-18 conditioned upon revising the resolution to make a finding that we find it not to be inconsistent with our new ordinance. City Attorney Horowitz advised the resolution already includes that language.

Commissioner Smith asked City Attorney Horowitz if he believes any proposed changes could possibly be rejected. City Attorney Horowitz answered no.

Commissioner Mallozzi wants to charge more for servicing outside areas. She would like a fee study to be completed.

City Manager Rey said a comprehensive fee study is a large undertaking. In the meantime we can make a CPI adjustment to the current connection rates.

Commissioner Shrouder said the item before us is from 2024.

City Attorney Horowitz said he would have no objection approving the item based upon the CPI rate adjustment to be brought forth at the next meeting.

Commissioner Smith said tabling the item may be better.

Commissioner Shrouder reiterated this item has been waiting since June 2024.

Commissioner Katzman asked if we are speaking on adjustments to the connection fees. City Manager Rey answered yes. He also advised the surcharge for outside rates are continually up for discussion in Tallahassee. He feels uncomfortable approving outside agreements with this item being up for discussion in Tallahassee. He asked City Attorney Horowitz if they are legally obligated to offer outside hookups. City Attorney Horowitz said there are three ways that a City can be legally obligated to serve parcels outside of its borders. One is if a service area is established by ordinance, the second is if there's a contract that requires that connection, and the third is a manifestation of intent. He is not aware of any manifestation of intent, as it relates to this property. The City Commission in 2020, adopted an ordinance restarting the process of providing service outside of its borders. That process had been stopped for many years. There was an ordinance adopted that defined a specific service area. Commissioner Katzman asked if the ordinance can be revoked. City Attorney Horowitz answered yes, but the properties that were approved prior must still be serviced.

Commissioner Shrouder said the 25% charge is above our costs. We need to reallocate costs. He would like to approve the item, change the hookup costs and do a cost allocation study.

Commissioner Mallozzi said the item tonight can be approved based on the new rates.

Commissioner Smith clarified there is no overloading of the City's water supply.

Commissioner Mallozzi moved to approve Resolution 25-18 with the rates to be approved at the next Commission meeting including the language stated by City Attorney Horowitz and the language stated by Commissioner Shrouder.

#### **CITY MANAGER REPORT**

25. Bi-Annual HOA Presidents/CDD Chair Meetings

City Manager Rey advised Mayor Curran and himself had a conversation regarding improving communication with residents. In the past he has created an HOA Presence and Community Development District Chair meetings to use those individuals as a conduit to bring City information to residents. He also advised he had a meeting with the Broward Sheriff's Office command staff who advised him they are looking to add a 25% increase across the board for all pay classes. Tomorrow he has a meeting with neighboring municipalities to gather their take on this and how it can be addressed. He advised this year there will additional spaces for summer camp users. They are able to accept 170 elementary school children and 40 teens. Staff is interviewing personnel and returning camp counselors. If there is a need to adjust salaries he will report that to the Commission.

Commissioner Katzman asked City Manager Rey to make clear that registrations are for Cooper City residents and children of city employees only. City Manager Rey confirmed only residents are enrolled.

Commissioner Shrouder said the registration needs to be done online. He wants to find a way to meet all demand.

#### **CITY ATTORNEY REPORT**

City Attorney Horowitz advised last Friday the County Attorney's Office sent out an email to all the municipal attorneys in Broward County regarding an issue involving the expansion of the Monarch Hill Landfill. In February the Broward County Commission approved several ordinances that were necessary as part of the expansion of the landfill itself. This all has to do with the ongoing solid waste

issues in the county, and the regional effort to provide for some accommodation, as it relates to disposal of solid waste. Currently the landfills remaining useful life is expected to be about six years. The proposed expansion will extend that lifespan to approximately 22 years. Within the past several weeks the cities of Coconut Creek and Deerfield have both initiated what's referred to as a chapter 164, dispute resolution process. Before one local government in the State of Florida can sue another there is a dispute resolution process that needs to be initiated which requires the adoption of a resolution. A meeting between the respective administrators, manager to manager. If the managers are not able to reach a resolution of the respective grievances the respective commissions meet. Coconut Creek and Deerfield are in the process of moving in that direction, as it relates to challenging the county's expansion. The County Attorney's Office on Friday sent out an email wanting to inquire as to whether or not any other municipalities in Broward County intend to participate in these proceedings. Coconut Creek and Deerfield, under the statute, are required to notify any other local governments which, in their determination, may have substantial interest in the matter. The cities have not notified anybody directly. They advised the County that they have no objection to the County reaching out to the municipalities to see if there was any other interest in joining the dispute resolution proceeding. The County's since extended that invitation. There is no action needed this evening, unless the Commission has a real intent in getting involved in the process.

#### COMMISSIONERS' CONCERNS/REPORTS/ITEMS TO BE PLACED ON NEXT AGENDA

Commissioner Smith thanked the City Manager and staff on increasing summer camp numbers. He also asked that the Public Safety Advisory Board be included in the BSO contract undertakings. Lastly, he thanked his colleagues for their work in Tallahassee.

Commissioner Mallozzi thanked her colleagues for their work in Tallahassee. She also thanked her colleagues for attending both the bunco tournament and pickle ball tournament raising funds for Relay for Life. All events in totality raised close to \$8,000 dollars. Eat to the Beat will be held Friday and the Mother Daughter Tea will be held in May.

Commissioner Katzman said all events were fantastic and welcomed Captain Tianga back to Cooper City. He also reminded the City Manager about the request for the speaker recognition system. On April 26th at 10:00 AM the Fire Station will hold an Autism Event with a Best Buddies Walk being held at Nova Southeastern University beforehand. He also wished Parks and Recreation staff member Bill Elliot a Happy Birthday.

Commissioner Shrouder said the Bunco event was amazing. He also welcomed Captain Tianga back to Cooper City.

Mayor Curran welcomed Captain Tianga back to Cooper City.
