# PLEDGE OF ALLEGIANCE

Hillary Waksman thanked the Commission for the proclamation and their support.

# 3. Auditor's Presentation

Stephen Emory with Citrin Cooperman gave a presentation on the Annual Comprehensive Financial Report. There are three reports within the comprehensive report. There is the General Auditors Report, the Compliance Report and the Internal Control Component. All reports were clean and there were no matters of noncompliance. He also spoke on the single audit requirement of the ARPA funds that was also issued a clean report. Earlier this year the City received a certificate of excellence from the GFOA for the 2023 statements and he believes the City will receive the certificate again this year. He advised funds were expended in accordance with budget allowances and all debt payments were made in a timely matter. He also spoke highly of the accurate monthly financials that did not require any adjustments.

Commissioner Katzman thanked Mr. Emory and the Finance Department for all their work. He asked Mr. Emory if we met all deadlines for submittals as in years past we did not. Mr. Emory answered yes.

Commissioner Shrouder said there was a period of time were we had finding in the report and missed deadlines so he thanked the Finance Department for the improvements. He also advised the City received some information on updates to IT that he believed was being handled by the IT vendor but were not.

Mayor Curran thanked the Finance Department for all their work.

Commissioner Mallozzi does not want to use a former employee as a consultant.

Commissioner Smith asked City Manager Rey if there are instances that require the City to contract out. City Manager Rey said we have multimillion dollar projects in the works and the City needs a representative to oversee the projects. Commissioner Smith asked the cost of this individual if he was on salary. City Manager Rey responded \$200,000 with benefits.

**MOTION:** Commissioner Mallozzi moved to approve Contract No. PSC2025-2 with Total Municipal Solutions, Inc., in an Amount Not to Exceed \$50,000.00. Commissioner Shrouder seconded the motion which prevailed by the following roll call vote. (4-1)

#### **REGULAR AGENDA**

11. Discussion and possible action on the regulation of certain fence materials to prohibit windscreens.

#### - Commissioner Mallozzi

Commissioner Mallozzi stated there are fence shade covers that are available to help provide privacy for residents.

Commissioner Shrouder said the Commission already debated this topic. The Florida Building Code does not approve windscreens under pre-drawn plans. Beautification is a part of the City's strategic plan. PVC fences, wooden fences and hedges can be installed. He asked Commissioner Mallozzi if she has any other information that was not discussed the previous time the item was on the agenda.

Commissioner Mallozzi said residents have asked her to bring up the topic. They can include aesthetic options with the coverings.

Commissioner Katzman has not heard an outcry from the residents wanting the option and does not believe it coincides with the City's beautification efforts.

**MOTION:** Commissioner Mallozzi moved to approve the regulation of certain fence materials to prohibit windscreens. Commissioner Shrouder seconded the motion which failed by the following roll call vote. (4-1)

12. Discussion and possible action on allowing commercial vehicle parking in residential districts. - **Commissioner Mallozzi** 

Commissioner Mallozzi stated she would like to look into allowing residents if needed to bring home commercial vehicles. If that is not the will of the Commission she would like to look into another parking lot using the unoccupied land in Monterra.

Commissioner Smith moved to table the item. He did not hear any comments on this item in the workshop held earlier tonight and it is not prudent to discuss acreage and funds with no details.

Commissioner Shrouder said regular vehicles with commercial lettering are allowed at properties with magnetic covers. Commercial vehicles could include semi-trucks which have been cited in the City.

Commissioner Mallozzi said certain professions require late call out times and residents may need to park at home. She is not supporting the parking of semi-trucks at homes. She stated there is a waitlist for parking spots of over 100 people. The money in the parking lot fund can be used to produce another parking lot.

Commissioner Shrouder said when an item is placed on an agenda staff has to produce backup and the Commissioners and Mayor have to spend time researching the topic. He did not find any mention of the item during her first 12 years of serving as a Commissioner. He asked what has changed to bring up the topic multiple times recently. He does not see an outcry or data for individuals wanting to park commercial vehicles.

Commissioner Smith said they need to review commercial vehicle citations to have all the information available.

Commissioner Katzman asked if the land in Monterra is the largest piece of unoccupied land the City has. City Manager Rey answered yes. Commissioner Katzman does not want to quickly jump to a particular use for that land.

Mayor Curran does not support using the land in Monterra for a storage lot. He also does not support allowing the commercial vehicles.

**MOTION:** Commissioner Smith moved to table discussion and possible action on allowing commercial vehicle parking in residential districts. Commissioner Shrouder seconded the motion which prevailed by the following roll call vote. (4-1)

# **CITY MANAGER REPORT**

# 15. Suellen Sports Complex Playground

City Manager Rey advised the City received a grant for \$200,000 for playground equipment at Suellen H. Fardelmann Sports Complex. What we can receive for \$200,000 is very limited. The Sports Complex is one of the City's most used parks and after research an additional \$600,000 is needed to complete a playground to be proud of.

Commissioner Katzman thanked City Manager Rey and staff for this research. The residents have been asking for upgraded playgrounds that are autism friendly as well as disability friendly. We have reserves and he supports using them to build the playground.

Commissioner Mallozzi supports the playground.

Commissioner Shrouder supports a playground that is nice and would like a gate installed.

Mayor Curran said all parks in the City are in need. Setting the precedent of spending \$600,000 on a playground and skipping the smaller parks in the City is against his beliefs. He asked why less cost expensive options were not presented. There are other parks in the City that are in dire need of updates. City Manager Rey said in terms of usage the Sports Complex has the most.

Commissioner Katzman agrees there are a lot of parks that need updated. The Sports Complex is a well-used park. He would like all parks to be updated but we need to start somewhere.

Commissioner Smith said he believes Mayor Curran wants to see the less costly options.

Commissioner Shrouder would like to approve a cost range.

Commissioner Smith asked when the Parks Master Plan will be presented. City Manager Rey meets with the consultant next week. Commissioner Smith would like to table the item until the Parks Master Plan is received. The plan will relay the needs of the residents. City Manager Rey said the residents want better playground equipment at all parks. Commissioner Smith asked when the grant money needs spent. City Manager Rey said if he receives consensus he can move forward.

Commissioner Katzman asked what moving forward entails.

Commissioner Smith said they can look at costs of flooring and equipment.

Commissioner Shrouder recommended approving moving forward and showing Mayor Curran the options he wishes to view.

Consensus was reached to move forward on the receiving particular costs on the playground.

16. Robert Webster Memorial

Ryan Webster, Chief Water Plant Operator and son of former Commissioner Robert Webster asked for the Commission's support in adding his father's name to the memorial in Memorial Park.

Commissioner Shrouder asked why the item is before the Commission for approval. City Manager Rey said he does not believe it is in the purview of the City Manager's role to recognize key members of the community. Legally it may not be required but he wanted to seek Commission approval. City Attorney Horowitz advised in 1995 the Commission adopted a resolution with a process for recognizing certain people who made contributions to the City. There were several different methods in that resolution, including planting trees, benches, parks, and the plaque that is in Memorial Park. There was no action taken to appoint individuals individually.

Commissioner Katzman offered condolences to Mr. Webster on his loss. He also asked for support on establishing a policy where former Commissioners and Mayors who have passed would automatically be added to the plaque. City Attorney Horowitz would like to bring back a resolution to that affect.

**MOTION:** Commissioner Smith moved to approve adding Robert Webster's name to the memorial at Memorial Park with no cost to the family. Mayor Curran seconded the motion which prevailed by a unanimous roll call vote. (5-0)

# 17. Pure Energy, LLC

City Manager Rey advised there has been a company handling beach volleyball at the Suellen H. Fardelmann Sports Complex. When the program was established a cost was also established. The former manager has since modify the rate. After speaking to City Attorney Horowitz the former city manager did not have the authority to modify the rate without consulting with the Commission. He spoke with Pure Energy and he advised he was not aware of the approval needed. There is a 25% return to the City when a vendor teaches on City property. He looked at rates from neighboring municipalities. If we continue with the 25% recovery rate the rate will become \$23 dollars an hour. The vendor asked to finish the season at the current rate and he move to \$23 dollars an hour for next season. City Manager Rey asked for the Commissions direction or approval for the rate that is being charged currently and if they would like to continue services with the vendor or utilize the bidding process.

Commissioner Smith asked when the season ends. City Manager Rey said there are no classes in the summer so a few more months.

Commissioner Shrouder said he discovered the issue. We have published permit rental fees in our City, and there are three different rental fees. There's resident, non-resident and local nonprofit. Residents, \$40 an hour, nonresidents \$55 an hour and local nonprofit is \$25 an hour. It turns out that this company has been being charged less than all three rates. He has seen emails between the Parks and Recreation Director and Assistant Director asking for approval. He asked City Manager Rey where he has read that the rate was approved by a former City Manager. City Manager Rey stated he was told that information by the Parks and Recreation Director. Commissioner Shrouder asked if the former City Manager was contacted to verify this information. City Manager Rey answered no. Commissioner Shrouder said when we detect issues we have to establish procedures so they do not occur again. He agrees if someone in the City told the entity they could have a discounted rate they cannot backtrack but he does have email documentation. This facility is for the residents and the entity needs to pay the actual costs.

Commissioner Smith asked if the current rates we charge are accurate. City Manager Rey answered yes.

Commissioner Shrouder said he was told with the reduced rate the entity would maintain the courts including sand purchases. Parks and Recreation Director Stacie Weiss said there was no mention of maintaining the courts. Commissioner Shrouder said he believes he read that maintenance would be handled.

Commissioner Smith asked what will happen if a motion is not approved for the rates the entity is paying currently. City Manager Rey said he will have to charge the entity the cost that is approved currently with no exceptions. Commissioner Smith asked if there are residents participating. City Manager Rey does not have a resident/non-resident break down.

Commissioner Shrouder said this item was noticed inaccurately without backup.

Commissioner Mallozzi said several items are placed on the agenda last minute with no issue.

City Attorney Horowitz advised the County requires 48 hours' notice. There is a mechanism under the County Charter to supplement an agenda within 48 hours which requires all backup be provided and made available to the public at the meeting. We have an administrative procedures resolution that requires members of the Commission to submit items the Tuesday, before the Commission meeting. Members of staff have a lesser timeframe which is 10 days prior to the Commission meeting.

Commissioner Shrouder would like the entity to enter into the 25/75 agreement, pay the posted rate or competitively bid the program.

Commissioner Shrouder does not want to vote on the matter tonight as it was not noticed properly with backup.

Commissioner Mallozzi asked if voting on the item can lead to issues. City Attorney Horowitz advised we have two procedural issues. One is it was added within 48 hours of this evening's commission meeting. We also have a resolution that was adopted that requires staff to place items on the agenda 10 days prior to the commission meeting that did not occur in this instance. Commissioner Mallozzi asked if the item is delayed what the entity will pay. City Manager Rey will collect what they have been collecting currently but they are notified.

Commissioner Shrouder said he takes issue with the Optimist Volleyball Commissioner, also running a for-profit company directly competing. There is only two months of children's volleyball offered by the Optimist because the other 10 months, the volleyball commissioner runs a for profit business. This is a conflict. He would be okay with the entity going into the 75/25% agreement. City Manager Rey said he is still negotiating the facility use agreement with the Optimist and the City has remained consistent that there is a complete separation between anybody who is making money out of any relationship with the Optimist Club and people that are members of the of the Board of the Club.

Commissioner Shrouder supports a 75/25 agreement.

Commissioner Smith said a motion can wrong a right and a second motion can establish a 75/25 agreement.

Commissioner Shrouder said the City has lost \$150,000 dollars. The entity should start paying the correct amount today.

Mayor Curran asked Commissioner Shrouder what he is suggesting with the Optimist Volleyball Commissioner, also running the program. Commissioner Shrouder believes it is a conflict. He asked why the Optimist are not running the program.

Commissioner Mallozzi said two months of a sports program is typical. Commissioner Shrouder said there are more than one season offered with other sports.

Mayor Curran said if the rates increase the entity will not succeed.

Commissioner Smith asked that the item be placed on a future agenda.

Commissioner Katzman said he believes a 75/25 agreement is the best option. He would like to see a significant discount for residents. The residents pay for the fields and deserve the discount.

The item was tabled to be heard at the May 13<sup>th</sup> Commission Meeting.

Commissioner Shrouder asked that the amount that the City has lost thus far be calculated and presented.

# COMMISSIONERS' CONCERNS/REPORTS/ITEMS TO BE PLACED ON NEXT AGENDA

Commissioner Katzman recognized Rabbi Bennet Greenspon of Temple Beth Emet who is celebrating 30 years of service. He thanked the Utilities Department for working on Easter Sunday correcting a water main break. He is also frustrated with the delay of the playground as we are a community of young families. We have reserves for this purpose. The residents want these upgrades.

Commissioner Smith thanked the Finance Department for their fiscal responsibility on behalf of the residents. He thanked BSO and the Captain Tianga for the quick responses he has been receiving. He looks forward to receiving the information requested from the City Manager to move forward on items.

Commissioner Mallozzi thanked the Utilities Department for working on Easter Sunday and the Finance Department on a great audit.

Commissioner Shrouder would like the Commission to look at the strategic plan and adjust it as needed to prevent future issues. They need to challenge themselves to stay on topic and achieve the goals of the plan.

Mayor Curran thanked the Utilities Department for working on Easter Sunday. He also thanked the Finance Department on a great audit and thanked Captain Tianga for her quick responses. He advised the commission will not always agree on items but it does not mean the playground equipment will not be approved. He would like to update the equipment in all parks.

#### **ADDITIONAL PUBLIC COMMENTS (3 MINUTES)**

Ypsan. Rojas thanked the Commission for holding the Code Workshop and suggested in the future a round table discussion be used. He also spoke in support of expanding the water polo program.

#### **ADJOURNMENT**

The meeting was adjourned at 8:54 PM.
