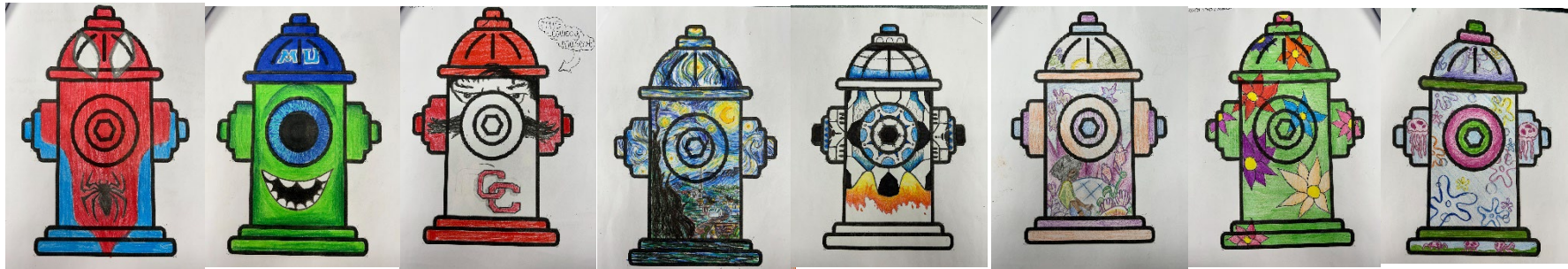

Cooper City's Quint delivery date is still reported as DECEMBER 2025.

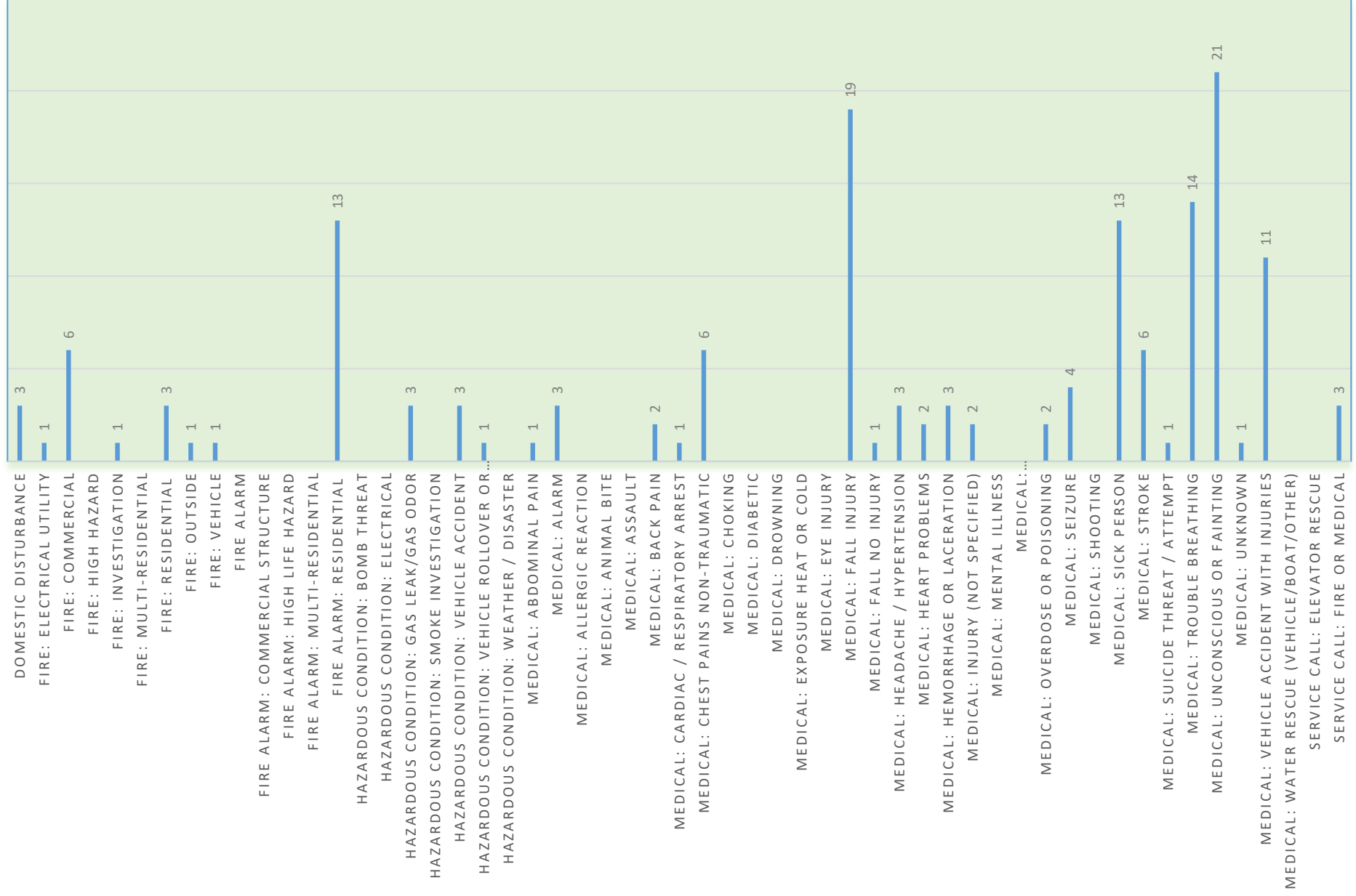

FIRE HYDRANT DESIGN UPDATE:

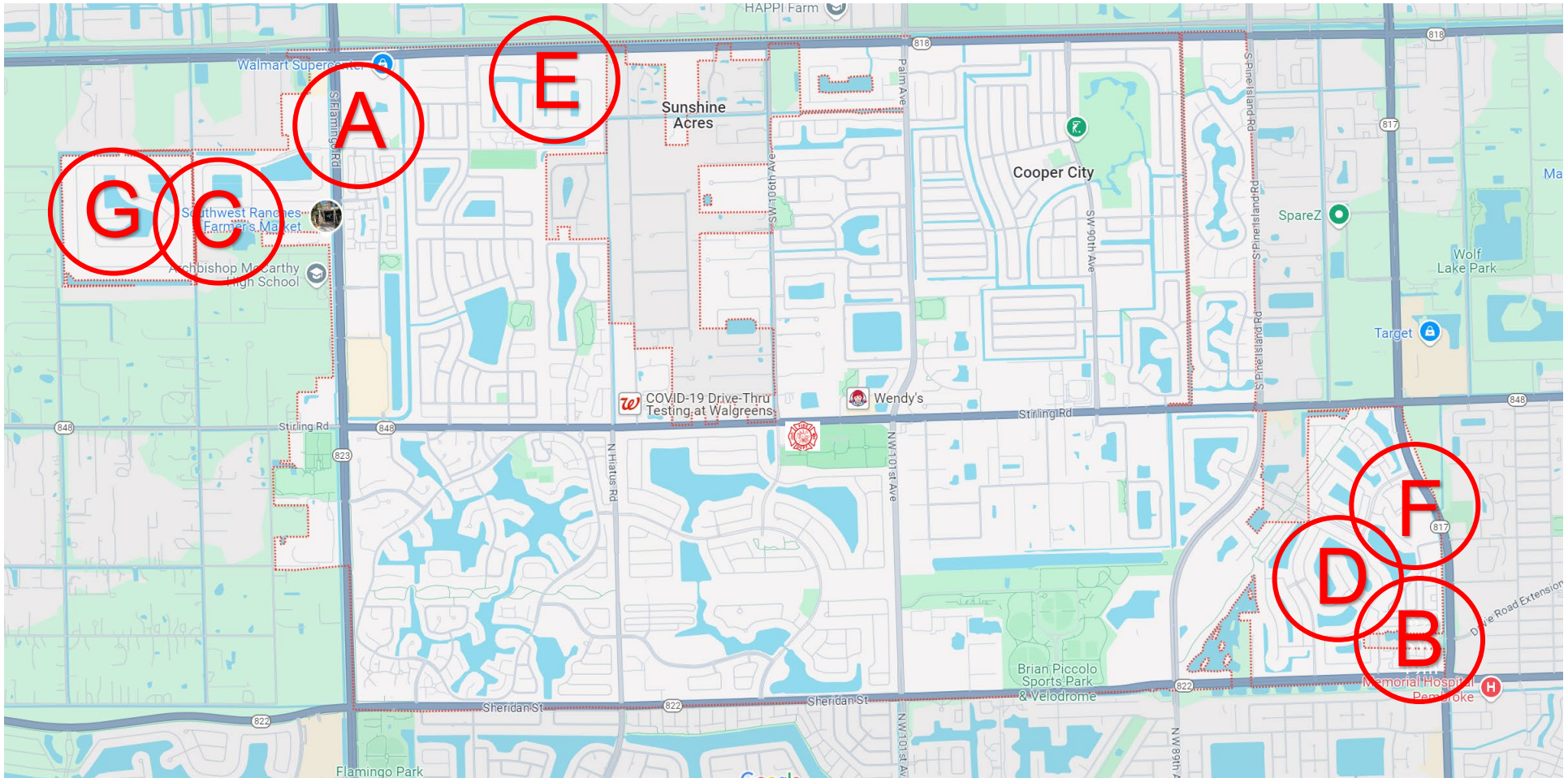
