FIRST AMENDMENT TO MASTER AGREEMENT CIP22076, AGREEMENT FOR WASTEWATER COLLECTION SYSTEM REHABILITATION SERVICES

CITY OF COOPER CITY, a municipal corporation organized and existing under the laws of the State of Florida and whose address is 9090 SW 50th Place, Cooper City, Florida 33328 ("City)",

and

MILER PIPELINE, LLC., a foreign limited liability company duly organized in the state of Indiana and authorized to do business in the state of Florida, located at 8850 Crawfordsville Road, Indianapolis, IN 46234, (hereinafter referred to as the "CONTRACTOR."), who is authorized to do business in the State of Florida

City and CONTRACTOR may each be referred to herein as "party" or collectively as "parties".

WHEREAS, on February 13, 2024, the City and CONTRACTOR entered into an agreement for the CONTRACTOR to provide Wastewater Collection System Rehabilitation Services; (hereinafter referred to as the "Original Agreement"); and

WHEREAS, the parties decided to incorporate the terms and conditions of Solicitation and Contract C1P1220762 between CITY OF OCALA and the CONTRACTOR for the Wastewater Collection System Rehabilitation services ('CITY Agreement), The CITY Agreement is attached hereto as Exhibit "A" and incorporated herein; and

WHEREAS, the initial term of the Original Agreement expires on January 8, 2025; and

WHEREAS, the Original Agreement provides for an option for two (2) additional 1-year renewal terms, subject to the mutual written consent of the Parties; and

WHEREAS, the City is satisfied with the CONTRACTOR's performance pursuant to the Original Agreement, and the Parties seek to renewal the Original Agreement for the first of two one year renewal term; and

WHEREAS, a price increase of 3% shall be implemented and effective commencing with the first renewal term; and

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, and other good and valuable consideration, the receipt and adequacy of which are acknowledged, the parties agree as follows:

- 1. **Recitals.** The foregoing recitals are true and correct and are hereby incorporated into this Agreement.
- 2. Incorporation of Original Agreement. The Original Agreement between the City and Contractor is hereby incorporated by reference as if set forth herein its entirety and remains in full force and effect except for those terms and conditions expressly amended by this First Amendment.
- Amendment to Exhibit B –Price Proposal. Subsection. The Price Proposal document attached to the Original Agreement under Exhibit B –Price Proposal is hereby deleted and replaced, in its entirety, with the document attached to this First Amendment as Exhibit B Amended Price Proposal.
- 4. Renewal Term. The Original Agreement is hereby renewed for an additional one (1) year term commencing <u>January 9</u>, <u>2025</u>, and ending <u>January 8</u>, <u>2026</u>. This Agreement may be renewed for up to <u>one (1) additional</u>, <u>one (1) year period</u> by written consent between the City and Contractor.
- 5. Notices. All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be address to the respective parties as follows:
