# Discussion on policy regarding utility billing estimates and manual adjustments – Commissioner Pulcini

Commissioner Pulcini would like the circumstances requiring the estimation of water bills to be explained.

Customer Service Supervisor Gabe Guerrero explained an estimate is done when a read is not possible.

Discussion ensued on estimating bills.

Commissioner Pulcini would like to keep money in the budget to replace the meters.

Commissioner Shrouder advised there are flaws in billing. He also spoke on the ACH process.

Discussion ensued on payment options for utility bills.

Commissioner Shrouder would like to create a seamless front-end way to process payments.

Commissioner Pulcini would like to update technology.

Commissioner Shrouder would like a written note to indicate a manual override. Customer Service Supervisor Gabe Guerrero advised there are written notes made for manual overrides.

#### Discussion to explore implementing a Fraud Hotline - Commissioner Pulcini

Commissioner Pulcini advised most entities have a fraud hotline. He would like direction for the City Attorney to look into options.

City Attorney Horowitz would defer to the internal auditor for operations.

Consensus was reached for the City Attorney and internal auditor to look into options.

Commissioner Shrouder asked what the violation process is. Commissioner Shrouder would like to only use the citation process and clarify the fine amount.

**MOTION:** Commissioner Shrouder moved to approve Ordinance 21-22 using the citation process only. Commissioner Green seconded the motion which prevailed by a unanimous roll call vote (5-0).

**MOTION:** Commissioner Green moved to approve Ordinance 21-22 as amended. Commissioner Pulcini seconded the motion which prevailed by a unanimous roll call vote (5-0).

#### **CITY MANAGER REPORT**

City Manager Napoli spoke on the budget transfers and removed the transfer for the auditor.

Mike Bailey spoke on the roof that needs replaced.

City Manager Napoli asked to appoint Tim Fleming as Interim Director for Public Works.

**MOTION:** Commissioner Shrouder moved to appoint Tim Fleming as Interim Director for Public Works. Commissioner Meltzer seconded the motion which prevailed by a unanimous roll call vote (5-0).

#### **CITY ATTORNEY REPORT**

City Attorney Horowitz advised he would like to publicly request a Shade Session concerning a lawsuit with BSO and pension.

# **POLICE CHIEF'S REPORT**

Captain De Giovanni advised the back to school traffic operation has concluded. School traffic flow with 130 citations issued. The Commercial Plaza initiative has 54 of 66 plazas in the City in compliance. Captain De Giovanni thanked a Monterra resident for sharing information of suspicious behavior that led to an arrest for a Davie incident. He spoke on the house watch performed by District 16 as residents vacation. Captain advised his team would monitor all facilities during high holy days. The Explorer program has been launched and any youth that want to participate can contact District 16. The COP program is also open and looking for participants. There is currently one vacancy with the community involvement

specialist. He also spoke on Operation Front Porch, which is a service that allows shipping packages to District 16.

Commissioner Pulcini thanked Captain De Giovanni for assisting with moving a bus stop location.

#### **FIRE CHIEF'S REPORT**

Chief Bishop advised there is an ongoing training with new drivers and hydrant flow testing will be done by end of year. Fire Inspections are currently 78% complete and on schedule to complete the remaining by year's end. Call volume is up 9% from same time last year. He advised he attended CERT training were a CERT member was named volunteer of the year. The CERT and Explorers members were involved in the Bike Rodeo and Autism event. The current apparatus is now in service but Rescue 28 is out of service with a mechanical issue. The new reporting system has been delayed to January.

Mayor Ross asked what is being used to replace Engine 28. Chief Bishop answered a truck from Weston.

# Discussion regarding implementing the recruitment process for the City Manager's replacement - Commissioner Shrouder

Commissioner Shrouder wants to be prepared in the case the city manager leaves.

Commissioner Meltzer believes putting this on the agenda may be premature but he did speak to the City Manager about moving on and wants to establish a timeline.

Commissioner Green will continue to support Mr. Napoli as the City Manager.

Commissioner Meltzer advised this is not performance base but by him applying for three jobs shows an unwillingness to be here.

Commissioner Pulcini advised the CAFR speaks to a weakness in that the City does not have a succession plan.

Mayor Ross advised we do need to address the process and possibly have a facilitator come in to help with a succession plan.

Commissioner Shrouder spoke on the process of having an interim from FCCMA. City Attorney Horowitz advised his office could reach out to the FCCMA for options.

Commissioner Green spoke on his support of the Mr. Napoli and the relationship between the City Manager and Commission as a two way street.

Commissioner Meltzer stated he believes it is an issue when the City Manager has applied for three jobs thus far.

Commissioner Shrouder spoke to Mr. Napoli about longevity and continuity.

City Manager Napoli spoke on his conversation with Commissioner Meltzer and the need for stability. He advised the opportunity was unique but he wants to do what is best for the City.

Mayor Ross advised a facilitator might be useful to hear all sides.

Discussion ensued on a facilitator.

Commissioner Pulcini asked where the funds would come from for a facilitator and he is willing to see if there is a way to improve.

Commissioner Green stated it is important to know the challenges the current City Manager has.

Commissioner Shrouder spoke on the need to have a succession plan.

Discussion ensued on hearing all sides to issues.

Mayor Ross said that the City Attorney has the direction to contact FCCMA and he would like to bring forth a facilitator.

Commissioner Meltzer would like the City Manager to come up with a reasonable timeline.

Commissioner Green believes the City Manager is committed and would suggest a facilitator to address issues that may need worked on.

Mayor Ross believes an opportunity should been given to the City Manager to speak to the Commission which would be best said with a facilitator.

Commissioner Green asked the City Manager if he is committed to stay with the City until the end of his contract. City Manager Napoli advised he is committed but there are some items that need to be addressed.

Commissioner Shrouder asked the City Manager if he is willing to waive the termination without cause item in the contract.

Mayor Ross would not prefer to address the contract as it is not on the agenda. He also spoke on resolving issues that arise.

A brief recess was held.

Consensus was reached to contact the FCCMA for a succession plan.

Mayor Ross will bring forth an item for a facilitator.
