

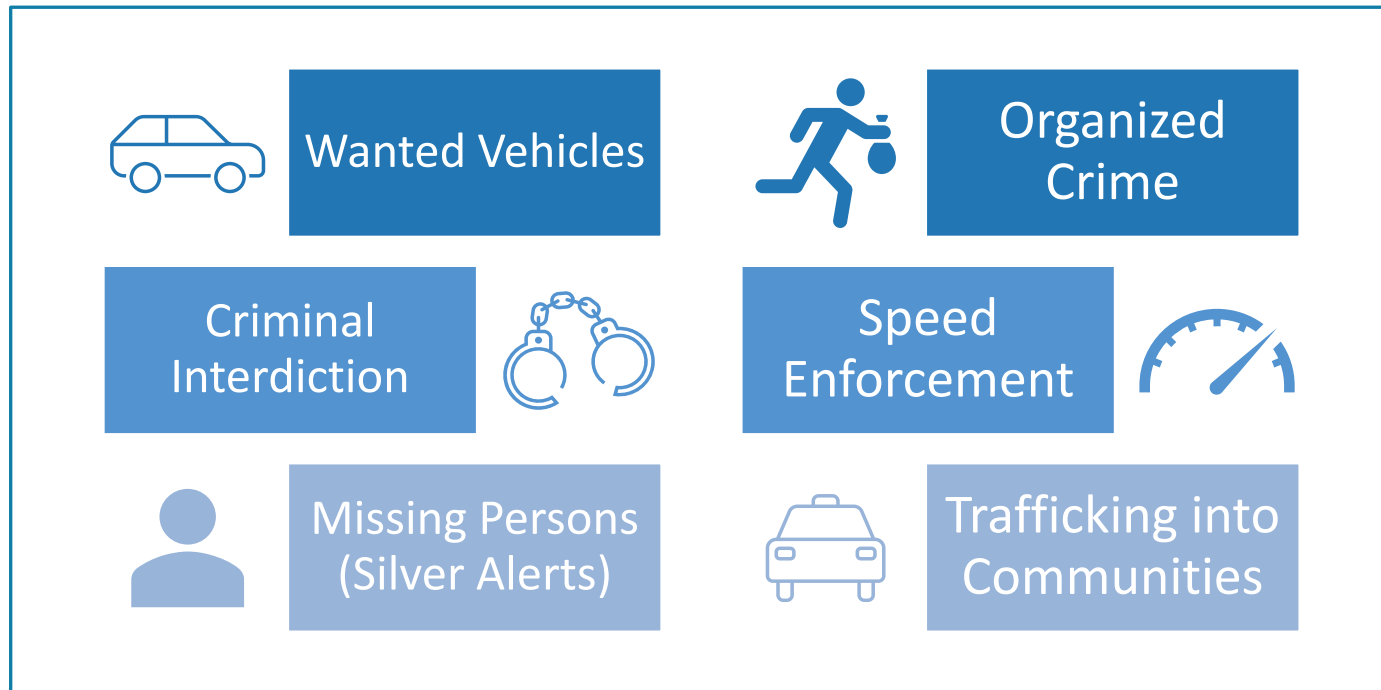

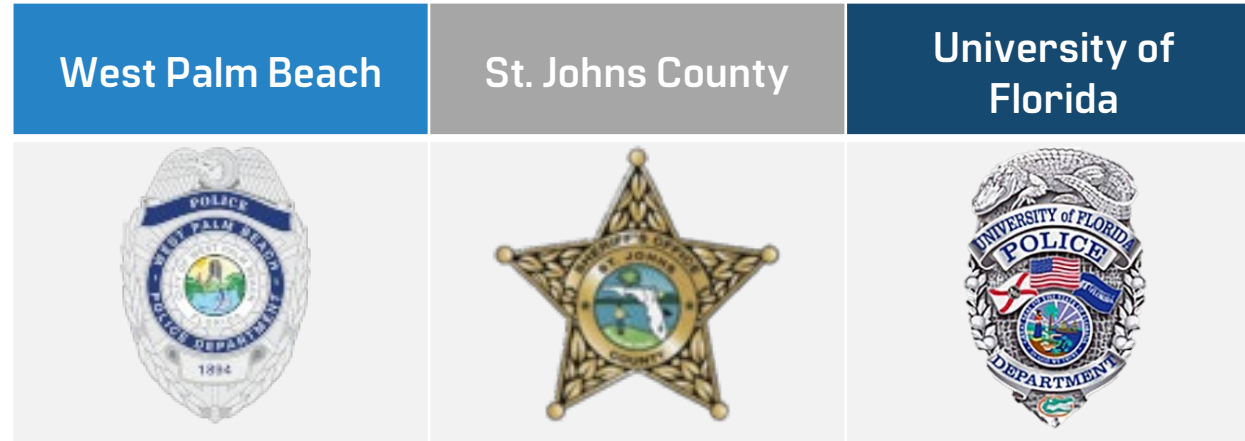

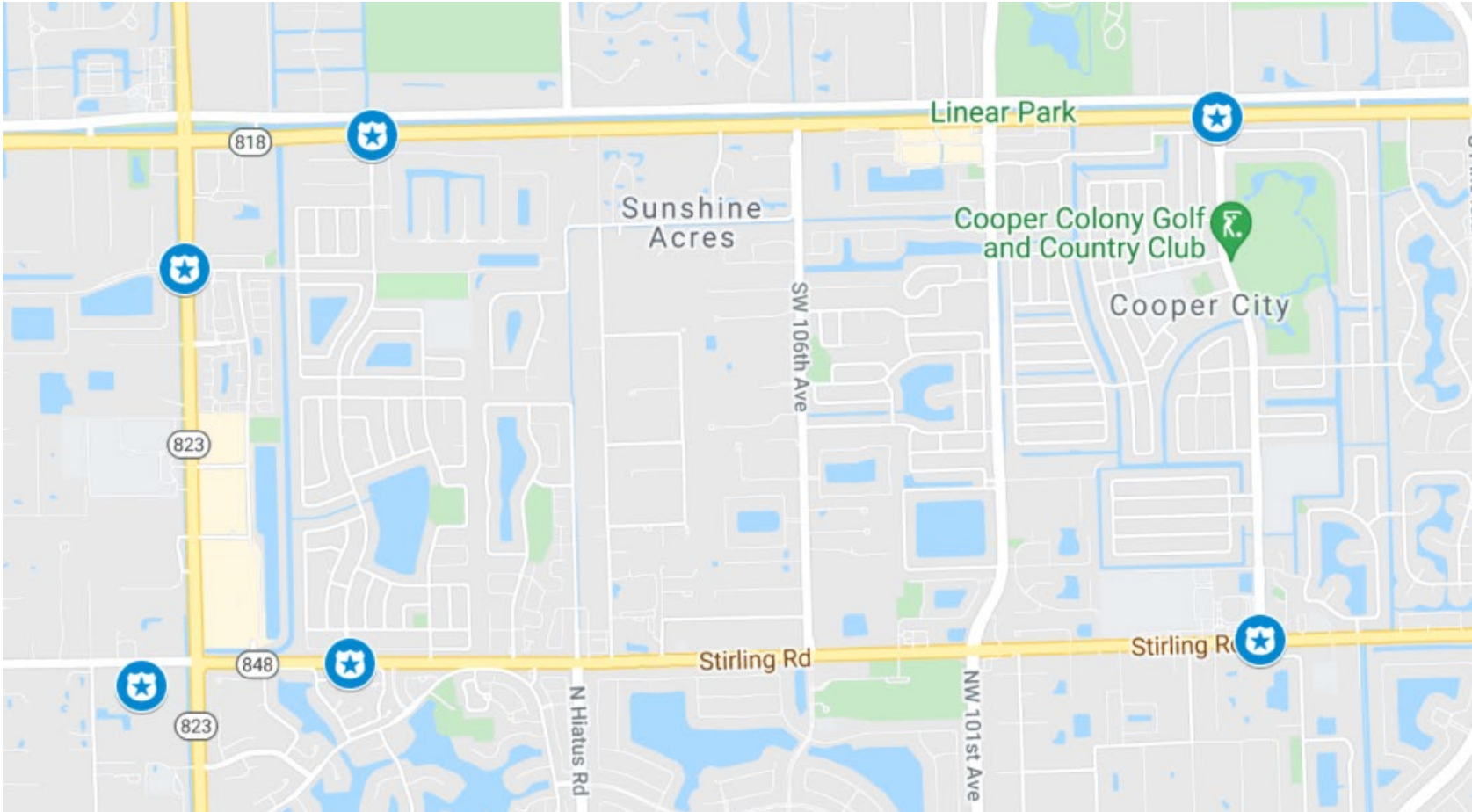

WARRANTY INFORMATION

During The Warranty Period

- This warranty covers any defects in equipment or workmanship under normal use during the warranty period.
- Vetted Security Solutions will repair or replace, at no charge, products or parts of a product that prove defective because of improper workmanship, under normal use and maintenance.
- Vetted Security Solutions will repair the product at no charge, using new or refurbished replacement parts.
- Vetted Security Solutions will be responsible for all shipping costs to and from the manufacturer.
- Vetted Security Solutions will assess customer discrepancies within a 72-hour period of being notified of issue by either the automated system or agency personnel.
- Vetted Security Solutions will provide a maximum fifteen (15) day turn-a-round on repairs from the date of receipt of the item.
- Vetted Security Solutions will assure that repairs are completed within specifications with OEM parts.
- The warranty period for equipment purchased from Vetted Security Solutions is 365 days from date of purchase.

What The Warranty Does Not Cover

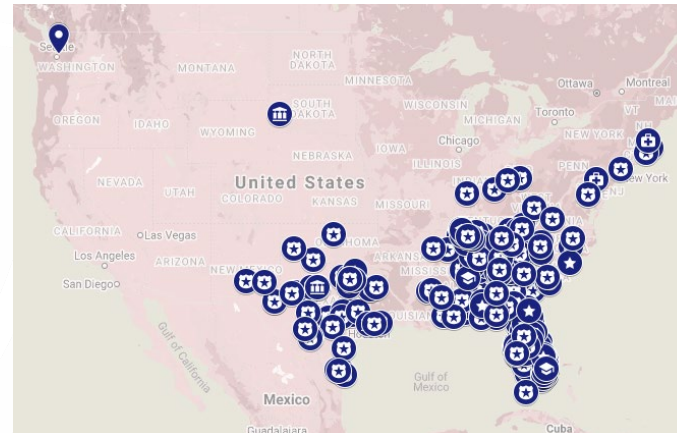
- This warranty does not cover vandalism or units that have been physically damaged in any way.
