# **MINUTES**

# **FINAL PUBLIC BUDGET HEARING**

Mayor Ross opened the meeting at 6:30 PM and led the assembly in the Pledge of Allegiance.

# **ROLL CALL**

Present were Commissioners Shrouder, Meltzer, Pulcini, Green and Mayor Ross.

# FINANCIAL MATTERS - PUBLIC HEARINGS | Fiscal Year 2022/2023 Budget and Taxes

## 1. **Ordinance 22-21 – (Finance)**

City Attorney Horowitz read "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, ESTABLISHING THE OPERATING MILLAGE RATE OF 5.875 OR \$5.875 PER THOUSAND DOLLARS OF TAXABLE ASSESSED PROPERTY VALUE, WHICH IS 4.26% PERCENT ABOVE THE ROLLED-BACK RATE OF 5.6348 FOR THE CITY OF COOPER CITY, FLORIDA, PURSUANT TO THE FY2022-2023 CITY BUDGET, IN ACCORDANCE WITH CHAPTER 200, FLORIDA STATUTES; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE" by title.

Commissioner Pulcini supports the rollback rate and believes this is the year to do so due to the issuance of the ARPA funds.

Commissioner Meltzer said the millage rate has gone down and the City is in good financial shape.

Commissioner Green supports 6.125 as recommended by staff.

Commissioner Shrouder advised he is disappointed the County Commission didn't roll back the millage rate. However, he is proud the current City Commission lowered the millage rate and is able to provide more services to the residents.

Mayor Ross asked City Manager Napoli if he is comfortable we 5.875. City Manager Napoli answered yes.

**MOTION:** Commissioner Pulcini moved to approve Ordinance 22-21. Commissioner Meltzer seconded the motion which prevailed by the following roll call vote. (3-2)

# 2. Ordinance No. 22 -22 (Finance)

City Attorney Horowitz read "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, ADOPTING AND APPROVING THE ANNUAL BUDGET FOR FISCAL YEAR 2022-2023, AND APPROPRIATING THE FUNDS REQUIRED FOR THE OPERATION OF THE CITY; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE" by title.

Commissioner Pulcini advised the budget was advertised without including the encumbrances of \$4.5 million per City Ordinance.

CFO Aaron Kendrick advised staff incorporated the encumbrances as part of the budget as an addendum.

Commissioner Pulcini asked City Attorney Horowitz to read section 2-206 of the City Code. City Attorney Horowitz advised all rollovers should be clearly delineated in the budget.

CFO Kendrick advised staff added the rollovers as an addendum to the budget. Commissioner Pulcini advised the number was not included in the budget. CFO Kendrick advised they clearly listed them in the addendum. Commissioner Pulcini said the statute exists so the residents know what is being rolled over and we did not advised them with the advertisement. Commissioner Pulcini said the list of encumbrances is also including operating costs.

Commissioner Meltzer asked City Attorney Horowitz if the budget presented by the Finance Department was presented correctly. City Attorney Horowitz answered yes, to the best of his knowledge. The Code requires a list of rollover appropriations and amounts provided to the Commission, which is included in the backup. The Code also requires the rollovers to be clearly delineated. The Code says any appropriation not included would not be valid. Commissioner Meltzer asked if all notices were proper. City Attorney Horowitz answered yes. Commissioner Meltzer said there could be some expenses included in the encumbrances not yet paid out.

Commissioner Pulcini asked if we should be rolling over operating expenses. City Attorney Horowitz said the code speaks to purchase orders.

Commissioner Shrouder asked if the \$4.5 million in encumbrances was included in the advertisement. CFO Kendrick answered no and the encumbrances will be refined. Commissioner Shrouder asked the requirement for advertising. City Attorney Horowitz answered the advertisement is for the proposed budget. He also advised the Commission has 60 days to amend the current budget and then amend next year's budget to accept the encumbrances.

CFO Kendrick advised the budget will be amended when the final number of encumbrances is determined.

Commissioner Shrouder asked if we advertised correctly. City Attorney Horowitz advised the code requires the amounts to be included in the budget. He has no reason to believe it was not advertised correctly.

Commissioner Shrouder said next year we need the appropriations done earlier. CFO Kendrick advised the schedule is given to the commission. Commissioner Shrouder said the advertisement did not include the rollovers.

Commissioner Green said the rollovers were approved and noticed in last fiscal year's budget. CFO Kendrick advised the rollovers are dollars not spent before the fiscal year ended however commitments were made with those dollars.

City Manager Napoli advised the code is not statutory. When the code was passed it was agreed the budget would need amended.

Commissioner Pulcini advised we should add what we know at the time the advertisement is published.

Commissioner Shrouder suggested we add a line to the budget that list encumbrances to a certain date to be included in the advertisement. CFO Kendrick agrees with his recommendation.

Commissioner Shrouder would like a link available to view the budget.

CFO Kendrick advised the action tonight will allow him to rollover encumbrances before the audit.

Commissioner Meltzer agrees that we need to add a line for encumbrances with a foot note.

City Attorney Horowitz advised the Commission can edit the budget tonight.

Commissioner Green said the encumbrances were included in the approved budget of the current year. He does agree with a foot note in the budget indicating the rollovers from a prior budget to the current budget.

Commissioner Shrouder said there will be more than \$4.6 added to fund balance at the end of the current year.

Commissioner Meltzer asked about fund balance at the end of year. CFO Kendrick explained years end expenses.

Commissioner Pulcini asked if the \$4.6 includes the BSO payments. CFO Kendrick advised he would need to clarify the BSO payment.

Commissioner Meltzer asked if we have collected all revenue for FY 2021/2022. CFO Kendrick answered we are at about 99% for revenue collection.

Mayor Ross opened the public hearing with no one wishing to speak. Mayor Ross closed the public hearing.

Commissioner Pulcini also advised the financials listed ARPA as revenue. CFO Kendrick answered there are audited financial statements and unaudited. He listed the funds as revenue as a clear display of available ARPA dollars.

Commissioner Meltzer asked that ARPA funds be indicated in the rollovers.

Commissioner Green asked if the majority of ARPA funds have been committed. CFO Kendrick advised we have \$17 plus and we have committed about \$3 million. The \$3 million spent were items that were approved by the Commission.

Commissioner Meltzer clarified the budget was noticed and presented properly. He would like to break down the encumbrance list by fund. Moving forward we need to include those in the advertisement. Commissioner Meltzer moved to approve the budget with this amendment.

Commissioner Shrouder suggested approving the budget as presented and then the future amendment would have better solid numbers for rollovers.

CFO Kendrick said if the rollovers are not approved they cannot honor payments.

Commissioner Shrouder said the commission needs to agree to present the amendment in 60 days.

**MOTION:** Commissioner Pulcini moved to approve Ordinance 22-22. Commissioner Meltzer seconded the motion which prevailed by the following roll call vote. (3-2)

Commissioner Shrouder moved to abate the Ordinance 22-5 for 60 days. Commissioner Meltzer seconded the motion.
