MINUTES

PLEDGE OF ALLEGIANCE

Mayor Ross opened the meeting at 5:30 PM and led the assembly in the Pledge of Allegiance.

ROLL CALL

Present were Commissioners Katzman, Shrouder and Mayor Ross. Commissioners Mallozzi and Green were absent.

PUBLIC COMMMENTS (3 MINUTES)

No public comments.

TOPICS FOR DISCUSSION

1. Discussion on FY 2023-2024 Budget

Commissioner Shrouder asked why the Commission holds a Commission Input Workshop prior to receiving the budget.

City Manager Eggleston recommends in the future a Budget Kickoff Meeting versus a Commission Input Meeting however, this year looks different due to time constraints.

City Attorney Horowitz advised Section 5.02 of the Charter requires the Public Input Meeting and the Commission Input meeting with the purpose of reviewing and considering recommendations resulting from the public input process and enabling the City Manager to obtain input from the Commission.

Commissioner Shrouder would like to have the year to date numbers for this meeting in the future. He said the City budgeted money for pickle ball enhancements and the updates made were minuscule. He asked what the process is for building new courts.

Commissioner Katzman said we need a review and repair schedule for the City's parks. He would like the addition of pickle ball courts to be included in the master plan for Parks and Recreation.

Mayor Ross said he is in favor of increasing the number of pickle ball courts but not to the detriment of removing the volleyball courts. He would like to have a variety of courts available to accommodate the Optimist and the pickle ball players.

Commissioner Shrouder said the Commission previously approved an Urban Planner to look at all of the City's recreational facilities but no plan was presented to the Commission. He stated someone needs to be responsible for a master plan for Parks and Recreation.

Mayor Ross believes the Parks and Recreation Director knows what is needed from the Optimist and the pickle ball community.

Commissioner Katzman said a master plan for Parks and Recreation will take into account all sports.

Commissioner Shrouder said the Commission needs to make a policy decision who will have the oversight or the vision to bring forth advancements to the courts.

Community Development Director Carlos Vega said staff has been in contact with several Urban Planning firms and have received a few proposals. However, the direction staff was given was for the Urban Planner to look at bike paths, trails to the parks, the dog park and a potential facility at Suellen Fardelman Park. He advised an Urban Planner does not typically look at additional courts but staff will bring forth the quotes they received on the initial scope.

Commissioner Shrouder said he was unware no action was being taken with the Urban Planner and if an Urban Planner does not look at facilities who can they contact to start the process. City Manager Eggleston said the City has a strong demographic of active recreation users. He said reaching out to users is important when looking for grant funding. However a comprehensive recreation plan is necessary when applying for grants. Commissioner Shrouder asked if the City currently has a comprehensive recreation plan. Mr. Eggleston answered no. Commissioner Shrouder asked how long it takes to develop a plan. City Manager Eggleston said they can reach out to firms and research the process for procurement but he does not believe the plan will be developed by September. A key component is outreach within the community.

Commissioner Shrouder said they have already held public input meetings and polled the community. He would like the City to develop a plan and then ask the residents if it is functional. City Manager Eggleston said staff can contact a firm to discuss costs and a timeline. Commissioner Shrouder would also like to explore short term solutions. City Manager Eggleston said staff will work diligently on short term solutions.

City Manager Eggleston said a capital improvement plan is needed. The comprehensive recreation plan would be a great item to add to a true capital plan. A true capital improvement plan is needed to drive the vision of a budget plan. Time wise this year we do not have enough time for implimentation but a capital improvement plan will be key in the budget process for the future.

Commissioner Shrouder said it sounds like the City is behind and asked what the immediate solution is to get caught up. City Manager Eggleston said identifying and talking to staff about making sound decisions before the plan is completed is important. Commissioner Shrouder asked who produces the capital improvement plan. City Manager Eggleston said the plan is staff owned and developed.

Mayor Ross understands the plan cannot be developed this year and said the Commission will be more productive moving forward.

City Manager Eggleston said the capital improvement plan will make it easier budget wise and leads to less surprises for the Commission and staff.

Mayor Ross asked if we have a process once we deem a vehicle is no longer useful. City Manager Eggleston said there is a surplus program.

Commissioner Shrouder said he does not recall approving a surplus resolution. City Attorney Horowitz recalls drafting two surplus resolutions in the past.

Commissioner Katzman would like to utilize the Recreation Advisory Board and involve the residents that play sports in the City. He would also like the beautification plan to be implemented before the next budget year. The traffic study, round-a-bout and the compensations study need to be budgeted

for this year. He also spoke on the need for a speaker recognition system for the dais and customer service training for staff. He would like to hire a consultant or temp worker for grant writing. He would also like to reconsider the mailing of the newsletters as it costs the City tens of thousands of dollars and incentivize residents to receive an electronic water bill to save on mailings. He asked for Commission consensus on his items.

Commissioner Shrouder said we need a department or division that can be responsible for capital improvements. City Manager Eggleston said next year they can look to build a list of priorities and a part of his role is assigning responsibility to handle the priorities.

Commissioner Shrouder said in the past the Commission budgeted funds for projects and the funds were not utilized. City Manager Eggleston said the balancing point is seeing forth the funds that are dedicated to projects.

Commissioner Shrouder said the online process for paying utility bills is antiquated. He asked how the Commission can give Mr. Eggleston the tools he needs to update these items. City Manager Eggleston said there are a fair amount of needs internally and externally. He advised a holistic plan needs developed. He advised time wise we are looking at next year's budget for the plan. Commissioner Shrouder asked Mr. Eggleston if he believes the City is behind on these items. Mr. Eggleston said he is still working through an assessment.

Mayor Ross has no issue with Commissioner Katzman's items.

Consensus was reached to look into Commissioner Katzman's recommendations.

Commissioner Shrouder said he would like to look at enhancements that can be completed now.

Commissioner Katzman said he would like to receive a plan to reduce expenses and increase revenues.

Commissioner Shrouder said the City's second largest revenue source is water billing and there were businesses with zero water usage and no water shutoffs in years. The City purchased meters twice that both had issues. These issues need addressed and corrected.

ADDITIONAL PUBLIC COMMENTS (3 MINUTES)

No additional public comments.
