SUBMITTING TO REFERENDUM AN AMENDMENT TO THE CHARTER OF THE CITY OF COOPER CITY AT ARTICLE III, ENTITLED "LEGISLATIVE;" AND IN PARTICULAR AMENDING SECTION 3.01 ENTITLED "CITY COMMISSION, POWERS AND **COMPOSITION"**; **AMENDING SECTION** 3.02, **ENTITLED** "OUALIFICATIONS, ELECTIONS AND TERMS;" **DELETING** SECTION 3.03, ENTITLED "ELECTION DISTRICTS," IN ITS ENTIRETY; AMENDING SECTION 3.07, ENTITLED "FILING FEES NOTICE OF CANDIDACY;" PROVIDING FOR ELIMINATION OF SINGLE-MEMBER COMMISSION DISTRICTS IN THE CITY OF COOPER CITY, COMMENCING WITH THE **NOVEMBER 2024 GENERAL MUNICIPAL ELECTION; PROVIDING** FOR THE CREATION OF THE POSITIONS COMMISSIONER 3 AND COMMISSIONER 4, WHICH SHALL BE ELECTED AT LARGE AT THE NOVEMBER 2024 GENERAL MUNICIPAL ELECTION, ALONG WITH AN AT LARGE ELECTED MAYOR; PROVIDING FOR THE CREATION OF THE POSITIONS COMMISSIONER 1 AND COMMISSIONER 2, WHICH SHALL BE ELECTED AT LARGE AT THE NOVEMBER 2026 GENERAL MUNICIPAL ELECTION: PROVIDING THAT THIS ORDINANCE, WHEN ADOPTED, SHALL BE SUBMITTED TO THE QUALIFIED ELECTORS OF THE CITY OF COOPER CITY, ON THE NOVEMBER 8, 2022 GENERAL ELECTION BALLOT AND IT SHALL BECOME EFFECTIVE AS PROVIDED BY LAW; PROVIDING FOR THE ADVERTISING OF THE REFERENDUM ELECTION; PROVIDING FOR CONFLICTS; **FOR SEVERABILITY**: **PROVIDING** CODIFICATION: AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Chapter 166, Florida Statutes, as amended, provides for a methodology of Charter amendments supplementary to and not in conflict with the Charter of the City of Cooper City, Florida; and

WHEREAS, Chapter 166, Florida Statutes, as amended, provides that such an amendment may be submitted to a referendum vote by the City Commission of the City of

WHEREAS, after careful deliberation and the consideration of public input, the City

Commission seeks to propose an amendment to the Charter eliminating election districts and

establishing four commission seats elected at large, along with an at large elected mayor; and

WHEREAS, the City Commission has held a public hearing in accordance with

Florida law; and

WHEREAS, the City Commission deems the proposed amendment to the City

Charter, as detailed herein, to be in the best interests of the citizens and residents of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF

THE CITY OF COOPER CITY, FLORIDA, THAT:

Section 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed

as being true and correct and are hereby made a specific part of this Ordinance upon adoption

hereof.

Section 2. Article III, entitled "Legislative," shall be revised by amending Section

3.01 entitled "City Commission; Powers and Composition;" amending Section 3.02, entitled

"Qualifications, Elections and Terms;" deleting Section 3.03, entitled "Election Districts;" and

amending Section 3.07, entitled "Filing Fees and Notice of Candidacy" of the Charter of the

City of Cooper City, as set forth in Exhibit "A," attached hereto and incorporated herein.

Section 3. The Ballot Title shall be as follows:

LARGE COMMISSION SEATS

Section 4. At the General Municipal Election on November 8, 2022, the following question shall be placed on the ballot for consideration by the qualified electors of the City of Cooper City, Florida, and shall read as follows:

Shall the Cooper City Charter be amended to provide for the elimination of single-member commission districts and the establishment of four (4) commission seats elected at-large, along with an at-large elected mayor; commencing in November 2024 with the positions of Commissioner 3, Commissioner 4 and the mayor elected at-large, and in November 2026 with the positions of Commissioner 1 and Commissioner 2 elected at-large?

This proposed Charter amendment will have no financial impact to the City.

Section 5. Advertisement. The City Clerk of the City of Cooper City is hereby authorized and directed to advertise the referendum election contemplated herein all in accordance with the Code of Ordinances of the City of Cooper City, Florida, as well as the State of Florida Election Code.

It is the intention of the City Commission of the City of Cooper City that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of the City of Cooper City, Florida, and that the Sections of this Ordinance may be renumbered, re-lettered and the word "Ordinance" may be changed to "Section," "Article," or such other word or phrase in order to accomplish such intention.

Section 7. Severability. If any clause, section, or other part of this Ordinance shall

Section 9. Effective Date. This Ordinance shall take effect immediately upon its adoption.
