MINUTES

PLEDGE OF ALLEGIANCE

Mayor Ross opened the meeting at 6:34 PM and Carly Jenkins led the assembly in the Pledge of Allegiance.

ROLL CALL

Present were Commissioners Shrouder, Meltzer, Pulcini, Green, and Mayor Ross.

CHANGES TO AGENDA/EMERGENCY MATTERS

None.

PROCLAMATIONS/PRESENTATIONS

Commissioner Shrouder presented Yard of the Month to Michael and Randi Adario.

Captain De Giovanni gave a presentation on LETF: ALPRS & Crime Prevention. He spoke on the benefits of automated license plate readers and provided information on numerous crimes. He stated that it brings value to economic development and will benefit residents for many years to come.

Commissioner Meltzer asked about the use of ARPA funds.

City Manager Napoli stated the City is researching what ARPA funds can be used for in relation to the program.

Commissioner Pulcini thanked Captain De Giovanni for the presentation and suggested we incentivize the HOA's to connect their security systems.

Mayor Ross asked if the LETF funds are priority. City Manager Napoli advised for the initial portion they will utilize LETF funds.

Commissioner Meltzer asked that the use of ARPA funds be looked into and brought back to prioritize the need.

Captain De Giovanni said the second portion of the LETF is to fund the crime prevention fund and chip a pet this fiscal year, which is a free service to residents.

PUBLIC SPEAKING

Open Public Meeting -

Greg Manuel, spoke on a citation he received for a commercial vehicle.

Commissioner Pulcini asked if there are stipulations in the code for commercial vehicles.

Captain De Giovanni spoke on section 25-10.

Commissioner Green asked if there was a way to inform code about a vehicle temporarily being parked in the driveway.

City Attorney Horowitz advised that there is currently no waiver opportunity for that.

Commissioner Shrouder asked how the code could be changed to recognize an exception.

Commissioner Green suggested that commercial vehicles could apply for a permit.

Commissioner Shrouder stated that the code is fine, but more communication is needed.

Mayor Ross a SW dvised the Community Development Department will look into possible revisions that may need to be made.

Commissioner Meltzer advised Mr. Manuel that someone from the city staff will contact him when the issue is placed on the agenda.

David Nall spoke on lack of backup to the agenda items. He has a concern with agenda item 11. He asked the commission about the temporary labor invoices.

Marvin Stewart spoke in support of the two full-time facility maintenance positions and asked commission for a better resolution.

Susan Stewart also spoke in support of the two full-time facility maintenance positions.

Paul Higdon, spoke in support of the two full-time facility maintenance positions He thanked the commission for putting this item on the agenda.

Jimmy Goulet spoke on Mayor Ross meeting a resident and fees for Optimist and certain parks. He suggested a surcharge to assist with maintenance.

MOTION: Commissioner Meltzer moved to approve the consent agenda. Commissioner Pulcini seconded the motion which prevailed by a unanimous roll call vote (5-0).

REGULAR AGENDA

Discussion on Commission team building workshop - Commissioner Shrouder

Commissioner Shrouder advised this item was brought back to include Commissioner Green as he was not at the previous meeting.

Commissioner Green said that they have had several team building workshops in the past. He suggested having an independent contractor to facilitate.

Commissioner Pulcini had concerns about costs for a facilitator.

Commissioner Meltzer supports the workshop.

Mayor Ross advised he sent some options to the City Manager to review for a possible workshop.

Motion to approve first renewal of agreement with TD Bank for Procurement Card Services - Finance

Commissioner Pulcini spoke on providing financial statements within 150 days of year end.

CFO Bridgeman is aware of the concerns.

City Manager Napoli advised the clause can be amended to ensure enough time.

Commissioner Pulcini asked if financial statements could be completed in February. CFO Bridgeman answered the numbers may not be in then.

City Attorney Horowitz advised this contract is a piggyback with the City of Deerfield.

Mayor Ross about the limiting reimbursement to the city and the liability issue of \$10,000.

City Attorney Horowitz stated the cap applies to the first year of the renewal and the limitation is half of one percent of the prior year.

Commissioner Shrouder asked if this applies to the line of credit and if there is language in the line of credit documents that reference the agreements are applicable.

Attorney Horowitz advised these are two separate items.

Commissioner Meltzer asked if there is a ceiling on the rebate CFO Bridgeman answered no.

MOTION: Commissioner Pulcini moved to approve first renewal of agreement with TD Bank for Procurement Card Services. Commissioner Green seconded the motion which prevailed by a unanimous roll call vote (5-0).

Motion to approve agreement with Allied Universal for Sodium Hypochlorite – Utilities

MOTION: Commissioner Meltzer moved to approve agreement with Allied Universal for Sodium Hypochlorite. Commissioner Pulcini seconded the motion which prevailed by a unanimous roll call vote (5-0).

Discussion and possible action on reconsidering the conversion of two full time Facility and Recreation Assistants positions to four part-time positions – Mayor Ross

Mayor Ross had asked for this item to be brought back for reconsideration. He advised full time positions offer continuity and history. He believes it is the City Manager's decision on whether a position is part time or full time with regards to operations. Mayor Ross asked for the vote to be recalled.

Commissioner Shrouder advised that would require a budget amendment.

Commissioner Pulcini said it is not necessary to amend the budget. There is a position open for park ranger.

Mayor Ross asked City Attorney Horowitz if a budget amendment is needed. City Attorney Horowitz replied if there is no change to the financial impact, it may not require an amendment. It depends on what the commission's direction is.

Commissioner Shrouder said the reason they have this issue is because there was no communication with employees. He said they voted to change the job description not to terminate employees. The city

should have reached out to the employees. He advised if it is more efficient and a better product for the position change, it needs to be done.

Mayor Ross advised he spoke to the Recreation Director and City Manager who spoke on the benefits of full time positions compared to part time.

Commissioner Shrouder advised he did not have that conversation with the Recreation Director of City Manager and does not agree that part time positions are not as efficient as full time positions.

Mayor Ross said that the points that were made are well taken and his own investigation led him to reconsider. He asked City Manager Napoli how it would be best to work out having the two full time positions reinstituted. City Manager Napoli stated there is a couple of options. They could just reinstitute the positions or there is a full time park ranger position available.

Commissioner Shrouder said he went on the website and there are full time positions available right now. He also advised a lack of communication from the City to the employees is the issue.

Commissioner Meltzer said it is a lack of communication. He wants to be more efficient and do more with less but also does not want anyone to lose their job. He said that the park ranger position is available and he supports shifting the employees into those positions. He also advised the Commission sets policy and it is up to the city staff to handle the rest. The City needs to be better with communication and in the future they can swap full time positions with part time, if feasible.

Commissioner Green said full time employees are an important part of the City and that is apparent with resident's comments. He supports Mayor Ross.

Commissioner Shrouder said he does not want anyone to lose their job and Human Resources should have discussed options and issues with the employees. He asked why the community center would need a full time employee.

Commissioner Green asked if there are open part time positions in the recreation department and the turnover rate.

Recreation Director Stacie Weiss advised there are part time positions for youth program instructor, facility attendants, and park attendants.

Commissioner Shrouder said the payment amount on the website for the park attendant position is not accurate.

Commissioner Shrouder asked Director Weiss if she met with the two employees about the vacant park attendant position.

Commissioner Meltzer advised City Manager Napoli and staff should find a way to place the two employees in different positions and deal with it at the manager's level.

Commissioner Shrouder said the need of the city comes first and some descriptions are inaccurate.

City Manager Napoli advised staff will reevaluate the options.

REGULAR RESOLUTIONS

Resolution 21-47 (Administration)

City Attorney Horowitz read "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, TO APPROVE AND EXECUTE THE REGIONAL INTERLOCAL AGREEMENT FOR COOPERATIVE FIRE, RESCUE, EMERGENCY MEDICAL SERVICES, AND SPECIAL OPERATIONS RESPONSE THROUGH AUTOMATIC AID AND CLOSEST UNIT RESPONSE BETWEEN THE CITY OF COOPER CITY, THE BROWARD COUNTY SHERIFF'S OFFICE, AND BROWARD COUNTY, ATTACHED HERETO AS EXHIBIT "A" AND INCORPORATED HEREIN; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THIS AGREEMENT; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE" by title.

Commissioner Pulcini advised this agreement will improve response time and residents will benefit from it.

Commissioner Meltzer advised education is necessary.

Commissioner Shrouder explained that with priority calls, the closest unit will respond.

Mayor Ross spoke on concerns and asked about fees assessed if the agreement is not executed. Chief Bishop answered about \$16,000.

Mayor Ross asked why the Broward League was not involved.

Chief Bishop said they were in 2002. He also advised this is through Broward County not BSO.

Mayor Ross asked if the airport and seaport are a part of this ILA. Chief Bishop responded that he does not know. Some other municipalities have had similar questions.

Commissioner Green said the ILA is in the best interest for the community.

MOTION: Commissioner Pulcini moved to approve Resolution 21-47. Commissioner Shrouder seconded the motion which prevailed by a unanimous roll call vote (5-0).

CITY MANAGER REPORT

Budget Transfer Notification

City Manager Napoli said Mr. Nall's comment about not having enough backup is understood and there will be more backup in the future.

City Manager Napoli spoke on two budget transfers the internal auditor for risk assessment and the vacancy for the executive assistant.

Commissioner Pulcini advised a purchase order was missing.

Commission Meltzer said he knew about the temporary position but does not remember hiring a temp agency.

Commissioner Pulcini asked City Manager Napoli to look for other amounts that were spent and not encumbered.

Commissioner Meltzer asked for an agreement or purchase order authorizing it.

City Manager Napoli said Athena the agency is a part of a co-op agreement.

Commissioner Pulcini asked if the city has to pay them a fee for every employee hired. City Manager Napoli responded only if the temp agency is used.

Commissioner Meltzer said when he asked for backup, he received time sheets approved by the City Clerk.

Commissioner Shrouder asked what the \$19,000 is for. City Manager Napoli advised wages and fees.

Response on Recycling Issue from a Previous Agenda

Henry Sori and Dawn McCormick from Waste Management gave a recycling presentation.

Commissioner Meltzer thanked Waste Management for the presentation. He asked about the monthly processing fee. Customer Service Supervisor Gabe Guerrero answered it is a true up and is based off of the average.

Commissioner Shrouder asked how much garbage and recycling is per residential household.

Mr. Guerrero answered under \$31.

Commissioner Shrouder mentioned that Davie has a proposal of \$5.75 per household for solid waste.

City Manager Napoli stated that Davie does not recycle but they are looking into it.

Commissioner Meltzer asked about other recycling options.

Commissioner Shrouder asked when the hauling contract will end.

Mr. Guerrero responded in September of 2023.

Commissioner Shrouder requested an alert if the market changes.

Mayor Ross asked how much commercial recycling pays as opposed to residential.

CITY ATTORNEY REPORT

None.

POLICE CHIEF'S REPORT

Captain De Giovanni spoke on school updates such as a parking lot option for Griffin Road. He discussed student safety with social media trends and provided an educational flyer to schools. He also spoke on the funeral services for Miya Marcano taking place in Cooper City. He reminded residents about Operation Front Porch and encourages everyone to take advantage of the free program. He discussed outreach at Renaissance Charter and recruitment for the Explorer's program. He also stated there is one community involvement specialist vacancy.

Commissioner Shrouder spoke on his support of Code Enforcement and their efforts.

FIRE CHIEF'S REPORT

Chief Bishop advised the fire hydrant maintenance will be completed by the end of the year and inspections are on track to finish with 100 percent compliance. He spoke on life safety educators presenting for fire prevention month and thanked Mayor Ross for helping him contact the Cooper City High School principal. Lastly he reported rescue 28 is currently out of service due to mechanics and platform is out of service.

Cooper City Hall: The legislative chair of recycle Florida today, so I spend about 20 or 30% of my time on recycling issues statewide i'm also on the Florida working group.

Cooper City Hall: that's working with ftp on the 75% recycling goal, so I just share that so um you understand my background on the recycling issues that we're going to talk about today.

Cooper City Hall: And this slide talks about the significant environmental benefits of recycling and largely with the reduction in greenhouse gas emissions that we are all striving to do when you recycle.

764

Cooper City Hall: metal paper and plastic you're actually avoiding the most greenhouse gas emissions of any materials, because you're replacing less virgin material to make new products.

765

Cooper City Hall: And the other point I want to make is an item's not recycled if it doesn't have an end market and we're going to talk a little bit about and markets tonight to.

766

Cooper City Hall: There has to be a demand for a finished product, you have to be able to sell that bale of recyclables in order to truly recycle on the right, it shows you the different greenhouse gas emissions for the different materials.

767

Cooper City Hall: and waste to energy technically is not recycling because you're not saving the Virgin material in the in the manufacturing process Florida, is the only state in the country that does count.

768

Cooper City Hall: waste to energy for recycling credits up in tallahassee but it doesn't meet the typical definition of recycling because you're not saving that virgin material.

769

Cooper City Hall: So this slide is really important to understand what has happened in the recycling markets over the last three or four years.

Cooper City Hall: And we all know that recycling hit a challenging period starting in 2017 that's when China which, if you look at the graph in 2017 China was taking 27% of all of the global recycling.

Cooper City Hall: into that country through a series of measures, the first was green fence the national sword, the Chinese Government really shut their door to global recycling and you saw it dropped 25% for so through those years.

Cooper City Hall: It was a huge glut of recyclable bails on the global market, with no home.

773

Cooper City Hall: And that's why you're going to see in the next chart price drop, but what I wanted to show you on this is the good news over the last three years, as we got through a really tough time.

Cooper City Hall: Is the majority of that market now stays in the United States, we went from 62% to 81%.

Cooper City Hall: Including ironically, the Chinese have come over here and built paper markets in our backyard, but also the plastics market and waste management, where the nation's largest.

Cooper City Hall: This charts really important from an economic standpoint, it shows you again why the last three years were very challenging when China closed its doors we had.

Cooper City Hall: An average ton of recyclable material, and that would include the average of paper aluminum plastic and glass was averaging about \$110 a ton down at the lowest periods, a.

Cooper City Hall: Q4 of 19 it dropped down to under \$40 a ton so that's why recycling got very, very expensive here for a while the great news is I showed you is we've been able to rebound the markets of rebound.

Cooper City Hall: We are now up to over 20 \$96 a ton of the last couple months it's even been higher, we do expect those prices to continue to stay high we think we we rode through the real tough period and we're back up in an upswing.

Cooper City Hall: and also one of the things we've learned through the pandemic was how important recycled material was to the manufacturing supply chain.

Cooper City Hall: All have sustainability goals, where they want more and more of their containers to have recycled content, so the market for recycling right now is booming and.

Cooper City Hall: So coming now closer to home we're going to talk a little bit about waste management management's router recycling in pembroke pines.

Cooper City Hall: That is where your material goes, it is the largest recycling facility in the southeastern United States we have tremendous capacity and technology there.

Cooper City Hall: And in that last year period from June 2022 may 2021 we processed about 2100 tons of recyclables so the way the economics work are your residents are billed monthly for sanitation and recycling services through their utility bill.

Cooper City Hall: They pay \$4 and 87 cents, a month for recycling \$3 and 29 cents, is for the collection, at their homes and then \$1 58 is for the processing and router.
