MINUTES

PLEDGE OF ALLEGIANCE -

Mayor Ross opened the meeting at 6:30 PM and led the assembly in the Pledge of Allegiance.

City Attorney Horowitz read the decorum policy as follows: Members of the Commission, staff members, citizens, and others are required to use civil and appropriate language when addressing the Commission or anyone present at the meeting and must refrain from using profanity, cursing, or exhibiting aggressive or threatening behavior. All comments should generally be directed to the presiding officer and not to individual members of the Commission, staff, or the audience. No personal verbal attacks toward any individual by either the Commission, staff, citizens, or others shall be allowed during any meeting of the Commission. Any persons making impertinent or slanderous remarks or personal attacks or who becomes boisterous while addressing the Commission or who otherwise violates the decorum rules set forth herein shall be barred from further audience before the Commission by the Mayor, or by request of any member of the Commission unless permission to continue or again address the Commission be granted by a majority vote of the Commission members present.

5. Appointment to the Business Advisory Board

City Clerk Tedra Allen advised Commissioner Katzman appointed Christian Spano to the Business Advisory Board.

6. Budget to actuals / City Financial Report - Finance

CFO Irwin Williams advised the financials are for the last six months ending March 31, 2024. The cash and cash investments were \$34.6 million at the end of March. The unassigned fund balance was \$31.6 million. At the end of March we were 50% of the way through the fiscal year. For debt service we repaid the \$50,000 dollar line of credit back to the bank. For capital outlays we are at 65% expended which is the purchase of two trucks and the LED monument signs. For the proprietary funds for Water and Sewer the excess of revenues over expenditures is \$1.6 million. CFO Williams advised he is currently in the process of reallocating all the investments and is in final negotiations with the bank to move our operating accounts within the next two weeks.

MOTION: Commissioner Katzman moved to approve the consent agenda. Commissioner Green seconded the motion which prevailed by a unanimous roll call vote. (5-0)

REGULAR AGENDA

12. Update and Possible Action on the City Manager Agreement

City Attorney Horowitz advised as directed by the Commission Mayor Ross had the authority to negotiate a recommended contract with Mr. Rey to step in as the incoming City Manager. On Monday May 13th the Mayor, Mr. Rey, and he sat down to have that public conversation in accordance with Chapter 286.011 of the Florida Statutes. As a matter of procedure they started with the current agreement that the City has with Mr. Eggleston as a predicate for a starting point. The agreement in the backup is an outgrowth of the negotiations that the Mayor conducted with Mr. Rey. The start date of the agreement is June 1st with the first date of employment on June 3rd. Mr. Rey would receive eight weeks of severance through November 1st and between November and May 31st of 2025, 14 weeks with the one year anniversary at 17 weeks. Following the second year of employment at 20 weeks. The salary proposed and recommended by Mayor Ross is \$227,500. There was an indemnification provision that Mr. Rey had requested. It is consistent with the requirements of Florida Law. Mr. Rey has agreed to waive all health insurance with a provision added that would entitle Mr. Rey to a payment of \$10,000 annually in lieu of the health insurance payment. That amount is broken down into equal monthly installments. There was also a provision added that relates to a cell phone allowance which is consistent with the City's current personnel manual.

Commissioner Shrouder moved to approve the agreement with Alex Rey. Commissioner Katzman seconded the motion.

Commissioner Green advised he will not be supporting the agreement based on historical processes with regard to hiring a City Manager. He explained at the Special Meeting of May 6th there was a motion to have Mayor Ross negotiate a contract with Mr. Rey who was a candidate from the 2023 City Manager search. He was hopeful that the Commission would of reached out to both of the candidates that were ranked second not just Mr. Rey. He explained he will not support the agreement due to a process not being followed.

Mayor Ross said everyone had an opportunity to reach out to any candidate. Mr. Rey was not his first or second choice. There have been six City Managers in the past five years and that is not a record they should be proud of. He is asking the Commission to rectify the issue and give Mr. Rey a chance. A unanimous vote would be wonderful for an incoming City Manager. He is asking everyone to reconsider their thinking and have a positive attitude towards a new start.

Commissioner Shrouder thanked Mayor Ross for negotiating the contract with a great salary to move the City along.

Commissioner Katzman said he reached out to Mr. Rey as he disclosed previously. Other Commissioners also had the opportunity to bring other ideas to the table. He is happy to support Mr. Rey and hopefully welcome him to the City.

Commissioner Green said several years ago there was a unanimous vote for a City Manager candidate named Tom Jones and the Commission at the time instead hired an Interim City Manager who did not apply. He voted against that individual but once he came aboard as City Manager he had his full support. He also voted against the hiring of the current City Attorney's Office due to a process not being adhered to. That law firm is still here today and he is thankful for Mr. Horowitz. Not supporting the agreement does not mean he will not support the candidate.

Commissioner Mallozzi does not support the candidate or the process. She spoke to people from two of the candidates former cities and there was discontent pre and post-election. She also disagrees with the severance package being based on elections. Turnover is a part of the job. She also said the negotiations were very quick.

Mayor Ross appreciates the professionalism in the negotiations. He advised this contract is costing the City less than the current contract with the City Manager.

Alex Rey said it will be an honor and privilege to be named City Manager if that is the will of the Commission today. He said to Commissioner Green and Mallozzi if he does not receive their vote today he hopes through his work and actions he can gain support in the future.

MOTION: Commissioner Shrouder moved to approve the City Manager agreement with Alex Rey. Commissioner Katzman seconded the motion which prevailed by the following roll call vote. (3-2)

REGULAR RESOLUTIONS

Commissioner Shrouder believes the 90 day extension should not include blanket bookings. Parks and Recreation Supervisor Josh Rhodes said staff will review all bookings and use discretion. Commissioner Shrouder does not want one individual to fill the entire calendar. Commissioner Shrouder recommended adding the language "waive or deny" to the following clause "the City's designee may waive the application timeframes provided on a case by case basis.

MOTION: Commissioner Shrouder moved to approve Resolution 24-11 with the addition of the following language "the City's designee may waive or deny the application timeframes provided on a case by case basis." Commissioner Green seconded the motion which prevailed by a unanimous roll call vote. (5-0)

ORDINANCES ON FIRST READING

14. Ordinance 24-09 (Parks& Recreation)

City Attorney Horowitz read "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA; AMENDING CHAPTER 12 OF THE CITY'S CODE OF ORDINANCES, ENTITLED, "PARKS AND RECREATION" BY SPECIFICALLY AMENDING SECTION 12-46(B), ENTITLED "APPLICATION PROCEDURE"; EXTENDING THE PERIOD TO SUBMIT AN APPLICATION TO UTILIZE PASSIVE RECREATIONAL FACILITIES AT CITY PARKS;

PROVIDING FOR CONFLICTS; PROVIDING FOR CODIFICATION; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE" by title.

MOTION: Commissioner Shrouder moved to approve Ordinance 24-09. Commissioner Katzman seconded the motion which prevailed by a unanimous roll call vote. (5-0)

15. Ordinance 24-11 – (Community Development/BSO Code Enforcement)

City Attorney Horowitz read "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING THE CITY'S CODE OF ORDINANCES BY AMENDING CHAPTER 17, ENTITLED "TRAFFIC AND MOTOR VEHICLES," BY AMENDING SECTION 17-18 ENTITLED "PROHIBITED STOPPING, STANDING OR PARKING ON CERTAIN ROADWAYS," TO PROHIBIT VEHICLES FROM BLOCKING TRAFFIC DURING SCHOOL HOURS AND TO REQUIRE VEHICLES PARKING ALONG ROADWAYS TO FACE THE FLOW OF TRAFFIC; AMENDING SECTION 17-19 ENTITLED "PARKING PROHIBITED OVER CATCH BASINS," TO PROHIBITED PARKING, ADDITIONAL REGULATIONS," TO PROHIBIT PARKING WITHIN RIGHTS OF WAYS AND SWALES, AND TO PROHIBIT TRAILERS, COMMERCIAL VEHICLES, AND RECREATIONAL VEHICLES FROM PARKING ON ROADWAYS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE" by title.

Commissioner Shrouder said Section 17-18(e)(5) states "Unless otherwise provided, citations issued for traffic or parking related offenses under this section shall be in the amount of \$25.00 for each offence, plus all applicable fees assessed by the Broward County Clerk of Courts." He believes \$25.00 is not sufficient. Captain De Giovanni said the violation is actually \$100.00 the language Commissioner Shrouder mentioned had not been changed. Captain De Giovanni also said they do have a Parking Enforcement Team that does go out throughout the week and he does receive complaints about the \$25.00 ticket. He would prefer to leave the \$25.00 amount. Commissioner Shrouder said in Section 17-19 it states "Swale shall mean the area of land located in the public right-of-way between the edge of the street pavement and the front property line of the adjacent property." He would like to include the words front or side because there are swales on the sides of certain properties. In Section 17-19(b)(2) he would like to change the language "without the consent of the owner, lessee or other person entitled to the possession and use of the property" to "without the consent of the owner, lessee or other person entitled for maintaining the property." He also asked if 36 hours too much time for correction. Captain De Giovanni said they felt 36 hours is a good number as there would be reasons such as holidays or celebrations were a vehicle would stay at a property for more than 24 hours. Captain De Giovanni also asked that the language "edge of the road to the property line" be used for the swale definition as it will capture all areas.

Commissioner Mallozzi said the language "between the edge of such roadway and the edge of a public sidewalk" is already listed in Section 17-18.

Commissioner Shrouder would like the language to be consistent.

Commissioner Shrouder asked the reasoning behind no parking over catch basins. Captain De Giovanni explained there are concerns with vehicle fluids going into the utility systems.

Commissioner Mallozzi said residents place things between the end of the swale and the roadway and that is precluded. By prohibiting parking in the swales without the homeowner's permission we are negating what the swale intent is. Captain De Giovanni said at the December 12, 2023 Code Workshop there were concerns where individuals were using the swale areas of neighbors. Commissioner Mallozzi asked if a resident who lives near a school zone would be able to utilize their swale for parking of their vehicle. Captain De Giovanni said parking is prohibited where there are signs posted. He can look into options for certain areas near school zones. Commissioner Mallozzi asked how the 36 hour rule can be enforced if a car leaves and returns. Captain De Giovanni said the ordinance was built similar to the commercial vehicle ordinance with a presumption built in. The main idea is to have enough time for the swale owner to maintain the swales. Commissioner Mallozzi said up North there would be specific times and days designated for parking. She asked if this method could be beneficial. Captain De Giovanni said they have looked into several creative solutions. They can monitor the current recommendations to see if additional changes need brought forth.

MOTION: Commissioner Green moved to approve Ordinance 24-11 as amended to include the language "without the consent of the owner, lessee or other person entitled for maintaining the property" in Section 17-19(b)(2) and making the swale definitions consistent with the language "the edge of such roadway and the edge of a public sidewalk." Commissioner Shrouder seconded the motion which prevailed by a unanimous roll call vote. (5-0)

16. **Ordinance 24-06 - (Finance)**

Mayor Ross opened the public hearing with no one wishing to speak. Mayor Ross closed the public hearing.

MOTION: Commissioner Katzman moved to approve Ordinance 24-06. Commissioner Shrouder seconded the motion which prevailed by a unanimous roll call vote. (5-0)

City Attorney Horowitz read "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING CHAPTER 2 "ADMINISTRATION", ARTICLE VI, "EMPLOYEE BENEFITS", DIVISION 2 "RETIREMENT PLAN", SECTION 2-158 "FIREFIGHTERS' PENSION PLAN" OF THE CITY OF COOPER CITY MUNICIPAL CODE OF ORDINANCES BY AMENDING ARTICLE XII, "COMPLIANCE WITH THE INTERNAL REVENUE CODE", TO PROVIDE FOR COMPLIANCE WITH SECURE 2.0 ACT; PROVIDING FOR SEVERABILITY, THE REPEAL OF LAWS IN CONFLICT, CODIFICATION, AND AN EFFECTIVE DATE" by title.

Mayor Ross opened the public hearing with no one wishing to speak. Mayor Ross closed the public hearing.

City Attorney Horowitz read "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING THE CITY OF COOPER CITY'S FIREFIGHTERS RETIREMENT PLAN CODIFIED IN CHAPTER 2 "ADMINISTRATION" OF THE COOPER CITY MUNICIPAL CODE OF ORDINANCES TO COMPLY WITH CHAPTER 2019-21, LAWS OF FLORIDA; BY AMENDING ARTICLE IX, DISABILITY, AND ARTICLE XI, DEATH BENEFITS, OF SECTION 2-158; PROVIDING FOR REPEAL; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE" by title.

Mayor Ross opened the public hearing with no one wishing to speak. Mayor Ross closed the public hearing.

City Attorney Horowitz read "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING ORDINANCE NO. 23-21, ADOPTED ON SEPTEMBER 26, 2023; PROVIDING FOR AN AMENDED BUDGET FOR FISCAL YEAR 2023-2024 FOR THE CITY, ATTACHED HERETO AS EXHIBIT "A" AND INCORPORATED HEREIN; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE" by title.

Mayor Ross opened the public hearing with no one wishing to speak. Mayor Ross closed the public hearing.

CITY MANAGER REPORT

No City Managers Report.

Commissioner Shrouder said assuming Mr. Rey signs his agreement and starts June 1st it is his hope that Mr. Eggleston and Mr. Rey can work out their schedules together. He is okay with Mr. Eggleston working remotely towards the end as long as he is accessible.

Mayor Ross said he spoke with Mr. Rey and City Manager Eggleston and figured two weeks would be sufficient working with each other. If the time needs adjusted he is sure they will work that out professionally.

Commissioner Katzman is fine with Mr. Eggleston working remotely as long as he is accessible.

Consensus was reached to allow City Manager Eggleston to work remotely after Mr. Rey is employed as long as he is accessible to assist.

Commissioner Katzman wants to ensure that the remaining job descriptions that have not been approved are placed on the May 28th agenda and the items in the personnel manual will be presented at the June 11th meeting. City Manager Eggleston agreed to this timeline.

CITY ATTORNEY REPORT

City Attorney Horowitz advised on May 10th the City had a hearing related to BSO and the disputed pension funds. The judge has reserved ruling on BSO's motion to dismiss the City's third amended complaint on the accrued liability and they are still awaiting the court's ruling.

Commissioner Shrouder would like to move the matter to the Complex Litigation Division. City Attorney Horowitz will advise council.

POLICE CHIEF'S REPORT

20. Police Chief's Report

Captain De Giovanni advised the last day of school is June 10th. There will be extra patrols at each school to ensure a safe ending of the school year. He and his staff have begun pre-planning for the 2024/2025 school year. He did receive a copy of the executed contract from the School Board of Broward County for the reimbursement to the City for the School Board contract including the amounts for next school year. This year there will be no extended school zone times for summer. The only school with a summer presence is Renaissance Charter. There will be increased enforcement with traffic and aggressive driving ahead of Memorial Day celebrations. Recently the Crime Suppression Team concluded an investigation with our major narcotics unit serving a search warrant on May 7th at the 9400 block of SW 51st Street. The search resulted in the apprehension of a suspect and seizure of a very large amount of narcotics and \$116,646 in illicit funds including a firearm and a vehicle. Rock Creek is actively moving forward with the STARS project. He looks forward to meeting with Embassy Lakes later this week. There will be a Police Explorers Appreciation Dinner at Nova where they will be honored by the Sheriff. They will also be participating in summer delegates. The Police Explorers program is a mentorship program for youths between the ages of 14 and 21. For more information on joining call 954-435-2000. Crafting with a Cop will be held on May 22nd at the District 16 Office and Pizza with Police will be held on May 28th at 4:00 PM at the Sicilian Oven.

Commissioner Katzman thanked Captain De Giovanni for attending a meeting at Embassy Creek Elementary addressing traffic issues. He also thanked Captain De Giovanni for enforcing stopping at stop signs as he sees many individuals not adhering to the stop signs.

Commissioner Mallozzi thanked Captain De Giovanni for his assistance with the schools. She also advised there is a meeting related to MPO and stacking of vehicles and it is essential Captain De Giovanni and our staff attend.

Commission Shrouder said the contract with BSO states "BSO agrees any currency seized within the City through active participation of districts personnel and subsequently forfeited solely to BSO shall be deposited in the city's law enforcement Trust Fund established by the City." Captain De Giovanni said he is on the City's side and using the unit has resulted in two large seizures. Commissioner Shrouder asked if the gates alone can be used for the Griffin Elementary School Traffic scenario. City Manager Eggleston said they need a base for the gates. Commissioner Shrouder would like to test the gates alone.

FIRE CHIEF'S REPORT

21. Fire Chief's Report

Chief Harrington advised last night he presented four graduating seniors with \$2,000 dollar scholarships to pursue a career in Fire Rescue Services. On May 24th at 11:00 AM he along with the CERT Program Manager will be conducting hurricane preparation for seniors at the Community Center. The Teen Council has begun designs on the two fire hydrants outside City Hall and work will be finished by tomorrow.

Commissioner Mallozzi thanked Chief Harrington for his presentation of the scholarships at Cooper City High School.

Mayor Ross welcomed Mr. Rey to the City.
