

CITY COMMISSION ORDINANCE/RESOLUTION

TITLE: Resolution 24-13 – (Finance)

DATE: May 28, 2024

DESCRIPTION: A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF

COOPER CITY, FLORIDA, AMENDING RESOLUTION NO. 20-8-3, ADOPTED ON AUGUST 25, 2020; PROVIDING FOR A RATE INCREASE FOR THE CITY'S MUNICIPAL PARKING FACILITIES; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR

AN EFFECTIVE DATE.

CITY MANAGER RECOMMENDATION:

The City Manager recommends that Resolution 24-13 be approved, amending the renewal period for the City's two municipal parking lots and leasing rates.

BACKGROUND OF ITEM:

The City currently leases two municipal parking lots for recreational vehicles (RVs) and other large vehicles. On August 25, 2020, the City Commission adopted Resolution 20-8-3, which increased parking rates to cover the rising repair and replacement costs due to age and wear and tear. Currently, the City receives approximately \$152,000 per fiscal year for operating both facilities. To enhance administrative efficiency and to mitigate inflationary pressures related to maintenance and repairs, staff recommends that lease agreements be renewed on an annual basis, instead of a semi-annual basis, along with a proposed increase ranging from \$24 to \$37 per year based on the size of the leased lot.

Staff recommends the City Commission approve the recommended rate increase for the lease period beginning October 1, 2024.

ANALYSIS:

Moving from semi-annual to annual renewal will allow for increased administrative efficiency. If the proposed rate increases are approved, it will boost the City's capability to maintain and repair the two parking lots due to regular wear and tear.

STRATEGIC PLAN:

The resolution aims to reduce administrative costs while increasing the City's capacity to handle parking lot maintenance and repairs. This aligns with the City's strategic goal of financially sustaining Someplace Special.

FISCAL IMPACT:

Effective October 1, 2024, RV lease rates will be increasing as follows:
