

CITY COMMISSION ORDINANCE/RESOLUTION

TITLE: Ordinance 22-25 (BSO)

DESCRIPTION: AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING CHAPTER

25, ARTICLE VI OF THE CITY'S CODE OF ORDINANCES, ENTITLED "ROADS AND RIGHTS-OF-WAY" BY SPECIFICALLY AMENDING SECTION 25-87, ENTITLED "PRIVATE STREETS;" PROVIDING FOR THE ENFORCEMENT OF SECTION 25-87 OF THE CITY CODE BY THE CITY'S POLICE CAPTAIN; PROVIDING FOR CONFLICTS;

PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

CITY MANAGER RECOMMENDATION:

The City Manager Recommends approval of Ordinance 22-25 amending Chapter 25, Section 25-87 of the City's Code of Ordinance for the enforcement by the City's Police Captain.

BACKGROUND OF ITEM:

At the March 8, 2022, meeting, the City Commission adopted Ordinance 22-2, establishing a procedure for City vehicles to access gated communities and gated commercial properties. The ordinance stipulated an approved gated emergency access system would be identified by future resolution. Further, the ordinance identified the Fire Marshal as the enforcer for compliance. On a future date, the City Commission approved resolution 22-15 which outlined the approved emergency access system. In addition, the resolution named the Police Captain as the enforcer of the secondary entry code requirement.

ANALYSIS:

The above-mentioned ordinance and resolution went into effect on September 1, 2022. Currently, the Code Enforcement team is overseeing the implementation and compliance effort. The City Staff is recommending we amend Ord. 22-2, which named the Fire Marshal as the enforcer, to reflect the Police Captain. This will bring consistency between practice and policy.
