



## CITY COMMISSION ORDINANCE/RESOLUTION

**TITLE:** Resolution 22-44 (Public Works)

**DESCRIPTION:** A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY APPROVING THE RENEWAL OF THE INTERLOCAL AGREEMENT BETWEEN BROWARD COUNTY AND THE CITY OF COOPER CITY FOR USE OF TEMPORARY DEBRIS MANAGEMENT SITES AND OTHER RELATED SERVICES, ATTACHED HERETO AS EXHIBIT "A" AND INCORPORATED HEREIN; AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE THE AGREEMENT AND TO TAKE ANY AND ALL ACTION NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**CITY MANAGER RECOMMENDATION:**

This City Manager recommends Commission approval of the Interlocal Agreement (ILA) for use of temporary debris management sites and other related services with Broward County.

**BACKGROUND OF ITEM:**

In the event of a regional disaster that generates a large amount of debris, Broward County has designated Temporary Debris Management Sites (TDMS) located throughout the County. These TDMS are locations for the delivery of municipal generated disaster debris. The City entered into an ILA with the County for the use of their TDMS and other related services in May of 2018. The ILA expires on November 30, 2022 unless renewed. Upon written consent of the County and the government agency, the agreement with the same conditions can be renewed for two additional five-year terms.

**ANALYSIS:**

The County will allow government employees and authorized contractors to bring debris to the TDMS. Government entities using the TDMS will reimburse County for all costs and services provided under the agreement. The use of the County TDMS is highly advantageous to the City during the recovery efforts from a natural disaster for debris management as the City has limited capacity to store, process and dispose of disaster-size debris material. The TDMS will process and make final disposal of the municipal generated disaster debris in an expeditious and cost-effective manner for the City should the City be impacted from a regional natural disaster. The renewal of the ILA needs to be noticed to the County by November 15, 2022. The renewal will be for a five-year term set to expire on November 30, 2027.

**STRATEGIC PLAN:**

A debris management plan that establishes procedures and assets for managing disaster debris in a coordinated, environmentally responsible, and cost effective manner better prepares the City to restore public services and ensure the public health, safety and welfare in the aftermath of a disaster.
