## **ORDINANCE NO. 22-19**

AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA AMENDING THE CITY OF COOPER CITY COMPREHENSIVE PLAN BY PROVIDING A TEXT AMENDMENT ADOPTING AND **INCORPORATING** A **PROPERTY RIGHTS** ELEMENT, ATTACHED HERETO AS EXHIBIT "A" AND INCORPORATED HEREIN; PROVIDING FOR TRANSMITTAL OF CERTIFIED COPIES OF THIS ORDINANCE AND TRANSMISSION OF THE PROPERTY RIGHTS ELEMENT TO THE STATE OF FLORIDA DEPARTMENT OF ECONOMIC OPPORTUNITY AND ANY **OTHER** INTERESTED GOVERNMENTAL **ENTITIES**; AUTHORIZING AND DIRECTING THE CITY MANAGER AND ALL APPROPRIATE **MEMBERS OF** THE **CITY** ADMINISTRATION TO TAKE ALL ACTION NECESSARY TO **EFFECTUATE** THE INTENT **OF** THIS **ORDINANCE: PROVIDING FOR SEVERABILITY**; **PROVIDING FOR** CONFLICTS; PROVIDING AN EFFECTIVE DATE.

**WHEREAS,** Sec.163.3167(2), Florida Statutes, requires that each local government prepare a Comprehensive Plan in compliance with the Local Government Comprehensive Planning and Land Development Act, as amended; and

**WHEREAS,** Sec. 163.3184(15), Florida Statutes, requires that the Comprehensive Plan be adopted by the governing body of the local government by Ordinance; and

WHEREAS, 2021-195, Laws of Florida, amended Sec.163.3177, Florida Statutes, to require the inclusion of a Property Rights Element in the City's Comprehensive Plan; and

WHEREAS, at its June 25, 2022, meeting, the City's Planning and Zoning Board, acting as the City's Local Planning Agency, considered the text amendments to the City's Comprehensive Plan adopting and incorporating a Property Rights Element as provided in Exhibit "A," attached hereto and incorporated herein, and voted to recommend approval by the City Commission; and

WHEREAS, the City Commission deems it to be in the best interests of the

citizens and residents of the City to transmit and approve the text amendments adopting

and incorporating a Property Rights Element into the City's Comprehensive Plan as

provided in **Exhibit "A,"** attached hereto and incorporated herein.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION

OF THE CITY OF COOPER CITY, FLORIDA, THAT:

**Section 1.** The foregoing "Whereas" clauses are hereby ratified as true and

correct and incorporated herein by this reference.

**Section 2.** In order to comply with the provisions of Chapter 163, Florida

Statutes, the City Commission hereby adopts and amends the City's Comprehensive Plan

to include a Property Rights Element as provided in Exhibit "A," attached hereto and

incorporated herein, subject to any objections, recommendations and comments report

that may be provided by the Florida Department of Economic Opportunity.

**Section 3.** The City Commission hereby certifies that it has conducted such

public hearings as may be required pursuant to Chapter 163, Florida Statutes, as amended,

in order to adopt the Comprehensive Plan Amendments.

**Section 4.** The City Clerk is directed to transmit a certified copy of this

Ordinance and a Certified Copy of the updated text amendments which includes the

Property Rights Element as provided in Exhibit "A," of the City's Comprehensive Plan

to the Florida Department of Economic Opportunity pursuant to Chapter 163, Florida

Statutes and any other interested governmental entity.

**Section 5.** Upon the return of the text amendments from transmittal review

and upon consideration at the adoption hearing, the City Commission hereby approves

the Property Rights Element as provided in Exhibit "A," of the City's Comprehensive

Plan, subject to any objections, recommendations and comments report that may be

provided by the Florida Department of Economic Opportunity.

**Section 6.** The City Manager and other members of the City Administration

are hereby authorized and directed to take any and all steps necessary to effectuate the

intent of this ordinance.

**Section 7.** If any clause, section or other part of this Ordinance shall be held

by any court of competent jurisdiction to be unconstitutional or invalid, such

unconstitutional or invalid part shall be considered as eliminated and in no way affecting

the validity of the other provisions of this Ordinance.

**Section 8.** All Ordinances or parts of Ordinances, Resolutions or parts of

Resolutions in conflict herewith, be and the same are hereby repealed to the extent of

such conflict.

**Section 9.** This Ordinance shall become effective upon its passage and

adoption.
