# **PLEDGE OF ALLEGIANCE**

Mayor Ross opened the meeting at 6:30 PM and Avery Volan led the assembly in the Pledge of Allegiance.

# **ROLL CALL**

Present were Commissioners Shrouder, Meltzer, Pulcini, Green and Mayor Ross.

## **CHANGES TO AGENDA/EMERGENCY MATTERS**

City Manager Napoli asked to move item 1 the Presentation on Text my Gov to the next Regular Commission Meeting on November 29, 2022.

## 2. Discussion on the Internal Auditor's Hotline Recommendation - Internal Auditor

Eddie Castaneda from MSL presented information on implementing a fraud hotline.

Commissioner Shrouder asked the differences in the two options presented. Mr. Castenda advised the basic providers set up a website and phone number and monitor the information. The fee ranges between \$600 to \$2.000. The higher end providers range from \$2,500 to \$11,000. They would train the employees and develop an ethics policy for reporting.

Commissioner Pulcini asked how the anonymous reporting works with public record requests. City Attorney Horowitz said he would like to do some research to see if a hotline compliant would be exempt however, absence a specific exemption it would be a public record.

Commissioner Shrouder advised typically they do not collect the individual's name who is reporting an issue.

Commissioner Pulcini said remaining anonymous is essential to the program.

Commissioner Shrouder said it was important to him for his fellow outgoing Commissioners to see this plan through.

Commissioner Green asked once the information is collected and given to the agency will they give an assessment of the information to determine fraud based on the city code or statues. Mr. Castenda advised the higher end providers would incorporate the City's policies and procedures. The Commission would direct what department would receive the complaints. Commissioner Green asked if information is reported to the Inspector General's Office. Mr. Castenda said he believes the reports should be handled internally.

Commissioner Pulcini said this hotline can also be used as a HR tool to help employees reach out to voice concerns.

Mayor Ross stated the City has a City Manager and Police Captain who is available to hear concerns. He asked the City Manager how many fraud complaints he has received. City Manager Napoli answered none. Mayor Ross is not in support of spending City funds on this hotline.

Commissioner Meltzer said the hotline's success is dependent upon support from management. City Manager Napoli stated he and staff will support any directive given but he does have concerns of abuse.

Commissioner Shrouder said statically this is how you find out issues are happening. This hotline is the gold standard of transparency.

Mayor Ross asked how many cities have the initiative in Broward County.

Commissioner Green said the difficulty is staff does not have the expertise to examine the information.

Commissioner Pulcini would like to offer a venue where individuals can feel safe to report an issue.

Mr. Castenda said his firm will reach out to the vendors to receive firm quotes to bring forth to the Commission.

**MOTION:** Commissioner Shrouder moved to approve the higher end provider for the fraud hotline up to \$20,000. Commissioner Meltzer seconded the motion which prevailed by the following roll call vote. (3-2)

Commissioner Pulcini pulled items 9 and 10. Commissioner Shrouder pulled items 3, 4 and 8.

**MOTION:** Commissioner Green moved to approve the consent agenda with the exemption of items 9, 10, 3, 8 and 4. Commissioner Meltzer seconded the motion which prevailed by a unanimous roll call vote. (5-0)

**MOTION:** Commissioner Shrouder moved to bring back items 3 and 4 as the verbatim minutes were not completed. Commissioner Green seconded the motion which prevailed by a unanimous roll call vote. (5-0)

# 8. Resolution 22-46 - (Parks and Recreation)

City Attorney Horowitz "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, APPROVING AND AUTHORIZING THE EXECUTION OF THE AGREEMENT BETWEEN THE CITY OF COOPER CITY AND BILL CLARK TENNIS ACADEMY, LLC, FOR THE PROVISION OF PROFESSIONAL TENNIS SERVICES, ATTACHED HERETO AS EXHIBIT "A," AND INCORPORATED HEREIN; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE" by title.

Commissioner Shrouder asked what the current contract is. Recreation Director Stacie Weiss answered we currently pay \$3,600 a month for one year. Commissioner Shrouder asked how much we are saving with the proposed contract. Director Weiss stated the first year it would cost \$32,400 and then move to \$34,200. We can also charge for non-residents if enrollment exceeds 70%. Commissioner Shrouder asked about the non-resident fee. Director Weiss explained if they exceed their capacity, which their primary participants are Cooper City residents, we will now have the ability to charge forty-five dollars per non-resident. Commissioner Shrouder asked why we do not charge a non-resident fee as a standard.

Commissioner Meltzer inquired about the possibility of adjusting prices if enrollment changes after year one. Director Weiss explained in 2024 some of courts will be unusable due to resurfacing.

Commissioner Meltzer replied it does not seem fair to the vendor to limit their capacity when the courts are being resurfaced.

Commissioner Shrouder would rather approve a one year contract and then assess the contract in the future.

Commissioner Pulcini said the vendor is doing a great service in the City and we want to assure the terms are agreeable to the vendor.

**MOTION:** Commissioner Shrouder moved to approve Resolution 22-46 for one year. Commissioner Meltzer seconded the motion which prevailed by a unanimous roll call vote. (5-0)

# 9. Appointment of the Assistant Utilities Director – Utilities

Commissioner Pulcini has concerns with the item being on the consent agenda and asked if the item cost is within the pay plan. City Manager Napoli advised he is requesting to move the position from pay grade 23 to 24. Commissioner Pulcini voiced concern with the Assistant Utilities Director being paid more than some Director's in the City. Also, the employee will have a take home vehicle as a benefit. He believes we should have a standard for all employees and not offer higher pay and benefits to only newly hired individuals.

Commissioner Meltzer asked for an update on the pay study. City Manager Napoli advised it will be brought forth in January or February. Commissioner Meltzer said Commissioner Pulcini's concerns are valid and he understands this position is an important position to get filled. Commissioner Meltzer asked Utilities Director Raj Verma if the individual will fulfill the department's needs.

Utilities Director Raj Verma said under the current market conditions and the city needs this is the best offer available. Other municipalities are paying more for the position and his best professional advice is this is the best money can buy.

Commissioner Shrouder said the Town of Davie has an Assistant Utilities Director listed at \$93,000 to \$145,000. He advised this is a specialist position and we need the expertise with this position. He also advised all Directors are in the FRS Senior Management Plan which is an excellent benefit.

Commissioner Green said he agrees with Commissioner Pulcini and he is hoping the pay study comes in as fast as possible. However, we need the expertise in place to move forward successfully.

Commissioner Pulcini said his issue is with the current employees that are not being paid adequately compared to this position.

Mayor Ross said we cannot compare all employees to this position. This position requires a higher education requirement.

Commissioner Meltzer said they have budgeted for the pay study to adequately address the other employees.

Commissioner Shrouder said if the Commission demands a certain level of professionalism they must be willing to pay for it.

Mayor Ross said the Utilities Director is asking for this item for the betterment of his department. He also asked about the take home vehicle. City Manager Napoli advised take home vehicles are based on functions.

City Manager Napoli advised this was not an easy decision but pay ranges in surrounding cities are higher than ours for this position.

Commissioner Green wants to assure we are compensating our current staff as well.

Commissioner Shrouder asked the City Manager look at the salary of the Assistant Director in Community Development and all Directors if needed so we can stay competitive.

Commissioner Shrouder would like to remove the acknowledgement form on the job description. Also, the date approved by Commission needs to be updated and the exemption status needs listed.

Commissioner Green wants to assure pay scale 24 is available to anyone who may fall into pay scale 24.

**MOTION:** Commissioner Shrouder moved to approve the pay scale listed as Exhibit 3, 9-3. Commissioner Meltzer seconded the motion which prevailed by the following call vote. (4-1)

Commissioner Pulcini wanted to state that piggybacks are exceptions to the code.

City Attorney Horowitz advised the code does use the word exception in the context of competitive bidding. But piggybacking it is one of several opportunities provided for in the code. A piggyback contracting opportunity is a competitive process. It's an exception from the City going through its own competitive solicitation. The nature of that type of contract is utilizing the competitive process of another governmental agency but it is still a competitive procurement.

City Manager Napoli said the City has over 100 contracts and piggyback contracts are a normal process utilized by cities.

Commissioner Shrouder said the contract is only used as needed and we are comparing apples to apples.

# 12. Motion to approve Piggyback award to IGM Technology Corp - Finance

CFO Kendrick advised this solicitation provides for the budget software and which will add additional transparency. This solicitation will also include the ACFR software.

Commissioner Shrouder said the master agreement does not list the prices of the modules we selected.

Commissioner Pulcini said the auditor will compile the ACFR so we may not need that module. He also said we are using ARPA funds and this will be a recurring amount. CFO Kendrick advised they will budget the software after the ARPA funds are finished. He also advised staff will be involved in the ACFR information so they would utilize that module.

Commissioner Shrouder said he cannot locate the modules in the master agreement. CFO Kendrick advised Miami Dade utilized this contract as well.

City Manager Napoli advised we will bring back the agreement to address the all the prices listed.

Commissioner Green asked if this item can wait until November 29, 2022. CFO Kendrick answered yes.

Commissioner Shrouder asked that the prices for the modules we selected be highlighted to be easily identified.

**MOTION:** Commissioner Green moved to table Piggyback award to IGM Technology Corp to the November 29, 2022 meeting. Commissioner Shrouder seconded the motion which prevailed by a unanimous roll call vote. (5-0)

#### 13. Motion to Approve External Audit Services (RFP- 2022-6-FIN) – Finance

Commissioner Shrouder asked if there is a benefit of continuity with keeping the firm we have currently.

Commissioner Pulcini said our current auditor is familiar with the City and they have developed efficiencies.

City Attorney Horowitz advised the procurement of an independent auditor is a very specifically regulated process by Chapter 218 of the Florida Statues. The city can use compensation as a factor as part of its evaluation criteria. The statute contemplates both the use of compensation and the consideration of a proposal without compensation. If compensation is one of the factors established to be used in evaluating the City Commission is required to do one of two things either select the highest ranked, qualified firm or state and document in its public records on the record this evening the reason for not selecting the highest rank firm.

Commissioner Shrouder advised the residents voted to have continuity with regard to the city's auditor.

Mayor Ross said being familiar with the City is key.

Commissioner Green said staff completed the entire process of a RFP and now we are choosing the firm we have now.

Commissioner Meltzer said Commissioner Shrouder who served on the evaluation committee ranked the firm of Keefe McCullough higher than our current auditor.

Commissioner Shrouder's only concern is that the audit is completed by March.

**MOTION:** Commissioner Meltzer moved to approve External Audit Services (RFP- 2022-6-FIN). Commissioner Shrouder seconded the motion which prevailed by a unanimous roll call vote. (5-0)

Bill Benson spoke on behalf of Keefe McCullough and thanked the Commission for the opportunity.

## 14. Discussion on Record Retention – Commissioner Shrouder

Commissioner Shrouder would like a record retention policy that states who and where city records are held.

City Manager Napoli advised we are moving to a new record retention software and staff will also write a policy.

## 15. Ordinance 22-25 (BSO)

City Attorney Horowitz read "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING CHAPTER 25, ARTICLE VI OF THE CITY'S CODE OF ORDINANCES, ENTITLED "ROADS AND RIGHTS-OF-WAY" BY SPECIFICALLY AMENDING SECTION 25-87, ENTITLED "PRIVATE STREETS;" PROVIDING FOR THE ENFORCEMENT OF SECTION 25-87 OF THE CITY CODE BY THE CITY'S POLICE CHIEF; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE" by title.

**MOTION:** Commissioner Shrouder moved to approve Ordinance 22-25 with the replacement of the term Police Captain with Police Chief. Commissioner Meltzer seconded the motion which prevailed by a unanimous roll call vote. (5-0)

#### 16. Ordinance 22-26 (Finance)

City Attorney Horowitz read "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING ORDINANCE NO. 21-24, ADOPTED ON SEPTEMBER 23, 2021, AS AMENDED; PROVIDING FOR AN AMENDED BUDGET FOR FISCAL YEAR 2021-2022 FOR THE CITY, ATTACHED HERETO AS EXHIBIT "A" AND INCORPORATED HEREIN; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE" by title.

Commissioner Pulcini said there is no Exhibit A listing the funding source. CFO Kendrick advised the rollovers is the Exhibit A. Commissioner Pulcini said if we change the 2021/2022 budget and the auditor finds expenses we would have moved funding away. Commissioner Pulcini does not believe we should be amending the 2021/2022 budget.

Commissioner Green said CFO Kendrick advised previously we would need to amend the 2021/2022 budget due to rollovers.

Commissioner Shrouder said there are expenses listed with no funding source in the backup. Commissioner Shrouder said the entire budget needs attached when staff is proposing a budget amendment.

CFO Kendrick has no concern with not bringing forth the amendment. Commissioner Shrouder said the entire budget needs attached.

Commissioner Meltzer said the amended budget needs presented noting the funding source.

Commissioner Green clarified if what the Commission is asking is that the numbers be placed in the 2022/2023 budget.

City Manager Napoli advised this item was generated from the Ordinance on rollovers. He advised we do not need to amend the 2021/2022 budget. He advised they will create an amended column and fill in the rollovers.

CFO Kendrick advised he will create an amended column and fill in the rollovers.

**MOTION:** Commissioner Shrouder moved to approve Ordinance 22-26. Commissioner Meltzer seconded the motion which failed by the following roll call vote. (4-1)

City Manager Napoli advised be have \$350,000 in contingency for public safety and Captain De Giovanni came up with a recommendation for the monies. He is asking for a consensus for a MOU for billing.

Consensus was reached to proceed with the MOU for billing.

Commissioner Shrouder asked about purchasing vehicles. City Manager Napoli advised we purchase of the Sheriffs contract and vehicles are very limited and we may have to look at buying from lots.

Commissioner Shrouder is okay with purchasing a vehicle from a lot.

Commissioner Green said if the procurement is legal and lawful he has no issue.

**MOTION:** Commissioner Shrouder moved to authorize the City Manager to buy vehicles that are budgeted from a manufacture dealer if it exceeds the budget amount it is below his authorized limits. Commissioner Green seconded the motion which prevailed by a unanimous roll call vote. (5-0)

City Manager Napoli advised certification of the 2022 election may be received late on Friday and they are leaning towards a Thursday November 23, 2022 Swearing In Ceremony at 6:30 PM in the Chambers of City Hall.

Captain De Giovanni advised there has been a CSA assigned to the district. Commissioner Shrouder asked about proactive patrols for the holidays. Captain De Giovanni advised his team is preparing two active operation plans that he will present on his November 29, 2022 report.

Commissioner Shrouder advised BSO gave a fulltime position to look into real estate fraud after a meeting he had with the Property Appraisers Office and BSO. He thanked BSO.

Captain De Giovanni advised the Santa Letter initiative will return for Cooper City resident children.. He also thanked Commissioner Pulcini and Meltzer for the productive relationship the past two years.

Commissioner Pulcini thanked Captain De Giovanni and District 16.

Commissioner Meltzer also thanked Captain De Giovanni.

#### **FIRE CHIEF'S REPORT**

# 22. Fire Chief's Report

Chief Harrington advised District 28 has reached out to several thousands of students for Fire Prevention Month. Chief Harrington also looked into call volumes the last six months and has cited a rise in calls. He also advised signage on the platform will be done in approximately four weeks. The hydrant flush system work is ongoing and there were two Cooper City CERT members deployed to the West Coast to aid in hurricane relief. The Santa Program will be advertised shortly and registration will be held on November 29, 2022 at 9:00 AM at the Fire Station.

Commissioner Pulcini thanked Chief Harrington and all staff at District 28.

Chief Harrington thanked both Commissioners Meltzer and Pulcini for their support.

Mayor Ross asked that a program installing smoke alarms be looked into for next year's Fire Prevention Month initiative.

Commissioner Green thanked Commissioner's Pulcini and Meltzer for their service and dedication to the City the last four years. Commissioner Green also asked that the City look into anything we have available to let the staff know we appreciate them.
