

CITY COMMISSION ORDINANCE/RESOLUTION

TITLE: Resolution 25-34 (Utilities)

- DATE: June 10, 2025
- **DESCRIPTION:** A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, APPROVING AND AUTHORIZING THE EXECUTION OF WATER AGREEMENT WITH ERICA RUBLE-LUCENA AND BRYAN LUCENA FOR TWO AND ONE HALF (2.5) WATER ERCS AT A TOTAL COST OF \$12,370.87 ATTACHED HERETO AS EXHIBIT "A" AND INCORPORATED HEREIN; AUTHORIZING AND DIRECTING THE APPROPRIATE CITY OFFICIALS TO TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

CITY MANAGER RECOMMENDATION:

The City Manager recommends approval of the Water Agreement for two and one-half (2.5) Equivalent Residential Connections (ERCs) with Erica Ruble-Lucena and Bryan Lucena, for their property located at 13201 Luray Road, Southwest Ranches, FL.

BACKGROUND OF ITEM:

Erica and Bryan at 13201 Luray Road, in the Town of Southwest Ranches, are requesting water connection for a total of two and one-half (2.5) ERCs. Erica & Bryan Lucena shall be responsible for all costs of construction and connections. The Town of Southwest Ranches, through the passage of its Resolution No. 2025-013, has granted this approval.

ANALYSIS:

The City is the owner of the Utility system on Luray Road and provides water distribution services. The system has sufficient capacity to support this request.
