RESOLUTION NO. 25-37

A RESOUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, AUTHORIZING THE CITY COMMISSION TO APPROVE AND AUTHORIZE THE CITY MANAGER TO ENTER INTO A FACILITY USE AGREEMENT WITH THE OPTIMIST CLUB OF COOPER CITY; PROVIDING FOR CONFLICTS; FURTHER, PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, The City owns, operates and maintains specific athletic fields and buildings within the City intended for recreational purposes. The Optimist Club of Cooper City started in 1982 in partnership with the City of Cooper City. The relationship with the City and the Optimist Club of Cooper City was updated and codified by Resolution No. 12-7-5, dated July 30, 2012, as amended. The Parties now desire to enter into a written agreement providing for the Optimist Club of Cooper City use of certain athletic fields and buildings for recreational purposes consistent with the terms and conditions set forth herein.; and

WHEREAS, The City and the members of the Optimist Club board had several meetings to identify the items that would be integrated into the Facility Use Agreement. When consensus was not accomplished in those meetings, a commission workshop was held on May 15, 2025 at 5:30pm.; and

WHEREAS, the items discussed at the workshop were in sections 4.1, 4.11, 4.21 and section 6.15 and the results of that discussion are incorporated in the Facility Use Agreement in the sections identified. This agreement is solely intended to authorize the use of the City facilities by the Optimist Club of Cooper City. Any other organizations affiliated with the Club or any of its members shall require a separate agreement with the City in order to utilize City facilities. and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA:

- Section 1.: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct, and they are made a specific part of and incorporated into this Resolution by this reference.
- Section 2.: That the City Commission approves and authorize the City Manager or his designee to enter into a Facility Use Agreement with The Optimist Club of Cooper City found in Exhibit "A".
- <u>Section 3. Conflicts.</u>: That all resolutions or parts of resolutions in conflict with this Resolution are repealed to the extent of such conflict.

<u>Section 4.: Severability</u>: That this Resolution shall be in full force and take effect immediately upon its passage and adoption.

<u>Section 5.: Effective Date.:</u> This Resolution shall become effective upon its passage and adoption by the City Commission.
