

To Whom It May Concern:

I am writing to provide a comprehensive summary of our completed swale repair work and to request the release of our bond for the above-referenced project.

We worked closely with both the Ranchette Isle HOA and the Marin Ranches HOA to develop an effective remediation plan. Representatives from both HOAs participated in our meetings with the City and Central Broward Water Control District, demonstrating the collaborative nature of this project. Both HOAs formally approved our proposed solutions prior to implementation.

The swale and drainage system repairs have been completed according to the Swale Repair Plan dated February 9, 2024. This work has been certified by Winningham & Fradley Engineers in their letter dated November 20, 2024, confirming that the construction was completed in substantial conformance with the approved Plan. Their As-Built documentation dated October 23, 2024, provides detailed verification of the completed work.

Significantly, despite experiencing extremely heavy rainfall over the past six to nine months, we have not received any complaints regarding the drainage system's performance. This demonstrates the effectiveness of the implemented solutions and validates the engineering design.
