SUBJECT: Motion to approve an agreement with The Butler Group of South Florida, LLC

D/B/A Nextaff for crossing guard services. – **Parks and Recreation**

CITY MANAGER RECOMMENDATION:

The City Manager recommends approval of the agreement with The Butler Group of South Florida, LLC D/B/A Nextaff for crossing guard services.

BACKGROUND OF ITEM:

The City contracts crossing guard services for five public schools in the City. The schools in which the Crossing Guard services are provided are: Cooper City Elementary, Embassy Creek Elementary, Griffin Elementary, Pioneer Middle School and Cooper City High School. There is a total of 20 posts within the City. If approved, the contractual company, Nextaff, is prepared to be in operations for the first day of school. (August 16, 2022)

ANALYSIS:

In 2019, the City of Miramar issued a bid (IFB 1-014) and awarded the contract to The Butler Group of South Florida, LLC D/B/A Nextaff. Since this time, Nextaff has been the contractor that provides the Crossing Guards services for the City of Miramar. The City is expected to bring forth their renewal option in January 2023. If awarded, the agreement will take effect upon execution and expire on January 14, 2023.

STRATEGIC PLAN:

Having the ability for students to walk or bike to school helps create a Strong Sense of Place, which is identified with the third priority. Working with the schools helps foster community pride and increases social interactions.

FISCAL IMPACT:

Funds are currently budgeted in the Contractual Services – Crossing Guards GL line item. With the increase in the Florida Minimum wage and other factors, the hourly rate will be \$21.07 per hour/employee.
