Resolution 22-27 (Utilities) TITLE:

DESCRIPTION: A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, APPROVING AND AUTHORIZING THE EXECUTION OF WATER AND SEWER DEVELOPER'S AGREEMENT FOR WATER SERVICE WITH STEPHANIE & AARON BRITO, 4901 SW 114 WAY, DAVIE, FLORIDA, FOR 1 ERC. ATTACHED HERETO AS EXHIBIT "A" AND INCORPORATED HEREIN; AUTHORIZING AND DIRECTING THE APPROPRIATE CITY OFFICIALS TO TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

CITY MANAGER RECOMMENDATION: The City Manager recommends owners, of Water & Sewer Developer's Agreement for water service with Stephanie & Aaron Brito, 4901 SW 114 Way, Davie, FL 33330 for one (1) 5/8" meter. There is no sewer service being provided to this property. The property is located in the Town of Davie and will be subject to 25% surcharge.

BACKGROUND OF ITEM: The owners are currently on well water, which is causing them operational issues. As a result, they have requested that the City provide them with water service. Their adjacent property owners are on City's water system and within service area.

ANALYSIS: City is the owner of the utility system and provides water distribution services. The system has sufficient capacity to support the project.

FISCAL IMPACT/COST BREAKDOWN: The owners have requested that the City extend its service line for additional payment of construction cost as required by the City code. The total cost for the owners are estimated at \$5,344.86 with the following breakdown:
