MINUTES

PLEDGE OF ALLEGIANCE

Mayor Ross opened the meeting at 1:00 PM and led the assembly in the Pledge of Allegiance.

ROLL CALL

Present were Commissioners Mallozzi, Katzman, Shrouder, Green and Mayor Ross.

PUBLIC COMMENTS (4 MINUTES)

None.

TOPIC FOR DISCUSSION - City Manager Candidates

- 1. Discussion and possible action to Select a New City Manager
- 2. Ryan T. Eggleston

Mr. Eggleston thanked the Commission for the opportunity to meet the staff and visit the City. He advised he is originally from Titusville Pennsylvania, attended Syracuse University and then returned to Erie, PA. He has 16 years' experience as a City Manager. He prides himself on four core values customer service, collaboration, communication and fiscal responsibility. He has been married for 15 years and has five children. In his spare time he enjoys the outdoors and traveling. He is family focused and looking for a special fit with a City that focuses on education and safety.

Commissioner Green asked Mr. Eggleston what things he believes he can improve within the City. Mr. Eggleston said he has studied the CAFR, budget and strategic plan. He would spend time meeting staff, residents and business owners to build relationships.

Commissioner Katzman asked how he can help alleviate concerns with regard to him being an out-of-state candidate. Mr. Eggleston answered fit is important, he feels confident he would be a great City Manager in Cooper City as he is a great leader that can build great relationships. He has reached out to colleagues in the state to gain knowledge of Florida government.

Commissioner Mallozzi asked Mr. Eggleston to speak on concerns with regard to him being an out-of-state candidate and the stigma of moving to Florida for retirement reasons. Mr. Eggleston said he has a lot of work life left in his career. He wants to find a community that offers a good fit for him professionally and personally.

Mayor Ross asked about the learning curve with him being from out-of-state. Mr. Eggleston said learning is a lifelong process and he is a credentialed manager through ICMA. Mayor Ross asked about building relationships as opposed to other in-state candidates that already have those relationships established. Mr. Eggleston said he would look to City staff some who have many years' experience in the City. He also would like to extend relationships to members of County and State agencies.

Mr. Eggleston thanked the Commission for his time in the City the past two days.

Mayor Ross asked Mr. Eggleston his date of availability. Mr. Eggleston said he would like to give his current employer enough time for a smooth transition so either late May or June 1, 2023.

3. Arthur "A.J." J. Krieger

Mr. Krieger thanked Mr. Napoli, staff and the community. He stated the City has an impressive organization and community.

Commissioner Green asked Mr. Krieger what things he believes he can improve within the City. Mr. Krieger said there is some work to do in restoring and invigorating City staff. He would also work on catching up on some deferred maintenance.

Commissioner Katzman asked how he can help alleviate concerns with regard to him being an out-of-state candidate. Mr. Krieger answered the mechanism of good financial management knows no boundaries. Mr. Krieger said maintained parks and roads and small time feelings can translate to any state or community.

Commissioner Mallozzi asked Mr. Krieger to speak on concerns with regard to him being an out-of-state candidate and the idea that some individuals come to Florida for retirement reasons. Mr. Krieger said retirement is not on his mind. He advised this is a community he would love to be a part of.

Mayor Ross asked his availability if he is selected. He advised his current employment agreement requires 30 days' notice and he has personal family milestones approaching so he would estimate after Memorial Day.

4. Alejandro "Alex" I. Rey

Mr. Rey advised currently he is the City Manager of St. Pete Beach and has been in the public service sector for 40 years, the last 20 years as a City Manager. He is also by trade an Industrial Engineer.

Commissioner Green apologized for not being able to meet with Mr. Rey. He asked Mr. Rey what things he believes he can improve within the City. Mr. Rey said he would like to build a relationship with the Commission and he would like to address the issue of staff turnover. He would also look into available grants the City can apply for.

Commissioner Shrouder asked Mr. Rey if his availability for a start date and how he would bridge the gap starting as a new Manager within the City. Mr. Rey advised he would need to give his current employer notice and he also has a trip planned for Mya 15th. He stated he would listen to the Commission's needs and concerns and start building relationships with staff. Commissioner Shrouder asked if he has resources that could help with the vacant CFO position. Mr. Rey responded he has colleagues in the area with financial experience. Commissioner Shrouder asked how he would compare his current or former City to Cooper City. Mr. Rey said his previous City is a small tourist beach town community. A more comparable City would be the Town of Miami Lakes as it is more of bedroom community. Commissioner Shrouder said the City is practically built out and asked how he would look to enhance revenues. Mr. Rey answered he would find ways to balance revenues and expenditures. Commissioner Shrouder asked Mr. Rey to speak on his financial experience. Mr. Rey answered he started his financial experience in Miami. He started as a Proactivity and Efficiency Engineer eventually becoming the Assistant Director of Budget. Commissioner Shrouder asked if he has ever been terminated from a job. Mr. Rey answered no.

Commissioner Katzman asked Mr. Rey what tenure he is looking for as a City Manager. Mr. Rey answered he is looking to work for several more years. Commissioner Katzman asked Mr. Rey to speak on staff development. Mr. Rey said he encourages staff development and cross training.

Commissioner Shrouder asked Mr. Rey how he created avenues of opportunity for professional growth without losing employees. Mr. Rey answered cross training is essential and it allows staff to see how other departments handle issues from start to finish.

Commissioner Mallozzi asked about recreation in his previous positions. Mr. Rey spoke on park size and open space available to the public.

Mayor Ross asked Mr. Rey if he is a member of the ICMA. Mr. Rey is a member of the Miami Dade City Manager's Association. Mayor Ross asked if he has held any leadership positions in a membership group. Mr. Rey answered no.

5. Roberto "Rob" Hernandez

Mr. Hernandez thanked the Commission for the opportunity. Most recently he served as the City Manager in Cape Coral and prior to that the City Manager of Savannah, Georgia. He also has experience in Broward County government, Coral Springs and the City of Fort Lauderdale.

Commissioner Green apologized for not being able to meet with Mr. Hernandez this morning and asked him what he would do to move the City forward. Mr. Hernandez would address staff vacancies and the needs of the residents.

Commissioner Shrouder asked his availability for a start date. Mr. Hernandez answered the middle of May.

Commissioner Mallozzi asked Mr. Hernandez how he deals with people that have a hard time comprehending right from wrong. Mr. Hernandez answered we need to understand communication and education. He also said it is his job to inform individuals the right and ethical way. Commissioner Mallozzi asked Mr. Rey what people would say about him behind his back. Mr. Rey said a nickname he has been given is "Robo Rob" as he is always on the go.

Mayor Ross asked Mr. Hernandez his availability for a start date. Mr. Hernandez answered mid-May. Mayor Ross asked if he is a member of the FCCMA. Mr. Hernandez answered yes, he is also an ICMA credential manager. Mayor Ross asked Mr. Hernandez how he would increase revenue or decrease costs knowing we have a 5% increase in our public safety contract. Mr. Hernandez answered long-term redevelopment of commercial properties can become economically feasible. He also spoke on property tax exemptions that can be provided or possible tax rebate programs.

Mr. Hernandez thanked the Commission, staff and Mr. Napoli.

6. Christopher "Chris" J. Russo

Mr. Russo thanked the Commission for the opportunity. He advised he is originally from New York, he came to Florida and was appointed the City Manager of Sunny Isles Beach from 2000 to 2005. He then did some consulting was the Town Administrator of SW Ranches. In 2012 he returned to his position in Sunny Isles Beach for nine plus years.

Commissioner Green apologized for not being able to meet with Mr. Russo this morning and he asked what are some important decisions he would have to make in order to move the City forward. Mr. Russo said he would focus on storm water and the Stirling Road drainage project. He would also like to look at

redevelopment of older facilities. Commissioner4 Green asked about his resume stating he worked in Sunny Isles Beach from 2005 to 2012 but also the Village of Portchester 2008 to 2012. Mr. Russo said when he went to New York the Mayor offered him a position that he took for four years

Commissioner Shrouder asked Mr. Russo his start date if he was selected. Mr. Russo said he has a small trip in June but is available soon.

Commissioner Katzman asked him to elaborate on soon. Mr. Russo answered he is available tomorrow.

Mayor Ross asked Mr. Russo how he would handle not having a CFO. Mr. Russo answered he does know a number of individuals that have financial experience in the area. Mr. Russo said he is very impressed with the area and would enjoy working in this City.

Mayor Ross reminded the Commission of Sunshine regulations.

The Commission took a brief recess.

Mayor Ross asked the Commission to indicate their top two selections for City Manager.

The votes were as follows:

Commissioner Shrouder - Alex Rey

Commissioner Katzman - Ryan Eggleston and Alex Rey

Commissioner Green - AJ Krieger and Ryan Eggleston

Commissioner Mallozzi - Ryan Eggleston and AJ Krieger

Mayor Ross - Ryan Eggleston and Rob Hernandez

Commissioner Green said Mr. Krieger was not one of his selections originally but he believes Mr. Eggleston and Mr. Krieger responded more than adequately to all his questions. He was very impressed with Mr. Eggleston approaching the dais to shake everyone's hand and Mr. Eggleston watching every Commission meeting in its entirety the past year. Mr. Krieger also advised he watched several of the past few Commission Meetings.

Commissioner Shrouder said all five candidates are phenomenal. He looked at what two candidates would fit well within the City. Mr. Eggleston was very prepared, young vibrant and exciting. Mr. Rey is more analytical and quieter. He said he can look at Mr. Eggleston and it could be a great fit for the next 25 years or it might not work out. But he believes it will be a homerun. Mr. Rey has amazing notes and references especially the reference from the City Attorney of St. Pete Beach stating he worked on an entire code update. All of the references also spoke on his financial background and he also encourages employee development. Commissioner Shrouder said we have great staff and we need to work on professional development in the City. Commissioner Shrouder said Mr. Rey references speaking on his great choices for positions within the City. He stated all five candidates are great but he looked at which candidate could help specifically with issues we have in our City. He stated the only downside with Mr. Rey is how long he is looking to stay with a City. He said for him the science points to Mr. Rey but the appeal and personality moves him toward Mr. Eggleston.

Commissioner Katzman said for him Mr. Eggleston was number one and Mr. Rey was number two along with Mr. Krieger. He stated all five candidates were very well selected and he thanked the Colin Baenziger firm for their work. He would agree with a lot of things Commissioner Shrouder stated. Mr. Rey is a safe bet as he has experience and strong experience with budgets. He asked many colleagues in the area and

all of them spoke very highly of Mr. Rey. However, he does not want to have a situation where someone may resign early starting this process again. Mr. Eggleston has a lot of the experience the Commission is looking for just not that many years of experience in total. He has collective bargaining experience and he has refinanced debt. Commissioner Katzman said he loved the idea that Mr. Eggleston wanted to be a resident of the City and would have children in different grade levels of schools across the City. He also stated Mr. Eggleston has a lot of experience in Parks and Recreations including launching a dog park in 90 days.

Commissioner Mallozzi thanked the Colin Baenziger firm for their work. She also thanked staff for the reception and hard work. She stated all the candidates were phenomenal. She said Alex Rey was her third choice and she spoke to many colleagues that had mixed reviews. She also did not feel he had a strong background in Public Works and that is something our City needs. She said Mr. Krieger and Mr. Eggleston were her top two choices. She said Mr. Krieger has a head on approach to his style of management. Mr. Eggleston is one of the best choices due to his experience with revitalizing areas especially in parks and recreation. His personality also seems like it will be a great fit for employees to help encourage and boost moral. She also said it was a great dedication he showed with watching one year of Commission meetings. She also appreciated Mr. Eggleston helping the employees clean up after the reception last night. That shows he has no issue doing every aspect of City work.

Mayor Ross thanked the Colin Baenziger firm for their work. He also thanked staff for the reception and hard work that showed tremendously. He said while he stands by wanting a candidates from inside the state of Florida he said all of the candidates are highly qualified. He believes Mr. Hernandez was the best fit because of his experience in Broward County. He also stated Mr. Eggleston was prepared and energetic. He believes Mr. Eggleston is best for the City. Mayor Ross also suggested they look at a second selection as negotiations need to be made by the City Attorney. He also reminded the Commission that there will be a vacancy starting April 14, 2023 so they need to discuss options.

Commissioner Shrouder said he is most excited to work with Mr. Eggleston and most excited to learn from Mr. Rey. His only fear with Mr. Eggleston is one would get excited in speaking with him due to his personality but Mr. Rey is the safe bet.

Commissioner Green echoed what Commissioner Katzman said about wanting to have a committed long term manager. He believes Mr. Eggleston would be a slam dunk and Mr. Krieger would be a great second choice.

Commissioner Katzman said Mr. Eggleston quoted the Athenian Oath which is important to him. He also has experience with hurricanes.

Commissioner Green moved to accept Ryan Eggleston as the top candidate.

MOTION: Commissioner Green moved to have the City Attorney start negotiating the contract with Ryan Eggleston. Commissioner Katzman seconded the motion which prevailed by a unanimous roll call vote (5-0)

City Attorney Horowitz will negotiate contract terms with Mr. Eggleston and bring back a contract to the April 11, 2023 Regular Commission Meeting for Commission approval.

Mayor Ross asked for a motion for a number two candidate.

Commissioner Mallozzi made a motion for Mr. Krieger. Commissioner Green seconded the motion.

Commissioner Shrouder finds it highly unlikely the City will not be able to work out a contract with Mr. Eggleston.

Commissioner Mallozzi agreed and pulled the motion.

Commissioner Katzman asked what the negotiation process is.

City Attorney Horowitz stated he would take the current City Manager's contract has as a starting premise and seek a proposal from Mr. Eggleston as to what he is expecting and looking for. Then he would take any input from this Commission to the extent that it was provided. If there was conflicting input he would work to reconcile any of those issues. A contract would then be brought back for approval to the April 11, 2023 Commission meeting.

Commissioner Mallozzi asked if there is any way we can ask him to move up his timeline with regard to a starting date.

Commissioner Green would love to have City Manager Napoli stay for an extra month. Commissioner Green also said all 5 candidates noted City Manager Mr. Napoli's professionalism and hard work. He personally thanked Mr. Napoli for dedication and managing this process in such a professional manner. He stated it would be a smoother transition if City Manager Napoli would want to stay on.

Commissioner Shrouder does not believe it is fair to ask City Manager Napoli to stay as they agreed on a date. He believes a Director can take on the role of acting during the transition and City Manager Napoli can remain available.

Mayor Ross said the entire interviewing process was handled professionally and all of the candidates complimented City Manager Napoli and staff. He stated there has been two times this Commission has placed him in a terrible situation. One was when we received an award from the Area Agency on Aging of Broward County and did not tender a donation. The second is today. He said they have not earned the right to ask City Manager Napoli to stay on but he will ask him.

City Manager Napoli thanked staff for their extraordinary work. He appreciates the need for continuity but there was a timeline established. He is committed to making sure he is available to help with the transition and he will start conversing with Mr. Eggleston immediately. He will work out a plan to assist in a smooth transition. He also advised the new City Manager should recommend the new CFO and resumes have been coming into the City. He advised Mr. Buffington who did the procurement assessment is available to assist and has experience as the former Finance Director of Fort Lauderdale. Finishing the audit and moving the budget process forward is key in the transition process.

Commissioner Shrouder asked Mr. Napoli to help designate an Acting City Manager. He sees the transition as a sort of overlapping in having someone available.

Commissioner Shrouder would like to address certain points with regard to the new City Manager's contract. He broke it into sections, severance, salary, raise performance and vehicle. For raises and performances he would like them to remain separate from staff. He would also like to define a better performance process. He wants to strengthen the language for termination with regard to conviction of a crime or bringing bad light or controversy to the City. He is also not in favor of a vehicle allowance. He would rather issue a city vehicle.

Commissioner Green disagrees with removing the vehicle allowance as most Cities have a vehicle allowance benefit.

Commissioner Shrouder clarified he would rather designate a City vehicle to the City Manager and then the City is still owning an asset.

Commissioner Green wants language that after a three year or five year mark through an evaluation process if the City Manager is meeting objectives they can be compensated additionally as such.

Commissioner Shrouder said Commissioner Green comments were fair. He would also like to have a clause stating 120 days' notice is required for notice.

Commissioner Mallozzi believes 120 days is unreasonable.

Commissioner Katzman suggested 90 days' notice at the least.

Mayor Ross said City Attorney Horowitz is negotiating the contract on the City's behalf and he can determine the numbers.

Commissioner Shrouder said they need to provide boundaries.

Commissioner Katzman said giving City Attorney Horowitz their consensus on their needs is a good idea. He would also like to consider the clauses that were considered in Mr. Napoli's contract with regard to applying at other entities.

Commissioner Mallozzi believes 90 to 120 days is unreasonable. She believes 60 days is fair and reasonable.

Mayor Ross said the City Attorney and Mr. Eggleston can speak on terms on behalf of the City.

Commissioner Shrouder would like to offer a tiered severance.

Commissioner Katzman asked Ms. Klein from Colin Baenziger if there is anything else she needs from the Commission. Ms. Klein stated the delegation of who will be negotiating the contract. The Commission designated City Attorney Horowitz.

Commissioner Shrouder asked for a recommendation for an acting City Manager by the April 11, 2023 Commission meeting.

Mayor Ross stated he would have liked to have the candidates available to the Commission after the meeting was finished.
