DEPARTMENT: Public Works

SUBJECT: Motion to approve the purchase of new/replacement playground amenities for the Bill Lips Sports Complex from Playcore Wisconsin, Inc. d/b/a GameTime in the amount of \$49,978. – **Public Works**

CITY MANAGER RECOMMENDATION:

The City Manager recommends Commission approval for the purchase of new/replacement playground improvements for Bill Lips Sports Complex.

BACKGROUND:

Playground amenities at City parks are recommended to be replaced every 10 years. The playground at Bill Lips Sports Complex was scheduled to be replaced in 2021. The Public Works department applied for a Florida Recreation Development Assistance Program (FRDAP) grant in the amount of \$50,000 for the purchase of new/replacement playground amenities and landscaping at the Bill Lips Sports Complex Park/Playground. The FRDAP Grant was approved this year (FRDAP Grant Project #A22027) and is a 100 % no match award through the Florida Department of Environmental Protection.

ANALYSIS:

The playground amenity is available from GameTime utilizing Omnia Partners - US Communities Contract # 2017001134. The City has used GameTime, a reputable and qualified playground equipment supplier and installer, for over twenty years. The City has used GameTime as its playground amenities supplier and installer since 2004. GameTime will be responsible to acquire all necessary permits for the installation.

STRATEGIC PLAN:

Upgrading playground spaces provides a safe environment for children to enjoy themselves, burn energy, gain confidence, learn new skills and to interact with other children.

FISCAL IMPACT:

City Commission approved \$50,000 in this year's capital budget for the replacement of the playground amenity at the Bill Lips Sports Complex. Grant funds will be reimbursed in the amount of \$49,978 after the project is completed.
