



CITY COMMISSION ORDINANCE/RESOLUTION

TITLE: Resolution 22-37 (Public Works)

DESCRIPTION: A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, AUTHORIZING SUBMISSION OF THE CYCLE 7 COMPLETE STREETS AND OTHER LOCALIZED INITIATIVES PROGRAM (CSLIP) APPLICATION TO THE BROWARD METROPOLITAN PLANNING ORGANIZATION (MPO) FOR THE SW 90TH AVENUE SAFETY AND MOBILITY IMPROVEMENTS PROJECT (THE "PROJECT"); SUPPORTING THE PROJECT AS A LOCAL AGENCY PROGRAM PROJECT; COMMITTING TO FUNDING THE CONSTRUCTION CONTINGENCY AND UPFRONT COSTS FOR DESIGN, CONSTRUCTION, AND CONSTRUCTION ENGINEERING AND INSPECTION SERVICES FOR THE PROJECT, SUBJECT TO REIMBURSEMENT UNDER THE LOCAL AGENCY PROGRAM; PROVIDING FOR IMPLEMENTATION AND AN EFFECTIVE DATE.

CITY MANAGER RECOMMENDATION:

This City Manager recommends Commission authorization for the submittal of the Cycle 7 CSLIP application, support and commitment of funds for the SW 90th Avenue safety and mobility improvements project.

BACKGROUND OF ITEM:

The Broward Metropolitan Planning Organization ("MPO") Complete Streets and other Localized Initiatives Program ("CSLIP") provides funding for local transportation projects that improve the safety and mobility of all transportation users in Broward County. The grant program funds initiatives such as: complete street projects, traffic calming, and intersection improvements, ADA upgrades, mobility hubs, bus shelters, bike racks, and technology advancements, such as transit signal priority and traffic control devices. The CSLIP process is highly competitive and applications are ranked in a priority order. Grants are awarded to the top ranked applications until the funds run out.

The project grant application cap is \$3 million for construction only. The delivery of the project will be through the Local Agency Program process and will require the City to provide the upfront costs for design, construction engineering and inspection services, and will be reimbursed in accordance with the LAP agreement. Any costs that exceed the construction cap or are not program eligible will be the responsibility of the City. All improvements are proposed within City rights-of-way and all improvements will be maintained by the City after the Project's completion. The application requires a supporting resolution from the City Commission.

ANALYSIS:

The MPO is currently taking applications for Cycle 7 of the CSLIP program. The application deadline is October 6, 2022. If the City's project is approved funding will become available in FY 2028 (unless federal funds are available to accelerate projects in prior years).

The City met with the MPO staff to review several potential projects for the City. Based on the MPO's priority scoring criteria, the most promising project location and limits are on SW 90th Avenue from Stirling Road to Griffin Road. The effort proposed for the improvement project include multimodal, safety, and traffic calming upgrades which will improve the quality of life for Cooper City residents. This includes shared use path on the east side of SW 90th Avenue with sharrows where typical section does not allow, raised speed table/crosswalks at select locations, neighborhood traffic circles at possible locations spaced along the corridor to reduce speeds as well as stormwater upgrades. There is also contemplation to remove the 90-degree off street parking near the golf course and replace it with parallel parking, a shared used path for safe pedestrian/bicycle mobility, and enhanced landscaping consistent with the City Landscape Master Plan on the east side of SW 90th Avenue.

The Project will be evaluated and ranked by the MPO to determine program eligibility in accordance with the CSLIP policies. The construction cost of the project is projected to not exceed \$3 million in construction. Any City cost share will be determined by City Commission's approval of program elements that are not eligible for reimbursement from CSLIP.

STRATEGIC PLAN:

Safety and mobility improvements to the SW 90th Avenue corridor have a direct relationship to the City's Beautification and Revitalization objectives. Not only will the roadway be improved for functionality and connectivity, there are also aesthetic features that will rejuvenate the look of the roadway without losing any character of the City.
