RESOLUTION NO. 25-48

A RESOLUTION OF THE CITY OF COOPER CITY, FLORIDA, ADOPTING A TENTATIVE OPERATING MILLAGE RATE OF 5.8450 FOR THE FISCAL YEAR 2025-2026 COMMENCING OCTOBER 1, 2025, THROUGH SEPTEMBER 30, 2026; SETTING A DATE AND TIME FOR THE FIRST PUBLIC HEARING TO CONSIDER THE TENTATIVE MILLAGE RATE AND A DATE AND TIME FOR THE FINAL PUBLIC HEARING TO ADOPT THE FINAL MILLAGE RATE AND BUDGET; PROVIDING FOR DIRECTIONS TO THE CITY MANAGER; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on July 22, 2025, the City Commission determined the tentative Millage Rate for the fiscal year commencing October 1, 2025 ("Fiscal Year 2025-2026"), and further scheduled the first public hearing required by Section 200.065(2)(b) of the Florida Statutes to be held on September 11, 2025, at 5:01 p.m., and

WHEREAS, the City Manager has recommended an annual budget for the Fiscal Year 2025-2026, commencing October 1, 2025, and

WHEREAS, the public and all interested parties will have the opportunity to address their comments to the City Commission, and the City Commission will consider the comments of the public regarding the tentative millage rate; and

WHEREAS, the City Commission of the City of Cooper City finds that setting the tentative millage rate at 5.8450 for Fiscal Year 2025-2026 is in the best interests of the citizens and residents of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA:

Section 1: ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2: ADOPTION OF TENTATIVE MILLAGE RATE: There is hereby proposed to be levied upon all taxable real and personal property in the City of Cooper City, except that property exempted under the Constitution of the State of Florida, and other laws of the State of Florida, the following millage rates, on each One Thousand Dollars (\$1,000.00) of assessed value for the applicable tax year for the benefit of the City of Cooper City:

Tentative General Millage Rate for FY 2025-2026 is 5.8450.

(said millage is 6.89 % more than the rolled back rate of 5.4683

Section 3: ESTABLISHMENT OF DATES, TIME AND PLACE OF PUBLIC HEARINGS: The first public hearing shall be held on September 11, 2025, at 5:01p.m., and the final hearing shall be held on September 25, 2025, at 5:30 p.m., to adopt a final millage rate and budget for Fiscal Year 2025-2026. The first public hearing and the final public hearing shall take place in the Auditorium of City Hall, 9090 Southwest 50 Place, Cooper City, Florida, at which time the City Commission will receive and consider any comments on the millage and budget from the public.

Section 4: DIRECTIONS TO CITY MANAGER: The City Manager, or the manager's designee, is hereby authorized and directed to submit forms DR-420 (Certification of Taxable Value), DR-420Debt (Certification of Taxable Value Debt) and DR-420 MM-P (Municipality Maximum Millage Levy Calculation) to the Broward County Property Appraiser's Office.

Section 5: EFFECTIVE DATE: This resolution shall be effective immediately upon its adoption.
