Tuesday, April 19, 2022 at 5:30 PM City Hall Auditorium | 9090 SW 50th Place

### **MINUTES**

#### **PLEDGE OF ALLEGIANCE**

Mayor Ross opened the meeting at 6:30 PM and led the assembly in the Pledge of Allegiance.

#### **ROLL CALL**

Present were Commissioners Shrouder, Pulcini, Green and Mayor Ross. Commissioner Meltzer was absent.

#### **PUBLIC COMMMENTS (4 MINUTES)**

Marcela White, 11295 SW 55 Pl spoke on Forest Lake Dog Park and asked about grass near a fence that is blocking an area at the park. She also asked that the closing time of the park be adjusted to dusk and if a workshop will be scheduled to address the dog park issues.

City Manager Napoli will contact Ms. White with regard to the grass near the fence.

Commissioner Shrouder advised the dog park will not be closed but depending on the results of the data collected, it may be relocated. The Commission can only gather and discuss items during public meetings so unfortunately it can take time to address certain concerns.

#### **TOPICS FOR DISCUSSION**

Discussion on amending Section 3.02 to eliminate the prohibition on an individual serving as mayor and/or commissioner for more than three (3) terms cumulatively without relinquishing either office for a period of one (1) full term – four (4) years – **Commission** 

Mayor Ross indicated the verbiage in Section 3.02 is the issue at hand.

Commissioner Pulcini advised they are here to discuss if this item should be on the ballot. He believes the residents already voted on the topic.

Mayor Ross said there are new residents in the community and additional population in the City. The City has been updating ordinances to serve the residents in a better fashion.

Commissioner Pulcini asked City Attorney Horowitz to explain the difference between the City's Charter and the City's Code of Ordinances. He advised the Charter should not be changed as ordinances are.

Mayor Ross advised the Commission could bring forth charter amendments when they see fit.

City Attorney Horowitz explained there is a distinction between the City's Charter and the City's Code of Ordinances. The City Charter is essentially the City's constitution adopted by the voters and can only be amended by referendum presented by the voters. The Code of Ordinances is more of a living document that the Commission controls. The City Charter provides for a Charter Review Commission that is convened every six years, made up of volunteer residents appointed by the Commission to make recommendations on revising the Charter. The City Commission always has the prerogative under

Chapter 166 of the Florida Statues to present amendments to the City Charter and present those items to the voters. If they are approved they are made apart of the Charter. The Commission always has that option separate and apart from the Charter Review Board.

Commissioner Pulcini asked if the Commission can amend the Charter. City Attorney Horowitz advised that State Statues allow it.

City Attorney Horowitz advised section 7.01 of the Charter says the Commission and or the electors of the City may propose amendments to the Charter in accordance with Chapter 166.

Commissioner Green asked if the Mayor was in favor of reducing the number of years a candidate has to wait to run again.

Mayor Ross answered there are options, reducing to a limit of two years is an option as well as deleting the word cumulatively in Section 3.02.

Commissioner Green advised he is not in favor of changing the current code. He does not see the harm in sitting out a term if an individual has served for 12 years.

Commissioner Shrouder does not believe the terms should be different based on districts. He favors term limits but he is not opposed to fixing the language. He does not want District 1 or 2 to be penalized. He does not believe it should state and/or in section 3.02. He advised the language regarding qualifications needs fixed as well.

Commissioner Green said there are two seats up for election in 2022. If language is changed and an individual is re-elected, they could potentially resign and run for Mayor while not fulfilling a complete term.

Commissioner Shrouder answered the candidate would need to resign to run and would of completed two years. If they decided to run for Mayor they would serve 10 years opposed to another district representative.

Commissioner Green advised every election cycle theoretically you could have individuals step down and run for an open seat. He does see the need to change the Charter if it has been working.

Commissioner Pulcini advised the problem is with the position of Mayor. He asked if other municipalities who rotate the position of Mayor have this issue.

Mayor Ross advised the rotating option would eliminate the position of Mayor.

Commissioner Shrouder said the Broward County Commission chooses among each other who serves as Mayor.

Mayor Ross said he wants to make it clear that he does not want anything passed to affect him.

Commissioner Green asked if the individuals on the dais would be affected by a change.

City Attorney Horowitz advised it would depend on how the item was drafted. It can be drafted that it takes effect in 2026.

Commissioner Green answered you cannot exclude anyone from running

for office.

Mayor Ross advised he is termed out.

Commissioner Green does not understand the push for a change.

Mayor Ross advised the option is for the voters to decide.

Commissioner Green said that at a minimum of 80% in each district in 2020, the voters approved district representation seats elected by district voters.

Mayor Ross said the question on the ballot was not a recommendation by the Charter Review Board.

Commissioner Green said there has not been an uproar expressing the voters were duped or concerned with the 2020 ballot questions.

Commissioner Shrouder advised Embassy Lakes did voice concern.

Commissioner Green replied Embassy Lakes was concerned with redistricting.

Mayor Ross does not understand the fear of bringing an option to the voters. He stated the longer an individual serves the more affective they could be as they build relationships throughout the state.

Commissioner Shrouder said term limits became effective in the 1990's.

Commissioner Green said the voters approved term limits in 1994. They also voted in 2006 and extended terms. If there was a desire to remove term limits based on 1994 to 2006, the residents had time to reconsider.

Mayor Ross advised voters have not had an opportunity to vote on a change.

Commissioner Pulcini advised this request is not coming from the residents or a resident's board. It is being presented by the Commission.

Mayor Ross advised it is the Commission's job to present resident's options as leaders.

Commissioner Green advised an effective leader has to know when to follow. There has not been any residents who have expressed interest in eliminating terms or districts. He said when Embassy Lakes' residents voiced concerns with split representation the majority of the commission voted against Embassy Lakes.

Mayor Ross answered the Commission voted for the majority of the City has a whole.

Commissioner Green asked who in the community asked for redistricting.

Mayor Ross said the Charter required the Commission to redistrict.

Commissioner Shrouder advised the Commission did the bare minimum with regard to change with the redistricting.

Commissioner Green said the most affected group came in and voiced concern due to split representation. That issue did not happen throughout the City.

Commissioner Shrouder said statistics have proven questions proposed to voters on the ballot are usually passed. If the Commission suggests a ballot question statistics in America say, it is likely to pass and the Commission needs to be cautious of that. He said items added by the Commission and not by the Charter Review Board should not be drastic changes. He advised there is an issue with the qualifying portion of the Charter. There is an issue that redistricting was done in December and the

Charter states you must reside in your district for one year. There are other issues in the section that state and/or that should be corrected.

Commissioner Pulcini agrees with addressing language issues but not with drastic changes that will affect the residents.

Commissioner Shrouder believes drastic changes need to come from the residents but we do not have a method for the residents to add changes besides the Charter Review Board. The Commission can convene the Charter Review Board at any time.

Commissioner Green said addressing term limits is a drastic item. The current method in place is to convene the Charter Review Board.

Mayor Ross said each Commissioner's definition of drastic is different.

Commissioner Shrouder stated he might not be sitting on the dais if term limits were not in affect. He believes term limits are good; however, they do need to address the language in the Charter. Commissioner Shrouder believes the language needs to be addressed because of redistricting.

Mayor Ross said the word cumulatively in Section 3.02 should be deleted to address position.

Commissioner Green said it is clear if you serve three terms, you need to sit out a four-year term before potentially running again.

Mayor Ross said if a Commissioner moves to another position, they should be able to serve a full term.

Commissioner Green said the individual is forfeiting terms when choosing to run for another seat.

Commissioner Shrouder believes term limits should be applied to position seats but the Charter Review Board should ultimately decide.

Commissioner Green advised the Charter Review Board would allow a sample size of the residents to look at issues.

Mayor Ross asked why the commission is fearful of sending options to the voters.

Commissioner Green asked what the fear is in allowing the Charter Review Board to convene and weigh in on the options.

Mayor Ross answered there is a time restraint.

Commissioner Green asked if the issues discussed would not affect anyone on the current dais why is there a time restraint. The item can be given to the Charter Review Board to review and decide.

Commissioner Shrouder believes we need to divide the topics in two. Major items need to be left to the Charter Review Board. He asked who in the City is going to enforce term limits. The City Attorney's Office stated if someone turns in qualifying papers, the City Clerk has to accept the paperwork.

Mayor Ross asked when a challenge could be made.

Commissioner Shrouder said other municipalities have policies with regard to term limit questions.

Commissioner Green said he believes the item on the agenda is a drastic item. He said the Commission needs to determine if the item on the agenda is worthy of convening the Charter Review Board. He advised he is not in support of amending the section if it is not urgent.

Commissioner Shrouder said the City of Miami states candidates of the City shall be residents of the City for at least one year prior to qualifying. The City of Miami Clerk is authorized and directed to file and prosecute appropriate action in the Dade County Circuit Court in the name of the City Clerk solely for the purposes of receiving judicial termination with regards to qualifications of the candidate. He advised we need to correct the current issue at hand. If a candidate comes forward with a non-City Driver's License and signs the oath of residency form does the City Clerk qualify them.

City Attorney Horowitz advised if a candidate comes in and submits a complete package of paperwork, signs the Oath of Residency and the Oath of Candidacy which has penalties for violation, and pays the filing fee, the City Clerk accepts the documents at face value and qualifies the candidate.

Commissioner Green asked if an individual has a Town of Davie Driver's License and provides documents do they qualify.

Commissioner Shrouder said the City Clerk does not verify the documents turned in.

Commissioner Green asked if the City Clerk looks at the documents to see if the candidate qualifies.

City Attorney Horowitz advised, his office consulted with the Division of Elections Office and the City Clerk consulted with the Broward County Supervisor of Elections and all three agree if a candidate submits a complete package, signs the Oath of Residency and the Oath of Candidacy which has penalties for violation and pays the filing fee the City Clerk should accept the documents.

Commissioner Green asked what documents are needed to be brought forth for qualification.

City Clerk Tedra Allen advised the candidate needs to bring forth the Appointment of Treasurer, sign an Oath of Residency, Statement of Candidacy and pay the filing fee.

Commissioner Green said the Charter states you need to live in the district you're running for, for a period of one year.

Mayor Ross asked who has the authority to challenge the residency requirement, the City or the individual running against the candidate.

Commissioner Green advised due to the redistricting, no one has resided in the district up for election in November 2022 for one year.

Commissioner Shrouder advised there are two interpretations. The Charter previously stated that redistricting had to take place six months in advance as the residency requirement was previously six months. One interpretation could be a candidate would need to geographically live in the district for one year. The City Attorney advised the City Clerk does not look into the accuracy of the documents. The Oath of Residency is the oath used by the State and does not reference the City specifically. There are two interpretations currently with the residency requirement.

City Attorney Horowitz advised the Charter is clear in that the commission shall be the judge of the qualifications of its members and the grounds of forfeiture of office.

Commissioner Green asked if the Commission is the judge of qualification does that apply to the current election and does the Commission have the discretion with qualification documents.

City Attorney Horowitz advised the City Clerk is the qualifying officer. The Commission under state law and the language of the Charter is the judge as it relates to the interpretation.

Commissioner Green said the redistricting changed Embassy Lakes, there is no language in the Charter referencing the change.

Commissioner Shrouder answered there is a reference in the Charter but for only sitting commissioners.

Commissioner Shrouder asked how the Commission judges qualifications.

City Attorney Horowitz answered tonight's discussion can provide an opening for interpretation.

Commissioner Green said a candidate could challenge the Commission's interpretation.

Commissioner Shrouder advised we have no standing with the Charter when the City Clerk accepts all documentations at face value. The Oath of Residency is a generic State form with no reference to the City of Cooper City.

City Clerk Allen advised she requests three proofs of residency in order to qualify a candidate.

Commissioner Shrouder said the City Attorney's opinion stated documents are not examined for accuracy.

City Attorney Horowitz believes what the clerk referenced with requesting proofs of residency does not conflict with his opinion. If a candidate supplies all required documents she is to qualify them.

Commissioner Shrouder said the Charter states there is a verification process but the City Attorney's opinion stated it is a managerial act to accept qualifying documents.

City Attorney Horowitz answered he does not believe there is a conflict with the Charter and his opinion.

Commissioner Shrouder stated residents in Embassy Lakes were in District 4 prior to redistricting.

City Clerk Allen said if a candidates documents show proof of the district they wish to qualify for they will be qualified.

Commissioner Shrouder said the issue needs addressed and fixed.

Mayor Ross asked how the issue can be addressed and fixed in time for the 2022 November election.

Commissioner Shrouder said the Commission needs to do more research. The State does not interpret the City's Charter and under State law the commission is to interpret the Charter.

City Attorney Horowitz advised he gave his legal opinion to the City Clerk and City Manager.

Commissioner Shrouder said the memorandum from the City Attorney's Office said the City Clerk does not verify information.

Commissioner Green said there are several documents needed for qualification and candidates will need to provide accurate documentation.

Commissioner Shrouder said the City does not look into verifying documents.

Mayor Ross said he has a unique situation where his address is interpreted as a different City in some instances.

Commissioner Shrouder stated a Driver's License should state where you have resided for one year.

Commissioner Green said there are many complexities with this issue and it would be irresponsible to move forward with recommendations without convening the Charter Review Board.

City Attorney Horowitz said while he stands by his opinion he is happy to supplement the opinion. He advised for example, if a candidate was to submit a water bill from the City of Hollywood that paperwork would be considered incomplete.

Commissioner Shrouder said we need to clarify whether the City Clerk verifies the documents submitted or not. The issue needs addressed.

Mayor Ross said when we look at the documentation is the issue. When are the documents looked at or challenged.

Commissioner Shrouder said many Driver's Licenses used as proof of residency during qualifying may not state the candidates address.

Mayor Ross suggested allowing the City Attorney's Office to research the topic.

Commissioner Shrouder said the Commission will be asked to interpret the issue and he needs legal research in order to do so.

Commissioner Green asked to convene a Charter Review Board. He understands language needs cleaned up but the local elections office will determine if the resident meets the qualifications.

Mayor Ross asked that the City Attorney research the topic and place it on the next commission agenda.

City Attorney Horowitz advised the deadline to submit questions to the Broward County Elections Office for the November ballot is June 13, 2022. The ordinance for eliminating districts will be on the next agenda if desired.

Commissioner Shrouder advised there is not enough time to convene a Charter Review Board and have two readings of an ordinance.

Commissioner Green does not support changes.

The City Attorney's Office will research the subject and compile a memorandum.
