

CITY COMMISSION STAFF REPORT

DEPARTMENT: Community Development

SUBJECT: AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING CHAPTER

21, ENTITLED "UNIFIED LAND DEVELOPMENT CODE;" BY SPECIFICALLY AMENDING SECTION 21-8, ENTITLED "DEFINITIONS;" AMENDING THE DEFINITIONS OF "ACCESSORY USE" AND "PERSONAL IMPROVEMENT SERVICES" TO PROVIDE FOR AND TO INCLUDE MICROBLADE AND PERMANENT MAKE-UP SERVICES; PROVIDING FOR CONFLICTS; PROVIDING FOR CODIFICATION;

PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

BACKGROUND OF ITEM:

These proposed changes to add language to the definition of accessory use and provide language under personal improvement services related to micro-blade/permanent make-up were approved on $\mathbf{1}^{\text{st}}$ at the May $\mathbf{10}^{\text{th}}$ Regular Commission meeting.

The above use is becoming more popular, and Cities are starting to add language in their code to differentiate it from a "tattoo parlor" type use. The change related to the percentage of accessory use allowed was a recommendation from the City Attorney's office for "easier" regulation/enforcement of accessory uses within a primary use, such as micro-blading within a salon.

<u>Cities that have already adopted language for micro-blade and permanent make-up as an accessory use in a salon:</u>

- Hollywood
- Coconut Creek
- Coral Springs
- Plantation
- Lauderdale Lakes
- Pembroke Pines

ANALYSIS:

Staff is recommending approval of this item. It expands the business opportunities and creates a clear definition in the City Code.

PLANNING AND ZONING BOARD RECOMMENDATION

On April 4, 2022, the Planning and Zoning Board recommended the **APPROVAL** of the Code Change with a 7/2 vote.

STRATEGIC PLAN:

Continue the goal of becoming more business-friendly.
