# PLEDGE OF ALLEGIANCE

Mayor Ross opened the meeting at 7:15 PM and led the assembly in the Pledge of Allegiance.

# **1.** Motion to approve the fourth amendment to the City Manager's employment agreement – Commission

**MOTION:** Commissioner Shrouder moved to approve the fourth amendment to the City Manager's employment agreement Commissioner Katzman seconded the motion which prevailed by a unanimous roll call vote. (4-0)

# **2.** Discussion and possible action on the use of a professional recruiting firm for the position of City Manager – Commission

City Manager Napoli advised he received four proposals from professional firms. He advised in the short period of time they had they looked at four major criteria. They looked at familiarity with Cooper City, Broward County and Florida, cost, the process time from initiation and completion and if the firm is Florida based. The firm with the most experience is Colin Baenziger with experience in Cooper City and Broward County. Process time between all was between 3 to 3.5 months. City Manager Napoli recommends Colin Baenziger.

Commissioner Mallozzi asked if travel costs are included. City Manager Napoli answered travel costs are additional.

Commissioner Katzman asked if Colin Baenziger included marketing costs. City Manager Napoli said marketing is included.

Mayor Ross asked if Colin Baenziger listed guarantees.

City Manager Napoli read the guarantee from Colin Baenziger that included not approaching the selected candidate for any other position as long as the individual is employed by the city. If the selected individual leaves for any reason other than an act of God within the first year the search will repeat for the reimbursement of expenses. If the City is not satisfied with the candidates selected they will repeat the search until they are satisfied and the price is guaranteed.

City Attorney Horowitz along with the City Manager will work on an agreement with Colin Baenziger.

**MOTION:** Commissioner Mallozzi moved to approve the professional recruiting firm of Colin Baenziger and having the City Attorney and City Manager work on an agreement. Commissioner Shrouder seconded the motion which prevailed by a unanimous roll call vote. (4-0)

Commissioner Katzman asked about the timeline.

Commissioner Shrouder would like to meet with the firm the beginning of January to inform the firm about all 5 commissioners' expectations.

Commissioner Katzman asked to add the item to the January 10, 2023 meeting.
