DESCRIPTION: AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, PERTAINING TO THE

SUBJECT OF PUBLIC NOTICE; AMENDING CHAPTER 2 OF THE CITY'S CODE OF ORDINANCES, ENTITLED "ADMINISTRATION," BY SPECIFICALLY AMENDING ARTICLE XI, SECTION 2-273 ENTITLED "PROCEDURES FOR QUASI-JUDICIAL PROCEEDINGS;" AMENDING CHAPTER 22 ENTITLED "PLANNING AND PUBLIC FACILITIES:" BY SPECIFICALLY AMENDING ARTICLE I, SECTION 22-3 ENTITLED "AMENDMENT TO FUTURE LAND USE ELEMENT;" AMENDING CHAPTER 23, ENTITLED "ZONING DISTRICTS;" BY SPECIFICALLY AMENDING ARTICLE VI, SECTION 23-152 ENTITLED "CONDITIONAL USE;" AND SECTION 23-153 ENTITLED "VARIANCE;" AMENDING CHAPTER 24 ENTITLED "SUBDIVISION AND SITE PLAN REVIEW;" BY SPECIFICALLY AMENDING ARTICLE IV, SECTIONS 24-70 - 24-71 ENTITLED "NONCONFORMITIES ASSOCIATED WITH THE EXPANSION OF STATE ROADS WITHIN THE CITY" AND "NONCONFORMITIES ASSOCIATED WITH EXPANSION OF COUNTY ROADS WITHIN THE CITY;" PROVIDING FOR ADDITIONAL NOTICE FOR QUASI-JUDICIAL PROCEEDINGS; PROVIDING FOR CONFLICTS; PROVIDING FOR CODIFICATION; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE. - Commissioner Katzman
