SUBJECT: Motion to approve and authorize an agreement with Champion Controls, Inc.

in the amount of \$57,715.80 to furnish two (2) above ground duplex control

panels for the upgrade of lift stations No. 15 and 56. - Utilities

CITY MANAGER RECOMMENDATION:

The City Manager recommends Commission approval of an agreement with Broward County and Champion Controls, Inc. in the amount of \$57,715.80 to furnish two (2) above ground duplex control panels for the upgrade of lift stations No. 15 and 56.

BACKGROUND OF ITEM:

The City's sewer collection/transmission system includes 82 lift stations. Although majority of these lift stations use submersible pumps, six (6) of these lift stations are "can" stations, which were common in the 1960s and 1970s. However, they are no longer desirable because of the safety and functionality reasons. As a part of the City's master plan, these "can" lift stations are being converted into lift stations that would now use submersible pumps with new control panels. In FY 2023, lift station no. 15 and no. 56 are slated for conversion.

In any lift station there are two (2) primary components – pumps and control panels. The upgrades to both can stations will require installation of these two components. While this authorization pertains to the purchase of control panels, a companion agenda item will request sole-source purchase of Wilo pumps. In order to save monies, the Utilities crew will be performing majority of the work in house.

This Agreement with Champion Controls, Inc. has an expiration of December 13, 2023
