Quint 28 was placed in a reserve unit for routine maintenance and scheduled repairs July 14th and back into frontline on August 8th.

New Quint 28 Update: The vehicle is still in the early stages of production at Pierce in Appleton Wisconsin. It is still on schedule for delivery in late November/December 2025. We expect a web link to view the build progress on the apparatus to be available soon.

NEW Rescue 28 Update: The apparatus is at REV's Oakland Park shop. The emergency lights from Whalen have been installed but there is an issue with the controller and Whelen Tech Support is involved. REV also must install and program the SIS (Shift Interrupt Switch) anti-theft device. The Fleet Manager, Victor Goizueta has offered technical assistance for the SIS installation.

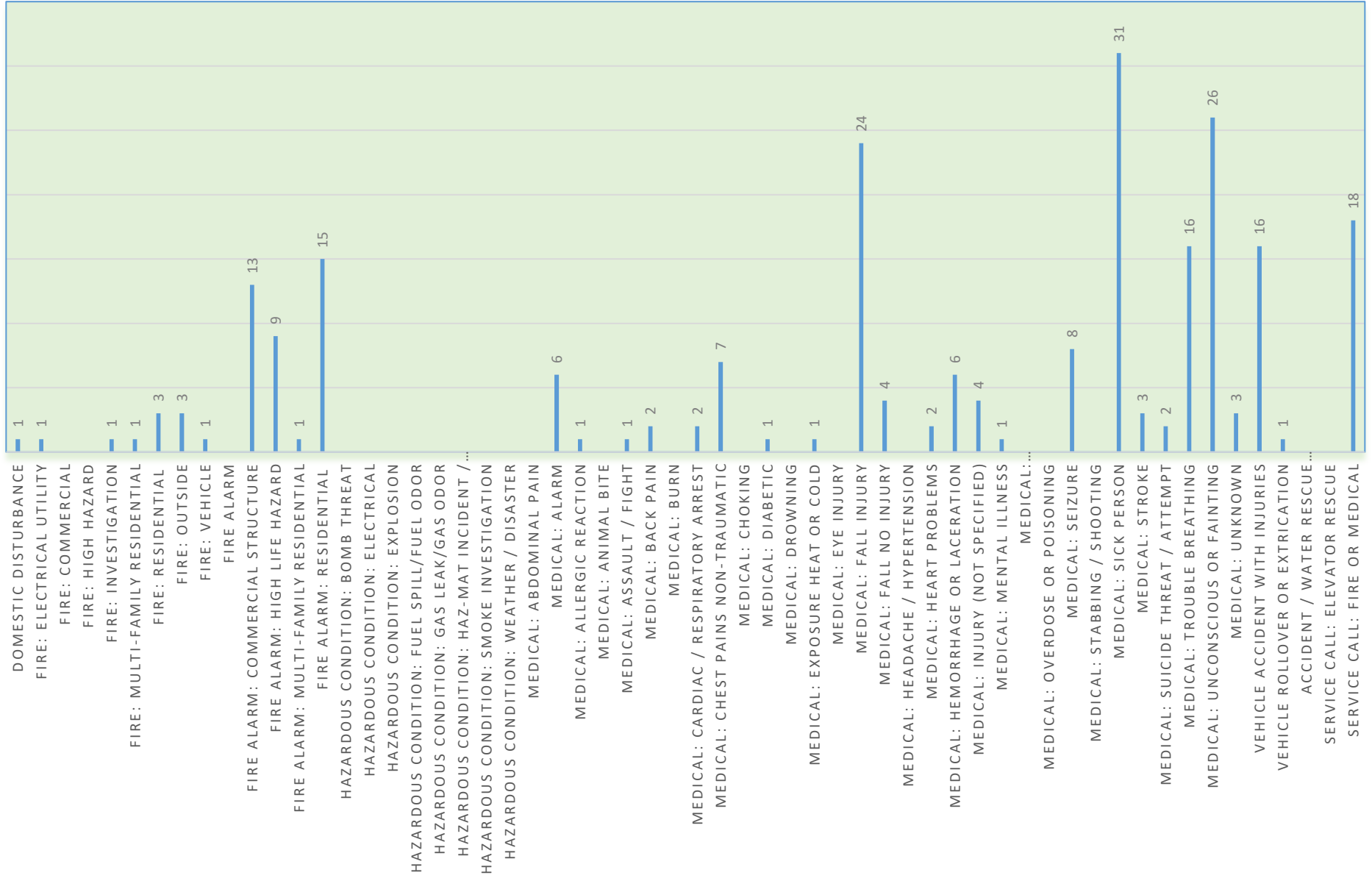

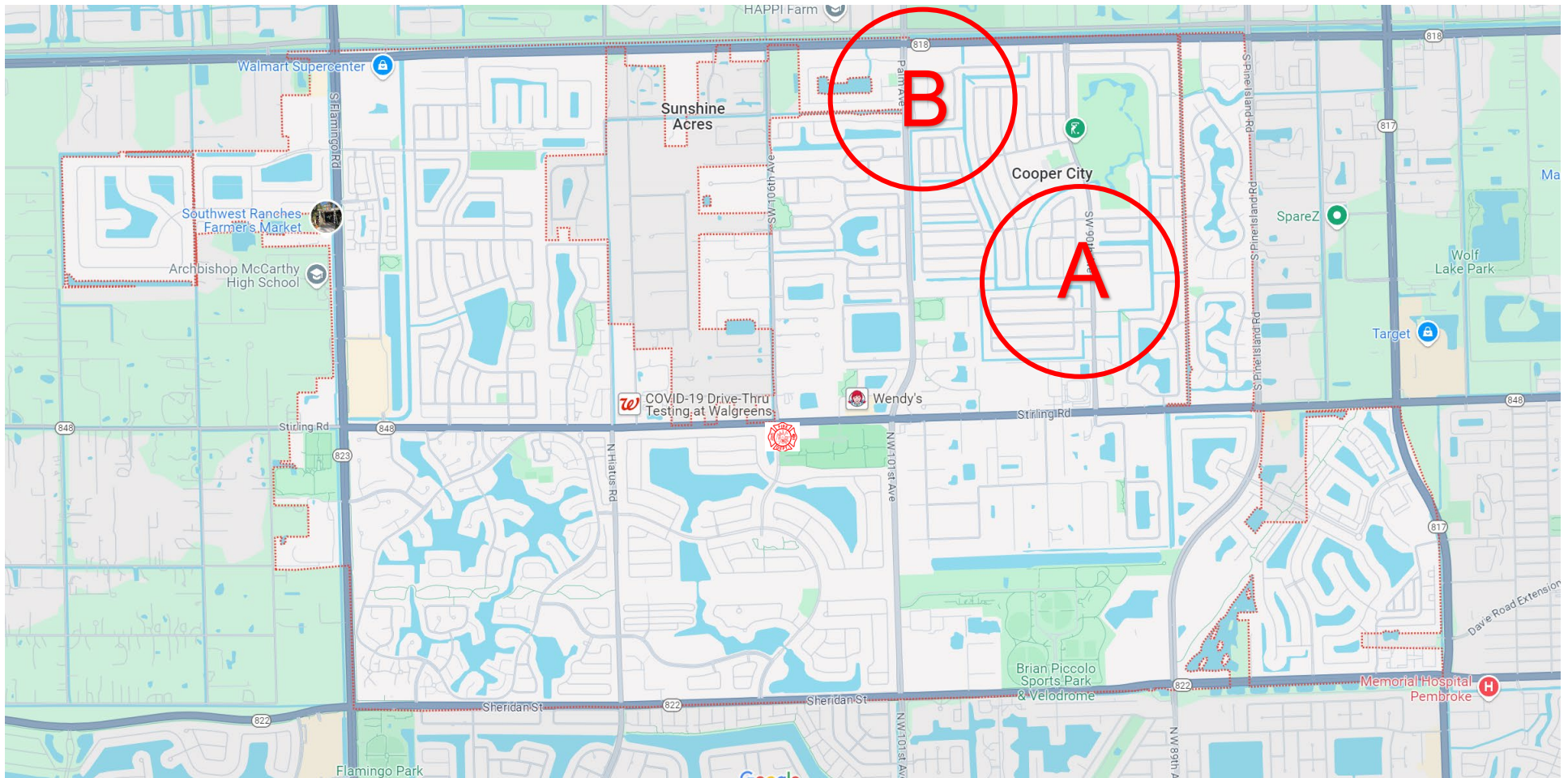
V. COMMUNITY OUTREACH REPORT
