

# CITY COMMISSION STAFF REPORT

SUBJECT: Motion to Approve the Piggyback of a Sourcewell Contract 020923-CEC for

Purchase of a Portable Diesel-Powered Air Compressor Trailer from 360 Energy

Solution, LLC for an amount not to exceed \$30,000. - Utilities

#### **CITY MANAGER RECOMMENDATION:**

The City Manager recommends that the Commission approve the piggybacking of Sourcewell Contract No. 020923-CEC, awarded to 360 Energy Solutions, LLC for Portable Construction Equipment with related accessories and attachments. This approval authorizes the purchase of a new diesel engine-driven, heavy-duty Portable Air Compressor Trailer in an amount not to exceed \$30,000. The agreement will run concurrently with Sourcewell Contract 020923-CEC and will be subject to terms and conditions acceptable to the City.

## **BACKGROUND OF ITEM:**

The city currently utilizes a 16-year-old air compressor that has reached the end of its useful life. Replacing this outdated equipment with a new diesel-powered, heavy-duty Portable Air Compressor Trailer will enhance the Utilities Department's ability to perform field operations more effectively and efficiently. The new compressor trailer will support tasks such as directional drilling for up to a 2-inch water service line and also power pneumatic tools such as air drills and air saws for water pipes.

## **PROCUREMENT**

Sourcewell was selected on December 20, 2022, under full and open competition. Eighteen (18) proposals were opened on February 9, 2023, and subsequently reviewed, evaluated and awarded. The following nine (9) suppliers were awarded contracts under RFP No. 020923: Clark Equipment Company | Federal Contracts Corp. | Generac Power Systems | JCB, Inc. | Multiquip, Inc. | Power Technique North America | Progress Solar Solutions | Skyjack, Inc. | Terex USA.

Article 2.C. of Sourcewell Contract No. 020923 allows supplier's authorized dealers, distributors or resellers relative to the Equipment, Products and Services offered under this Contract, which will be incorporated into this Contract by reference.

Clark Equipment Company provided an authorized reseller letter to validate that 360 Energy Solutions, LLC is an authorized Doosan Bobcat North America dealer and that 360 Energy

Solutions LLC is the sole authorized Doosan Bobcat Portable Power distributor for equipment sales and service as of January 14, 2025, for the air compressors, light towers and generators.

Piggybacking Sourcewell Contract No. 020923 offers the best value to the City due to time, expense and marketplace factors, pursuant to Sec. 2-258(f) of the Cooper City Procurement Code. The procurement process was conducted pursuant to Sec. 2-258(d) of the Cooper City Procurement Code.

Due diligence was conducted in accordance with Procurement Procedures to determine vendor responsibility, including verifying corporate status and that there are no performance and compliance issues through various vendor responsibility lists and a keyword internet search. The lists that were referenced included convicted vendors, debarred vendors, delinquent contractors, suspended vendors, and federal excluded parties. There were no adverse findings relating to vendor responsibility.

## **FISCAL IMPACT:**

Funding for this purchase is included in the Fiscal Year 2025 budget under the Utilities Department, in the amount of \$30,000. The lowest quote we received is \$27,465 from 360 Energy Solutions, LLC. The other two quotes are over \$30,000.
