MINUTES

PLEDGE OF ALLEGIANCE

Mayor Curran opened the meeting at 3:00 PM and led the assembly in the Pledge of Allegiance.

ROLL CALL

Present were Commissioners Smith, Mallozzi, Katzman, Shrouder, and Mayor Curran.

PUBLIC COMMENTS (3 MINUTES)

None.

TOPICS FOR DISCUSSION

1. FY26 Requested Budget

City Manager Rey discussed the general fund's recurring revenues as of July, noting our operating surplus is \$2,182,472. We started the year with \$32,620.814 and plan to transfer \$6,171,831 to fund capital improvements. The proposed millage rate for FY 25/26 is 5.845, lower than the current rate of 5.855. The fire assessment rate will increase due to higher public safety costs with BSO. Sales tax trends are expected to remain flat, while state revenue sharing will increase slightly from last year. Rates with FPL will rise next year. Investment funds remain steady. Staff will be bringing forth a recommendation for a new banking service to help obtain interest. The surtax allocation to the City will be \$536,396. The City may also explore a community shuttle option for residents. The Police budget for FY 25/26 is increased by \$340,000, and Fire's budget rises by \$238,321; both are budgeted figures. Health insurance costs are projected to increase by nearly 30%. Currently, we offer a two-tier plan, whereas most municipalities provide a four-tier plan. We are the only City offering a level 1 plan at this time.

Commissioner Mallozzi does not believe an HMO plan will be beneficial to any employee. City Manager Rey said the City's loss ratio is 152%. He is not recommending an HMO plan. City Manager Rey advised that staff had looked into other carriers. He suggested that Florida Blue Options is the best option.

HR Director Isis Medina advised the company that the best plan that compares to our current plan is Florida Blue Options, which is a PPO.

CFO Irwin Williams said the savings to the City will be \$104,000 with Florida Blue. City Manager Rey recommends creating a reserve for the savings to be used next year.

Commissioner Smith asked if an increase typically occurs every year with every carrier.

Director Medina advised that Cigna declined to cover the City due to our loss ratio.

Commissioner Katzman said he has coverage with Florida Blue in the high-deductible plan, and an HSA account is available as an incentive. He believes this may be a viable option. Director Medina said that currently, employees can enroll in an HSA, but the City does not contribute.

City Manager Rey would like to implement a cafeteria-style benefits approach.

Commissioner Mallozzi asked if the City Manager looked into self-assure.

Director Medina said she looked into options, but our experience in the City is too high.

Commissioner Smith said a change in insurance could affect staff's current providers.

Commissioner Shrouder said the plan we have currently is not realistic. The cost of benefits is substantial. He would like to look into better managing insurance costs.

Commissioner Smith said switching medical insurance will save us \$104,000. He also spoke on the potential gains of changing our banking services.

Commissioner Shrouder said the City may need to offer health insurance advocates to help educate individuals on available options. He stated that the City lost money and time by having to reissue the banking services RFQ. The issue was identified two years ago, and it has taken us this long to address it.

City Manager Rey said he and staff are looking into former retired employees who may be utilizing benefits they did not qualify for.

Commissioner Katzman asked what the City Manager needs from the Commission today regarding health insurance. City Manager Rey said he believes there is a consensus to move to Florida Blue.

Commissioner Smith wants to know what disruption this may cause to the employees.

City Attorney Horowitz noted that some changes are beyond the City's control, such as the acceptance of insurance by medical providers.

Commissioner Mallozzi said if the employees are not happy, it may cost the City more in the long run. She would like to see comparable lists for providers.

Commissioner Katzman said, generally speaking, most physicians will accept Florida Blue. Incentivizing plans may also help draw interest.

Commissioner Mallozzi asked if the City could face legal issues by counseling individuals to move to Medicare. City Attorney Horowitz said the City can provide an advocate as long as it is an opportunity for all employees.

Commissioner Shrouder said that having an advocate available to help individuals with paperwork and options would benefit everyone.

Commissioner Mallozzi asked if we could engage in advocate services now. City Manager Rey said health insurance carriers always look at history.

City Manager Rey said there has not been enough time spent on risk management within the City.

Commissioner Shrouder said risk management has to explore options.

Mayor Curran spoke on increasing stipends.

Commissioner Smith said the City has to get ahead of this, as costs will increase yearly. City Manager Rey will explore options.

Commissioner Shrouder would also like to create a reserve for the savings.

City Manager Rey said the budget also includes a 2.5% cost-of-living increase. The only additional position being proposed in the budget is a Community Development Economic Liaison.

Commissioner Smith asked City Manager Rey to clarify that he is only asking the Commission to approve one position. City Manager Rey answered yes.

Commissioner Mallozzi said that the statement is incorrect, as he is asking to approve a crossing guard position on a future agenda. City Manager Rey stated the crossing guard position replaces a contract.

Commissioner Mallozzi said the City does not have a community development district.

Commissioner Shrouder said he would like to merge IT with Communications. An additional position in Communications that can help attract businesses could be more beneficial.

City Manager Rey said we currently outsource communications services at \$66,000. If we move to a part-time position, we can produce savings. We also outsource IT services, including a monitoring service, for a total of \$104,000. Most issues are handled in-house, so he is terminating that service as of August 2025.

Mayor Curran said the knowledge in Community Development will thrive with the new position.

Commissioner Shrouder wants a robust communications department.

Commissioner Smith supports adding to the communications department.

City Manager Rey envisions this additional position as one that works directly with businesses and may attend several events.

Commissioner Shrouder said the Community Development Department is moving to stronger software, and he wants to add it to the communications department.

Commissioner Katzman likes the idea of a community engagement outreach position. The goal appears to be a position that facilitates engagements, making the City more efficient. He likes the idea of merging Communications and IT. He asked what the IT position in Community Development will merge into once the software is initiated. He believes the person may be eligible for inclusion in the department merger.

Commissioner Smith stated he wants to make sure any in-house employees interested in the position are considered and given the tools to succeed if needed. He also does not want to limit the salary amount if the best is needed.

Commissioner Shrouder said he wants a plan established, and if more funds are needed, the Commission will be notified.

City Manager Rey said \$600,000 is included in the budget for neighborhood tree trimming. There is \$300,000 budgeted for sidewalks. There is also \$100,000 budgeted for janitorial services, which has been increased to include services at the parks, and there has been interest in a July 4, 2026, celebration for the 250th anniversary. He asked the Commission's view on the subject.

Commissioner Katzman said the City can add the celebration to Founders Day.

Commissioner Shrouder suggested a patriotic theme.

Commissioner Mallozzi spoke on municipalities moving from fireworks to a light show.

Commissioner Smith asked if we could use flags or lights throughout the City as we do for the winter holidays.

City Manager Rey stated that in FY 2026, they will need to update the Strategic Plan, Stormwater Master Plan, and Rate Study, as well as the credit rating for utilities and special revenues. The plans that were completed this year include the Water and Wastewater Master Plan, Parks and Recreation Master Plan, Beautification Master Plan, and the Computer Equipment Replacement Schedule. A stormwater study will help with state support. There will be some significant projects in FY 2026 that will start, including the electrical system update. We will apply for funds from Resiliency Florida. The headworks project will also begin. We have applied for \$7 million through federal appropriations. In Fiscal Year 2027, the City will need to consider borrowing money. The new meter installation is close to 70% complete. The Parks and Recreation Plan projects will begin with two playgrounds being upgraded per year. There is still money allocated from the Beautification Master Plan of the previous year, making the allocation \$890,000. The projects include monument signs, park benches, walls, and fences.

Commissioner Smith asked if we prioritized the locations of the monument signs. City Manager Rey answered that the options will be presented to the Commission. Commissioner Smith would also like to see a rendering of the benches and furnishings.

City Manager Rey advised that the IT Computer Master Plan include all equipment and replacement plans for equipment. The Vulnerability Study projects include the Water and Wastewater Treatment plants. The Pavement Condition Index analysis program is close to \$1 million per year.

Commissioner Smith asked if we are alerting the residents of the pavement projects. City Manager Rey will post the information.

City Manager Rey said facility improvements include public safety facilities, a Citywide HVAC replacement, and a public safety facility assessment with access control cards.

Commissioner Mallozzi does not want to include a new City Hall. City Manager Rey said he included the structure in the latest public safety facility update.

City Manager Rey stated he has had second thoughts on the LED lights on Griffin Road, as it is a state road.

Commissioner Mallozzi said she has heard concerns about the roundabout on Hiatus Road. She spoke to her colleagues at the MPO, and a waiver can be obtained to work around the distance rule. The waiver includes a traffic study, which she would like completed in the first two weeks of school.

Commissioner Shrouder read a letter of support for a roundabout from over 22 years ago, written by Former Mayor Debbie Eisinger. He stated that the state is providing us with funds for design, and we need to move forward.

Commissioner Mallozzi wants to pursue the traffic study for a waiver as opposed to the roundabout.

Commissioner Smith is not interested in the study for a waiver. He asked Commissioner Katzman to speak on the letter he read at a previous Commission meeting with HOA support. Commissioner Katzman said he read a letter from the property manager on behalf of the Board of Directors.

Commissioner Shrouder said the roundabout will be aesthetically pleasing.

Mayor Curran asked the City Manager to show the residents where the sidewalk will be added to help address concerns. He also asked to reduce the speed on Hiatus Road.

City Attorney Horowitz has asked Broward County why and on what basis our request for a lower speed limit was denied.

Mayor Ross would like a workshop for residents to voice concerns.

Commissioner Katzman would like information advertised showing where the sidewalks will be.

Commissioner Smith wants drone photographs included.

Mayor Curran would like staff to address concerns regarding FPL issues.

Commissioner Katzman said he was told by our FPL liaison that residents can go to the FPL website to submit claims. He would like a resolution drafted.

Commissioner Smith has not received complaints. He asked what the complaints were.

Commissioner Mallozzi said she has been notified of damage to properties.

City Manager Rey said there are two issues. There are issues with the areas from construction work and surge issues. He suggested contacting the Public Service Regulatory Commission.

Commissioner Shrouder believes the issues are with the site on Palm Avenue. He would like a stop order to be issued.

Commissioner Katzman asked if they could adopt a resolution that could be forwarded to the Public Service Regulatory Commission. City Attorney Horowitz answered that he can complete a resolution in draft form and adopt it.
