## **RESOLUTION NO. 25-51**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, APPROVING THE CITY'S LEGISLATIVE PRIORITIES FOR FY2026-2027; AUTHORIZING AND DIRECTING THE CITY TO ACCEPT THE AWARD OF ALL APPROPRIATED FUNDS, EXECUTE GRANT AGREEMENTS, EXPEND BUDGETED FUNDS, AND TAKE ANY AND ALL ACTION NECESSARY TO IMPLEMENT THE TERMS AND CONDITIONS OF ANY GRANT AGREEMENTS CONSISTENT WITH THE FY2026-2027 LEGISLATIVE PRIORITIES; AUTHORIZING AND DIRECTING THE CITY MANAGER TO TAKE ANY AND ALL ACTION NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS,** the Florida Legislature annually considers appropriations which provide funding for infrastructure, programs and projects; and

**WHEREAS,** the 2026 Florida Legislative Session is scheduled to commence on January 13, 2026; and

WHEREAS, the City Manager and the City's professional staff have identified a number of critical infrastructure projects set forth on the Staff Report attached to this resolution and incorporated herein by reference; and

**WHEREAS,** the City's legislative priorities and appropriation requests are consistent with the City's strategic plan and necessary for the City's revitalization and beautification efforts; and

WHEREAS, the City Commission seeks to approve the manager's recommendations for the FY2026-2027 state legislative priorities and to authorize and direct the City Manager to take any and all action necessary in furtherance of such efforts, including, but not limited to, the execution of applicable grant agreements, the acceptance and expenditure of grant funds and to take any further steps necessary to implement the terms and conditions of such grant agreements; and

WHEREAS, the City Commission of the City of Cooper City, Florida finds that the adoption

of this resolution is in the best interests of the citizens and residents of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE

CITY OF COOPER CITY, FLORIDA, THAT:

**Section 1.** The foregoing "WHEREAS" clause is hereby ratified and confirmed as being

true and correct and is hereby made a specific part of this Resolution. **Section 2.** The

Commission of the City of Cooper City, Florida hereby approves the City Manager's recommended

FY2026-2027 state legislative priorities. The City Commission hereby further authorizes and directs

the City Manager to take any and all steps necessary to pursue appropriations pursuant to such

priorities, including, but not limited to, the execution of applicable grant agreements, the acceptance

and expenditure of grant funds and to take any further steps necessary to implement the terms and

conditions of such grant agreements.

**Section 3.** The City Manager is hereby authorized and directed to accept the grant funds

and to take any and all action necessary to effectuate the intent of this resolution.

Section 4. All Resolutions or parts of Resolutions in conflict herewith, be and the same

are repealed to the extent of such conflict.

**Section 5.** If any section, sentence, clause or phrase of this Resolution is held to be invalid

or unconstitutional by any court of competent jurisdiction, then said holding shall in no way affect

the validity of the remaining portions of this Resolution.

Section 6. This Resolution shall become effective immediately upon its passage and

adoption.
