## **RESOLUTION NO. 25-21**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY FLORIDA, CITY. APPROVING AUTHORIZING THE CITY MANAGER TO PURSUE AND EXECUTE A GRANT AGREEMENT WITH THE STATE OF FLORIDA DIVISION OF **EMERGENCY** MANAGEMENT (FDEM) THE HURRICANE LOSS **MITIGATION** FOR PROGRAM (HLMP); AUTHORIZING THE CITY MANAGER TO ACCEPT THE GRANT FUNDING AND TAKE ANY AND ALL ACTION NECESSARY TO EFFECTUATE THE INTENT OF **PROVIDING RESOLUTION**; **FOR CONFLICTS:** PROVIDING FOR SEVERABILITY: AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Cooper City ("City") seeks to apply for a Florida Division of Emergency Management (FDEM) Hurricane Loss Mitigation Program (HLMP) grant to fund the City's police department wind mitigation project, in an amount not to exceed \$160,000; and

WHEREAS, if received, the City intends to utilize the grant funding for wind mitigation and retrofit activities through the removal and installation of windows and doors, thereby enhancing the police department building's resistance to hurricane force winds and debris, mitigating potential losses in the event of a hurricane or severe weather event, and fortifying the City's police department and emergency operations center; and

**WHEREAS,** the City Commission of the City of Cooper City, Florida deems it to be in the best interests of the citizens and residents of the City of Cooper City to authorize the City Manager to pursue and execute a grant agreement with FDEM for the HLMP grant.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, THAT:

**Section 1.** The foregoing "WHEREAS" clause is hereby ratified and confirmed as being true and correct and is hereby made a specific part of this Resolution. All exhibits

attached hereto are incorporated herein and made a part hereof.

Section 2. The City Commission of the City of Cooper City, Florida hereby to authorizes the City Manager to pursue and execute a grant agreement with the State of Florida Department of Emergency Management, as needed, for the Hurricane Loss Mitigation Program Grant.

Section 3. The City Manager, or City Manager's designee, is hereby authorized and directed to accept the grant funds and to take any and all action necessary to effectuate the intent of this resolution.

**Section 4.** All Resolutions or parts of Resolutions in conflict herewith, be and the same are repealed to the extent of such conflict.

Section 5. If any section, sentence, clause or phrase of this Resolution is held to be invalid or unconstitutional by any court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this Resolution.

**Section 6.** This Resolution shall become effective immediately upon its passage and adoption.
