

## RESOLUTION 23-15

**A RESOLUTION OF THE CITY OF COOPER CITY, FLORIDA SUPPORTING HONORARILY DESIGNATING THE PORTION OF S.R. 823/SOUTH FLAMINGO ROAD BETWEEN SOUTHWEST 52<sup>ND</sup> STREET AND SOUTHWEST 55<sup>TH</sup> STREET IN BROWARD COUNTY AS ARCHBISHOP EDWARD A. MCCARTHY HIGH SCHOOL WAY; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, Archbishop Edward A. McCarthy High School is celebrating its 25<sup>th</sup> anniversary this year; and

**WHEREAS**, the State Legislature and the Governor approved the road honor designation for Archbishop McCarthy High School as follows: “That portion of S.R. 823/South Flamingo Road between Southwest 52<sup>nd</sup> Street and Southwest 55<sup>th</sup> Street in Broward County is designated as “Archbishop Edward A. McCarthy High School Way.”; and

**WHEREAS**, the segment of S.R. 823/South Flamingo Road between Southwest 52<sup>nd</sup> Street and Southwest 55<sup>th</sup> Street in the Town of Southwest Ranches is under the jurisdiction of Florida Department of Transportation; and

**WHEREAS**, pursuant to Section 334.071, Florida Statutes, the designation of a state transportation facility (including a road segment) for honorary or memorial purposes requires a special act of the Florida Legislature, and markers/signage reflecting such a designation may only be placed along such road if the local government body passes a resolution in support of the designation; and

**WHEREAS**, the City supports the Florida Department of Transportation to install signage reflecting the designation.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA:**

**Section 1.** The recitals above are true and correct and are incorporated herein by reference.

**Section 2.** The City Commission hereby supports honorarily designating that portion of S.R. 823/South Flamingo Road between Southwest 52<sup>nd</sup> Street and Southwest 55<sup>th</sup> Street in Broward County to Archbishop Edward A. McCarthy High School Way.

**Section 3.** That the appropriate City officials are authorized and directed to take any and all actions necessary to effectuate the intent of this resolution.

**Section 4.** This Resolution shall take effect immediately upon adoption.
