Hello Mr. Manager,

I am writing on behalf of Archbishop McCarthy High School in the Town of Southwest Ranches. I serve on their Board of Director's and I am helping with this effort. The Florida State Legislature and the Governor approved a road designation during the most recent Legislative session as follows:

"That portion of S.R. 823/South Flamingo Road between Southwest 52nd Street and Southwest 55th Street in Broward County is designated as "Archbishop Edward A. McCarthy High School Way."

The Resolution from the state and the full legislative tracking and bill can be accessed via this link: House Bill 21 (2023) - The Florida Senate (flsenate.gov)

Please see email from FDOT to your team below. Although Archbishop McCarthy High School is located in the Town of SWR, because this portion of Flamingo Road also falls within Cooper City, the Florida Statutes require that Resolutions supporting the designation must be passed by each affected local government prior to the erection of the markers.

The Town of Southwest Ranches plans to pass the attached Resolution at their meeting next week and we are hoping that Cooper City might also be able to include a Resolution on your agenda for your meeting on July 25. The school is hoping to have the sign installed in time for the first day of school in mid-August but FDOT will not be able to install until they receive the Resos from SWR and CC.

State Legislature and the Governor approved the road honor designation for Archbishop McCarthy High School as follows:

"That portion of S.R. 823/South Flamingo Road between Southwest 52nd Street and Southwest 55th Street in Broward County is designated as "Archbishop Edward A. McCarthy High School Way."

The full legislative tracking and bill can be accessed via this link: House Bill 21 (2023) - The Florida Senate (flsenate.gov)

Florida Statute 334.071 indicates that if the road segment being designated is located in more than one city, resolutions supporting the designation must be passed by each affected local government prior to the erection of the markers.
