Dear Ryan,

I hope you are having a great week! Please find the updates to our proposal below:

- A six (6) month extension with a 5% adjustment on the WM Collection portion of the rate, effective from 10/1/2023 to 3/31/2024. Additionally, I want to remind you that the disposal

portion of your rates was increased by WIN Waste on July 3rd, and there will be a second adjustment on Oct 1st, 2023, based on the new disposal per ton rate. The Recycling Processing rate will also be adjusted on October 1st to reflect the new WM processing rate in the county.

- WM commits to providing \$5,000 for the Environmental Scholarship program during the extension term.

Regarding the termination clause, I would like to point out that WM will not accept a termination for convenience due to the short term of the agreement, as discussed in our previous conversations. However, the termination for breach clause will continue to be in effect, as stated in the current agreement.
