MINUTES

PLEDGE OF ALLEGIANCE

Mayor Ross opened the meeting at 6:30 PM and Alyssa Kahn and Valentina Menendez led the assembly in the Pledge of Allegiance.

ROLL CALL

Present were Commissioners Shrouder, Meltzer, Pulcini, Green and Mayor Ross.

CHANGES TO AGENDA/EMERGENCY MATTERS

City Manager Napoli pulled number 19 the Discussion and Possible Action on Code Section 25-10 to be brought forth at a future Commission meeting with a recommended code change.

PUBLIC SPEAKING

Open Public Meeting

Clay Faulk, 5681 SW 113 Ave, thanked the Commission for closing Forest Lake Dog Park as it was a difficult decision to come to.

Stephanie Sterr, 5707 SW 113 Ave thanked the Commission for closing Forest Lake Dog Park.

Santiago Fernandez, 5661 SW 113 Ave, thanked the Commission for closing Forest Lake Dog Park.

Thomas Honan, 5691 SW 113 Ave, thanked the Commission and City Manager Napoli for closing Forest Lake Dog Park.

David Nall, spoke on the declaratory action result with regard to the qualification of Joshua Giancarlo. He believes the City mismanaged the case and asked the City to have a discussion on a possible appeal.

Joshua Giancarlo, 10909 Nashville Dr, thanked the City Attorney, City Manager and City Clerk for their efforts on the declaratory action.

Thomas Callazo, 11305 SW 58th thanked the Commision and the City Manager for listening to their concerns and closing Forest Lake Dog Park.

Commissioner Green advised contrary to social media posts he did not know any of the residents that spoke with concerns regarding Forest Lake Dog Park personally.

Commissioner Meltzer said he did what was in the best interest of the City with regard to closing the dog park.

BOARD/ADMINISTRATIVE REPORTS

1. June 2022 Financial Report – Finance

CFO Aaron Kendrick advised he can produce the financial reports in any format the Commision prefers.

Commissioner Pulcini said the format chosen first online was preferable.

Commissioner Meltzer would like to receive the trial balance and the customary report.

CFO Aaron Kendrick advised all governmental funds are in the positive. As of June 30, 2022 the General Fund fund balance is at \$21,400,000.

Commissioner Meltzer asked a potential guess on the fund balance by fiscal years end. CFO Aaron Kendrick advised about \$9 or \$10 million more from the previous year however we can expect about \$9 or \$10 million in expenditures. Commissioner Meltzer asked about receiving encumbrances. CFO Aaron Kendrick advised encumbrances will be presented in August and September.

CFO Aaron Kendrick advised the Water and Sewer Fund is experiencing inflationary pressures. However, they have enough fund balance to absorb the cost.

Commissioner Pulcini asked if the Capital Projects Fund still has a negative fund balance. CFO Aaron Kendrick answered yes.

CFO Aaron Kendrick advised in terms of budget to actuals, revenues are ahead of schedule and expenses are lagging. As we approach the end of the year there will be an uptake in expenses to get projects done before closeout. There was a utilization plan conducted for the Community Development Department and it will be updated. We are currently at 21% for ARPA expenditures. He also advised staff hired a contractor to replace the previous ARPA Manager.

Commissioner Meltzer asked if we received the state money for pensions and if so how much. CFO Kendrick will verify.

CFO Kendrick advised the City completed the audit on June 30, 2022. June 30th was the cutoff. At 9:00 PM the audit was released and it was forwarded to the State. Additionally that report has to be uploaded on the State website for the AFR. The report was late and he advised he takes responsibility for missing the due date. He also stated staff worked hard to complete the audit and he commends his staff for their work and advised moving forward he will not miss any future deadlines.

Commissioner Shrouder asked the amount of the contract for the ARPA Manager. CFO Kendrick answered \$19,500 for a two month period. Commissioner Shrouder asked if the City would need him for more than two months as the procurement code prohibits splitting contracts under \$20,000 to forgo city approval. City Manager Napoli advised the gentleman agreed to a test period of two months.

Commissioner Shrouder asked about the FDOT Streetlight reimbursement. CFO Kendrick advised the Public Works Director has been communicating with the State for the reimbursement. Commissioner Shrouder wants to assure we meet the deadline to receive the money. CFO Kendrick advised we have a list of schedules for shared revenues. Commissioner Shrouder asked if there is an individual who consistently monitors the budget to actuals. CFO Kendrick advised each month staff reviews variants and deviants. Commissioner Shrouder also asked about EMS Transport at \$0. CFO Kendrick advised he is available to meet and discuss the line items in detail with Commissioner Shrouder. Commissioner Shrouder asked if we are currently over budget on any items other than Water and Sewer, or under budgeted on any items. CFO Kendrick advised there is a report available with those details that he can provide to the Commission.

Commissioner Meltzer asked that we collect all funds that are due to us from the State. CFO Kendrick advised the City Manager is making sure we monitor obtaining our fair share of revenues. Commissioner Meltzer said to let the Commission know if resources are needed.

2. Appointment to City Boards Update

City Clerk Tedra Allen advised Courtney Spiker, Bob Sands, Benjamin McAffee, Larry Kreisberg and Michael Vadnal have been appointed to the Mental Health and Wellness Advisory Board.

Mayor Ross thanked the appointees.

Commissioner Shrouder asked if we have vacancies on the pension boards. City Manager Napoli advised he will appointing a member to the Police Pension Board.

Commissioner Meltzer asked for an updated list of Board vacancies.

Commissioner Shrouder asked about vacancies on all pension Boards.

City Manager Napoli will provide a list to the Commission.

MOTION: Commissioner Meltzer moved to approve the consent agenda. Commissioner Green seconded the motion which prevailed by a unanimous roll call vote. (5-0)

15. Motion to approve and authorize an agreement with Crom, LLC pursuant to Section 2-258 (f) of the City code in the amount of \$84,249.05 for cleaning, repair, and restoration of a concrete water storage tank at 2650, N. Pine Island Road, Cooper City, FL, piggybacking City of West Palm Beach extended contract – Utilities

Commissioner Shrouder asked Public Works Director Raj Verma if he is familiar with the work and sure of the costs. He also confirmed the addendum was removed. Public Works Director Raj Verma answered yes.

MOTION: Commissioner Shrouder moved to approve and authorize an agreement with Crom, LLC pursuant to Section 2-258 (f) of the City code in the amount of \$84,249.05 for cleaning, repair, and restoration of a concrete water storage tank at 2650, N. Pine Island Road, Cooper City, FL, piggybacking City of West Palm Beach extended contract. Commissioner Meltzer seconded the motion which prevailed by a unanimous roll call vote. (5-0)

16. Motion to approve an agreement with Chen Moore and Associates for the development of a Citywide Landscape Master Plan with supporting Design Guidelines in the amount of \$92,241.00 – Public Works

Commissioner Shrouder asked Public Works Director Tom Good if he has reviewed the contract and is satisfied with the price. Director Good answered yes.

Commissioner Meltzer looks forward to the publics input for design.

MOTION: Commissioner Shrouder moved to approve an agreement with Chen Moore and Associates for the development of a City-wide Landscape Master Plan with supporting Design Guidelines in the amount of \$92,241.00. Commissioner Green seconded the motion which prevailed by a unanimous roll call vote. (5-0)

17. Motion to approve an agreement with The Butler Group of South Florida, LLC D/B/A Nextaff for crossing guard services. – Parks and Recreation

Commissioner Pulcini said he understands this item is time sensitive.

Commissioner Shrouder asked why this contract is being presented late. Parks and Recreation Director Stacie Weiss advised they were trying to work with the previous vendor but do to staffing within the Finance Department they had to do market research and proceed that way. Commissioner Shrouder asked the percentage increase. Director Weiss answered the hourly rate is going from \$13.84 to \$21.07 an hour. Commissioner Shrouder asked when Director Weiss spoke with Finance. Director Weiss answered initially in December. Commissioner Shrouder asked why the item was not procured by Finance. City Manager Napoli advised the item was held up by the Finance Department and in the meantime they searched for piggyback contracts. Commissioner Shrouder said he has voiced concerns about the Procurement Department and was told by the City Manager things were fine and now the City is paying 50% more for a service.

Commissioner Meltzer asked the options we currently have. City Manager Napoli recommended approving the contract and then issuing a RFP. He also asked why we can't transition this contract to a task under the Police Department.

Commissioner Shrouder asked why we cannot hire crossing guards like other municipalities do. Director Weiss answered they require certifications. Commissioner Shrouder asked why we could not hire individuals that are trained already.

Mayor Ross asked if Director Weiss inquired about pricing from other municipalities. Director Weiss answered yes.

Mayor Ross would like to approve the item, start the RFP process and look into the cost of training inhouse possibly using CERT or COP members.

Commissioner Shrouder asked whose responsibility it is to provide services. Director Weiss answered statute cites the party who has jurisdiction over the roads.

MOTION: Commissioner Green moved to approve an agreement with The Butler Group of South Florida, LLC D/B/A Nextaff for crossing guard services. Commissioner Pulcini seconded the motion which prevailed by the following roll call vote. (3-2)

NO: Commissioners Shrouder and Meltzer

YES: Commissioners Pulcini, Green and Mayor Ross

18. Motion to approve an agreement with Evergreen Solutions, LLC to conduct a Classification and Compensation Study – Administration

Commissioner Pulcini said the cost of the study is substantial and would like to do the study in house. However, we need to take action immediately and take care of the employees.

HR Director Lourdes Mantecon advised the City does not have the resources to conduct the study in house.

Commissioner Meltzer prefers to look into doing the service in house. He asked the resources needed. HR Director Lourdes Mantecon advised a company would look into all neighboring municipalities' pay scales and job descriptions.

Commissioner Shrouder said of 33 cities provided to the commission only 7 preformed a compensation study and only 3 were conducted after our 2016 study. Commissioner Shrouder advised we should retrieve the data from the previous company from 2016. The main issue is compensation. HR Director Lourdes Mantecon advised in exit interviews previous employees mentioned the need of updating job descriptions. Commissioner Shrouder said the 2016 study was updated in 2019. He asked what plan she would ask the company to look into. HR Director Lourdes Mantecon answered a step plan could be valuable. Commissioner Shrouder asked if there is a database with job descriptions. Also, there are several irregularities and changes to job descriptions that have not been updated without Commission approval.

Commissioner Pulcini does not want to stall the issue.

Commissioner Shrouder said we need to have direction before hiring a company.

Mayor Ross said he would like to look into taking the project in house in the future but staff has spoken on their needs.

Commissioner Shrouder asked Director Mantecon if she reviewed the 2016 report. HR Director Mantecon answered no. Commissioner Shrouder would like her to review the information as she may gain the information needed.

Commissioner Pulcini asked that HR conduct a report on our own employees.

Commissioner Meltzer said to keep in mind there are a lot of residents that are suffering as well.

MOTION: Commissioner Green moved to approve an agreement with Evergreen Solutions, LLC to conduct a Classification and Compensation Study. Commissioner Pulcini seconded the motion which failed by the following roll call vote.

NO: Commissioners Shrouder, Pulcini and Meltzer

YES: Commissioners Green and Mayor Ross

20. Discussion on FY22/23 Budget - Commissioner Pulcini

Commissioner Pulcini advised he may not be able to attend the budget workshops so he wanted to speak on the budget today. He believes revenues may be understated and asked City Manager Napoli to review them. He also advised on page 40 the indirect cost was not increased with the 16% budget increase.

Commissioner Shrouder said the format the budget does not provide enough detail. The budget has us using funds from the Capital Improvement Fund but there is 0 dollars in that fund. There are changes in positions and additional positions proposed with no alert to the changes. There is very little details on the BSO increase. Also there is no specifics on capital purchases as indicated in previous budgets. He asked if every department director received this budget and if so when. CFO Kendrick answered no but all the directors helped to create the budget. Commissioner Shrouder asked if the budget was posted online. CFO Kendrick advised it was posted last Wednesday. Commissioner Shrouder said budgeting by positions was not included. CFO Kendrick answered the City Manager did instruct him to add the

discrepancies noted and revise the budget. Commissioner Shrouder asked if the positions will be added to the budget. CFO Kendrick answered they will be added to the budget in the notes area. Commissioner Shrouder asked if legally he can defund a position in the notes section. City Attorney Horowitz answered if there is a line item in the budget the Commission can amend it. The Commission

cannot set salaries but they can determined what positions can be funded.

Mayor Ross said salaries are within the City Manager's responsibilities.

Commissioner Shrouder said the budget is the Commissions job. He can play the video from a previous meeting were the Commission asked for salaries to be placed in the budget by line item as it has been done in previous budgets with the exclusion of last year.

City Manager Napoli said defunding means eliminating a line item. He advised the salary line is based on budgeting by position. His professional opinion is that it is not a prudent way of managing personnel in the city to budget by position but if the Commission wants to do so they can.

Commissioner Green said he does not believe it is the Commissions responsibility to run the City, it is their responsibility to set policy and the budget.

Commissioner Shrouder said on July 27, 2021 this body instructed the Manager to budget by position. Commissioner Shrouder would like to play the audio from that meeting.

Commissioner Meltzer agreed that was the decision and the City Manager will do so. The directors give their budget to the Manager and provide the personnel numbers they determine they need and that is the City Manager's determination on personnel numbers. However, if he sees a position that needs discussed he will do so.

Commissioner Shrouder said when he spoke to City Manager Napoli he said there was not a Commission directive. City Manager Napoli said he believed the previous budget met the intent the Commission asked for.

21. Discussion on the Budget Format, Procedure, and Timing – Commissioner Shrouder

Commissioner Shrouder said anything being changed should be indicated as such.

Commissioner Meltzer said red lines or strikeouts can be added.

City Manager Napoli agreed to annotate the items.

Commissioner Shrouder would like the budget in advance of the tentative millage resolution. He looked at neighborhood municipalities and they do receive the budget earlier. City Manager Napoli advised he has no issue in presenting the budget earlier.

CFO Kendrick said moving the budget process ahead causes issues as we do not have the necessary information needed to compose the budget.

Commissioner Meltzer suggested having the budget workshops earlier in 2023.

Commissioner Green said the proposed budget will not have the information needed to formulate it.

Commissioner Meltzer said we can have the workshops earlier to help determine preliminary rates.

CFO Kendrick advised the proposed budget is proposed and not final. However the budget will then run into the audit schedule. But he has no issue with presenting it earlier.

City Manager Napoli advised mid-June is a good time.

Commissioner Shrouder proposed the Deerfield Beach model with two back to back budget workshops in June dividing the departments.

Mayor Ross said dividing the process may not be good for resident's comments. He would also like to remove the virtual option from meetings.

CFO Kendrick advised the audit wraps up the end of April and he cannot have a budget complete 6 weeks thereafter.

Commissioner Pulcini said property values come out June 1st.

Commissioner Shrouder cited several municipalities that have budget meetings in June. He would like to find staff that can achieve the goal of June.

CFO Kendrick advised staff can work towards any goal put forth. He would prefer May and June to work on the budget as the budget is a combination of work done by all departments.

Commissioner Meltzer wants the information before voting on the preliminary rates.

CFO Kendrick advised the addition of new software will be able to assist him immensely.

Commissioner Meltzer would like to add the software presentation to a future agenda.

Commissioner Shrouder wants to know why this City is the only City that cannot make the June goal.

Commissioner Meltzer said they may need the software and tools to assist them that they don't currently have.

City Manager Napoli said staff will present the preliminary budget on June 15 with accompanying workshops thereafter. He also said other cities have a dedicated budget department which we do not.

Commissioner Shrouder would like the workshops in mid-June.

Commissioner Meltzer said he needs time to review the budget.

Mayor Ross believes two weeks after June 15 is acceptable.

Commissioner Meltzer wants the budget software to be discussed and looked into.

22. Discussion on Cooper City being listed on the State of Florida's "non-compliant local governments" list, the consequence of being non-compliant, and holding the City Manager accountable for the City violating State Law for the second year. - Commissioner Shrouder

Commissioner Shrouder said the Commission was told the City would submit the information required on time and for the second year we did not. He would like to hold the City Manager accountable for the consequence of violating State Law.

CFO Kendrick said he was the one who made that commitment and advised they did miss the deadline. He is disappointed in missing the deadline but is proud of the staff and himself for completing an audit two months prior to the previous year on a tighter time frame.

Commissioner Shrouder said using last year as a measurement is unacceptable. He advised he should have made a motion to fire the City Manager when excuses were given last year. He should have been informed of missing the deadline by the City Manager instead of reading about it online.

City Manager Napoli advised the ACFR was submitted online in time. The Annual Financial Report was not submitted on time. They have been in contact with the state to clarify the date of submission.

Commissioner Shrouder asked why the City Manager did not advise the Commission of the late submittal.

Mayor Ross said by the time City Manager Napoli found out to it was too late to notify. Communication is important.

Commissioner Shrouder asked why the federal website says we are late if the issue is with the State date. CFO Kendrick advised there was no secret when they finished the audit. They do have a number of exceptions such a holidays.

Commissioner Shrouder said it is a reoccurring theme that we are late on federal deadlines. He wants to speak on accountability. He asked what accountability we need to put in place.

Commissioner Green asked in terms of accountability what the Commission is going to do to set an example.

Mayor Ross said the accountability the Commission has is to the residents.

Commissioner Shrouder said the Commission completes ethics training on time and if not they are held accountable. For years the audit has been on time and the past two years it has not been. That timeline is determined by the state of Florida.

Mayor Ross asked the consequence of being late. City Attorney Horowitz advised there is a process under the legislative procedures that require if a city is late that a list goes to the Auditor General and he can refer the matter to the Legislative Audit Committee, they can conduct a hearing and the ultimate penalty can be the withholding of state funds.

Commissioner Shrouder asked if the ARPA monies is state funds.

Mayor Ross said we need to look to the future and this not occurring again.

City Manager Napoli said the staff reports to work every day to do their best. They do not come in with the intent of missing deadlines. We are a small staff that will at times miss deadlines. The reason for missing deadlines is due to the constant turnover of the Finance Director position. Moving forward we will not have these issues. He understands the limitations and capabilities of staff, there are 5 new directors in the City and he cannot overwhelm them with requirements until they are fully on board but he has no doubt next year they will meet all requirements.

Mayor Ross said he accepts the apology as he knows CFO Kendrick did his best. CFO Kendrick walked into the problem he was not the cause of the problem. However next year if there is the same issue the accountability will be severe.

Commissioner Shrouder said if staff is working hard there is a competency issue. They authorized staff to use an outside consultant to help with the audit. This is a deadline required by the State of Florida. He is not okay with an apology. He would like accountability.

Mayor Ross asked Commissioner Shrouder's idea on the accountability. Commissioner Shrouder advised he would replace the staff, and he would depart with the current City Manager. He is also asking the Commission what their idea is of reasonable accountability.

Commissioner Green said firing the City Manager is very unreasonable. He said in the past several years we have gone through a number of several department heads and staff. We have a small staff and we see the efforts put into the city. Firing the City Manager sends the wrong message to staff and is counterproductive. He is thankful for City Manager Napoli for moving this City forward as he has done. He said people make mistakes, he himself makes mistakes. It is important to uplift the staff so they can be successful. The City has been operating short staffed. The staff is not missing deadlines because they are not working.

Commissioner Shrouder said everyone makes mistakes, but his issue is not being informed about the mistake. He said he has very little communication with City Manager Napoli. He tried to have schedule an everyday phone call but that was not successful.

Commissioner Green said as a leader he needs to ask himself can I do something to facilitate better communication.

Commissioner Pulcini said all five Commissioners have different expectations.

City Manager Napoli said he provides information he believes is important. He sends a weekly update and he has to communicate what he thinks needs communicated. He said things do slip through. He advised he does not try to withhold information. He has regular standing meetings with each department head. He does want to meet the Commissions expectations.

Commissioner Meltzer said he does not believe the City Manager is trying to hide information. He said each Commissioners needs are different.

Commissioner Shrouder said pursuant to the Charter and State Law he can ask the Police Department for any public record he wants. However, the City Manager instructed the Captain to filter the information.

Mayor Ross said the City Manager filters the information through him for efficiency.

City Manager Napoli said the contract requires all communication to go through the City Manager.. Commissioner Shrouder said the contract does not supersede state law.

Commissioner Meltzer moved for a recess. Mayor Ross seconded the motion.

After a brief recess the meeting resumed.

Commissioner Shrouder would like an updated list from BSO directly. City Manager Napoli will have BSO provide the list to him. Commissioner Shrouder said he was informed that the IT Manager was leaving by seeing the job posting on the City website. City Manager Napoli advised after the individual submitted the resignation the commission was informed via email a few days later. Commissioner Shrouder stated he has brought up procurement issues previously and if one of the individuals in that department leaves he believes the Commission should be informed instead of reading about the job opening online. City Manager Napoli responded he was trying to work with that individual to retain her.

Commissioner Shrouder said he would like material items.

Commissioner Meltzer said there is a wide gap between what is material for each of the commissioners. He suggested Commissioner Shrouder write down his expectations and provide them to the City Manager.

Commissioner Shrouder does not want to find out about items from the news or the public.

Commissioner Meltzer does not believe the City Manager wants them to find out items from the news or public but he is human. He also does not believe he is withholding information purposely.

Commissioner Shrouder said he communicated to the City Manager that employees leaving was important to him. However again he was not informed.

Commissioner Shrouder asked the commission if they were aware of a licensing agreement to allow Franklin Charter School to use our property for one dollar a year.

Commissioner Meltzer was not aware of an agreement. He also suggested that the Commissioner write down what he expects with regard to communication with the City Manager and discuss it with him.

Commissioner Shrouder said the licensing of real property needs to be communicated to the Commission.

City Manager Napoli said he did speak to the Commission about a MOU.

Commissioner Meltzer asked that the agreement be sent to the Commission.

Commissioner Shrouder made a motion to suspend the City Manager. No second the motion died.

Commissioner Shrouder made a motion to let the City Manager know if there is another fail in communication he will be suspended and terminated. No second the motion died.

Commissioner Meltzer made a motion to adjourn the meeting. Mayor Ross seconded the motion.

City Attorney Horowitz read "A RESOLUTION OF THE CITY OF COOPER CITY, FLORIDA, ADOPTING A PROPOSED OPERATING MILLAGE RATE OF 6.125 FOR THE FISCAL YEAR 2022-2023 COMMENCING OCTOBER 1, 2022, THROUGH SEPTEMBER 30, 2023; SETTING A DATE AND TIME FOR THE FIRST PUBLIC HEARING TO CONSIDER THE TENTATIVE MILLAGE RATE AND TENTATIVE BUDGET AND A DATE AND TIME FOR THE FINAL PUBLIC HEARING TO ADOPT THE FINAL MILLAGE RATE AND BUDGET; PROVIDING FOR DIRECTIONS TO THE CITY MANAGER; AND PROVIDING FOR AN EFFECTIVE DATE" by title.

Commissioner Meltzer supports the ceiling at 6.125.

Commissioner Pulicini would support the roll back rate at 5.6 He would prefer to use ARPA funds.

MOTION: Commissioner Shrouder moved to call the vote. Mayor Ross seconded the motion which failed by the following roll call vote. (2-2) *Commissioner Green was not present on the dais.*

YES: Commissioner Shrouder and Mayor Ross

NO: Commissioners Meltzer and Pulcini

Commissioner Shrouder said this rate is not a ceiling this rate is sent out to the residents. He is not willing to raise the taxes on the residents. This item is being presented in a rush as it is due on August 4, 2022 and the resolution was amended earlier today. This is not acceptable. He asked how he is able to set a tentative millage rate without seeing the budget.

Commissioner Meltzer asked if the rate set tonight can be set higher.

City Attorney Horowitz answered under the statue the property appraiser advertises the tentative millage rate on the TRIM notice. In order to increase the rate it requires a separate notice to the residents.

Commissioner Meltzer asked how much less money the city will generate with the rollback rate.

CFO Kendrick answered around \$1.8 million dollars.

Commissioner Pulcini asked how much we received in ARPA funds. CFO Kendrick answered \$8.9 million.

Commissioner Shrouder said we have ARPA dollars coming in.

Commissioner Meltzer asked if we can apply those funds to operations.

CFO Kendrick answered there are elements we can apply to operations but there are limitations. Also, the Commission allocated all of the dollars already. However, they can be reallocated.

Commissioner Meltzer is in full support of lowering the millage his understandings is tonight they are setting a ceiling and can determine a definite number at the hearings.

Commissioner Shrouder said the only notice to the residents is this preliminary rate.

Commissioner Meltzer advised he is not prepared to set a final millage tonight.

CFO Kendrick advised this is a recommendation from staff.

Mayor Ross advised tonight is merely setting a cap.

Commissioner Pulcini said we have ARPA funds available.

Mayor Ross does not believe we need to spend more money on mailings to go above the preliminary number.

Commissioner Shrouder said the budget should have been presented earlier.

Commissioner Meltzer asked that the budget be presented earlier next year.

Commissioner Shrouder said they were never given a midyear budget review.

Commissioner Green stated staff presents the financials every month. This is a recommendation from staff based on what they do on behalf of the City day in and day out. Costs are going up and he supports the 6.125 millage rate.

City Attorney Horowitz advised if the proposed rate adopted at the first budget hearing exceeds the rate passed tonight every resident of the city needs to be noticed by first class mail at the City's expense at coordination with the Property Appraisers Office.

Commissioner Pulcini said we allocated \$2.5 million that was earmarked for a police department that is no longer needed. We should pass that savings on to the residents.

City Manager Napoli advised we can use the ARPA funds to plug into the budget because of lost revenue. However to cover those costs in the future we may need other measures.

Mayor Ross stated this is a tentative rate. Staff did not raise the millage with this recommendation.

Commissioner Pulcini asked if the TRIM notice will state a tax increase. City Attorney Horowitz advised the Department of Revenue would state it is a tax increase.

Commissioner Shrouder said we received ARPA funds and we wants to lower the taxes for the residents.

Commissioner Meltzer recommended 5.975.

CFO Kendrick advised that's a decrease in the budget of \$600,000.

City Manager Napoli advised this budget was very difficult. However if they can reallocate the ARPA funds it is possible.

Mayor Ross said Commissioner Pulcini was against using reserved funds to operate the budget but he is for using the temporary ARPA funds.

Commissioner Pulcini said the ARPA funds were issued to help the residents.

Commissioner Meltzer said he had no idea what the 2023 budget would look like when they allocated the funds.

Mayor Ross said the Commission needs to take into account the future and leaving the rate as is will avoid a possible tax increase in the future.

CFO Kendrick said the 6.125 creates \$1.7 million dollars additionally however BSO is an increase of \$1.6 million and we are currently \$933,000 into the fund balance to make this budget work.

Mayor Ross asked about the budget effect of the millage at 6.0. CFO Kendrick answered \$460,000.

Mayor Ross said he can see moving to a 6.0 at this time as it is a tentative ceiling.

Commissioner Shrouder said this item was presented late and some accountability needs taken into account.

Commissioner Shrouder moved to amend Resolution 22-28 to 5.875. No second the motion died.

Commissioner Meltzer moved to amend Resolution 22-28 to 5.925. Mayor Ross seconded the motion.

MOTION: Commissioner Meltzer amend Resolution 22-28 to 5.925. Mayor Ross seconded the motion which failed by the following roll call vote. (3-2)

Commissioner Meltzer asked City Manager Napoli if there are any big items that we may need for ARPA funds. City Manager Napoli answered a potential substation for the Fire department.

Commissioner Shrouder asked for a commitment that the rate will go down in the future.

Mayor Ross said we need to make the best decision for the residents.

Commissioner Meltzer said 5.875 would be the lowest millage rate we have had in Cooper City in 9 years without cutting services.

Mayor Ross said we can go down on the millage rate. He does listen and become educated and his opinion can change.

Commissioner Meltzer said we can potentially lower the rate during the budget process.

Commissioner Pulcini said we are either giving a tax decrease or we are not.

Commissioner Shrouder said he will be reasonable and agree to 5.875.

MOTION: Commissioner Shrouder moved to reconsider Resolution 22-28 as amended to 5.875. Mayor Ross seconded the motion which prevailed by the following roll call vote. (3-2)

Commissioner Shrouder asked when we received the finalized Fire Methodology Report. CFO Kendrick advised we received the report a few days ago but a revision was made earlier today.

Commissioner Shrouder said he received an updated resolution today as well. City Attorney Horowitz answered that was correct. Commissioner Shrouder stated he sees errors and the item refers to a cost allocation plan which we have yet to receive. CFO Kendrick advised the numbers used are from the previous cost allocation plan. He advised the difference is miniscule. However, there were category changes.

Commissioner Shrouder advised the information was received late and he would like to defer the resolution to be heard after the information is reviewed thoroughly.

Commissioner Meltzer and Mayor Ross had no issue with deferring to next week.

Commissioner Green is prepared to vote tonight.

Commissioner Pulcini said the indirect costs for Fire Legal Services are higher than what we have budgeted. He is okay with passing the Resolution and making corrections in the future.

Chris Wallace from Munilytics advised the costs were estimates based on the old cost allocation plan. The BSO costs and pension costs can also be adjusted.

Commissioner Shrouder said the assessment has costs going down for Fire. Mr. Wallace said the allocations are determined by call volume. Commissioner Shrouder said even if the City has 0 Fire calls there is a cost to having the fire truck. He asked if there is a better method that can be utilized. Mr. Wallace said the fire budget is based on the number of assigned personnel on the fire apparatus.

Commissioner Pulcini said we need to pass the resolution and we can always update the numbers.

Mayor Ross agrees with Commissioner Pulcini.

Commissioner Shrouder respects their opinions but is not personally comfortable until he can read the latest information in whole.

Commissioner Green asked if the City Manager supports the item. City Manager Napoli answered yes as long as when the time comes we utilize the funds for beautification.

Mayor Ross opened the public hearing with no one wishing to speak. Mayor Ross closed the public hearing.

MOTION: Commissioner Shrouder moved to approve Ordinance 22-18. Commissioner Pulcini seconded the motion which prevailed by a unanimous roll call vote. (5-0)

CITY MANAGER REPORT

31. Budget Amendment

City Manager Napoli advised this amendment is for Utilities to fill the fuel tanks for hurricane season.

32. Insourcing Line Marking for Utilities

City Manager Napoli advised this service can be transferred in house and once we purchase the equipment needed we will save approximately \$50,000 a year.

33. Fire Apparatus Update

City Manager Napoli advised staff has working to obtain all cost estimates.

Commissioner Meltzer thanked staff and the City Manager for bringing services in house and we wants to continue to look at services that we can possibly bring in-house.

CITY ATTORNEY REPORT

City Attorney Horowitz advised it is a privilege for himself and his law firm to represent the City. He also advised the declaratory action on behalf of the City Clerk against candidate Joshua Giancarlo who has been qualified to run for the District 1 Commission seat has been decided. The Judge rendered her order finding Mr. Giancarlo to be qualified under the City Charter. He advised it was the City's position from the onset of the issue, that the City's interest in this matter was not whether or not Mr. Giancarlo should be qualified but to ensure all candidates who are qualified met all the requirements under the City Charter. There is no dispute that the Charter requires a candidate to reside in their district for one year prior to qualifying. What the court determined was that Mr. Giancarlo met that requirement.

Mayor Ross asked about options left to the City, including an appeal. Mayor Ross said this is a case of first impression and a good intellectual legal issue that will make good law if it is appealed.

Commissioner Meltzer asked City Attorney Horowitz opinion.

City Attorney Horowitz advised the City does not have an opinion on who is qualified to run. The only interest is insuring they are qualified under the City Charter. Weather he agrees with the judge's opinion is irrelevant. As a municipal attorney he does agree this is a good intellectual legal issue.

Commissioner Shrouder said the order does not cite any law to help provide clarification. He believes the order strikes down the one year requirement. He believes that is a challenge to the ordinance or charter amendment.

City Attorney Horowitz advised he believes the legal issue would be the impact of redistricting on a residency requirement.

Commissioner Shrouder said he believes there is a 30 day requirement to challenge redistricting. He does not believe the order is correct.

Commissioner Green said the City Clerk did what she believed what was correct in having the court render an opinion. The City went above and beyond to address the concern and the judge made the ruling.

Commissioner Shrouder said there was no law cited in the order.

Mayor Ross said this is something we can make law on behalf of Cooper City and every municipality in the state of Florida.

Commissioner Shrouder asked the potential cost. City Attorney Horowitz said the declaratory action costs were approximately \$6,700 and he would anticipate the same amount for an appeal.

Commissioner Meltzer wants to know if we would prevail.

Mayor Ross said if we appeal they will enforce the charter.

Commissioner Meltzer said it was said we would succeed with the declaratory action and we did not.

Commissioner Shrouder said it would have been nice to know why we did not succeed with law, and no law was cited. He said we will receive a full opinion from the Fourth District Court of Appeal.

City Attorney Horowitz advised the City is not looking for a certain conclusion.

Mayor Ross is pushing for an interpretation of the charter.

Commissioner Shrouder said the issue was not narrowed at first.

Commissioner Green said the City already asked the Judge to make a decision.

Commissioner Shrouder stated this is a process. The process is not over.

Mayor Ross said he is looking at the interest of the citizens of the City.

Commissioner Green said he believed the declaratory action would be the final step. He does not believe we should appeal.

Mayor Ross said the Judge disregarded the Charter.

Commissioner Green asked if the Judge's ruling disregarded the Charter. City Attorney Horowitz advised her ruling interpreted the Charter.

Commissioner Shrouder asked who interprets the charter. City Attorney Horowitz answered under case law the commission, if there is a question as to the interpretation the court decides. Commissioner Shrouder said we need to ask the Fourth District Court of Appeal.

MOTION: Commissioner Shrouder moved to direct the City Manager and the City Attorney's Office to appeal the decision regarding the Joshua Giancarlo qualification. Mayor Ross seconded the motion which prevailed by the following roll call vote. (4-1)

YES: Commissioners Shrouder, Meltzer, Pulcini and Mayor Ross

NO: Commissioner Green
