SUBJECT: Motion to approve the purchase of a Fire Apparatus (1 Ladder, 1 Rescue)

CITY MANAGER RECOMMENDATION:

The City Manager recommends a motion to approve the purchase of a Fire Apparatus (1 Ladder, 1 Rescue)

BACKGROUND OF ITEM:

The City's fire-rescue services are provided by contract with Broward Sheriff's Office (BSO). While BSO provides the staffing and fleet maintenance, the City is responsible for the purchase of the apparatus. In reviewing the current fleet, there are apparatus that need replacement, including the following:

ANALYSIS:

There is the need to maintain similar units in our fleet, to allow for consistency of operation within all units and consistency in mechanical support and parts. The City obtained quotes for apparatus and recommends authorization to procure the following:
