MINUTES

PLEDGE OF ALLEGIANCE

Mayor Ross opened the meeting at 6:30 PM and led the assembly in the Pledge of Allegiance.

ROLL CALL

Present were Commissioners Shrouder, Meltzer, Pulcini, Green, and Mayor Ross.

CHANGES TO AGENDA/EMERGENCY MATTERS

City Manager Napoli stated items 10-16 are being deferred from the agenda.

PROCLAMATIONS/PRESENTATIONS

A Proclamation for Red Ribbon Week was presented to Melissa Sauer and Pfc. Bruce W. Carter

A Proclamation for 50th Anniversary of Rotary Club of Davie-Cooper City presented to Club President Michael Roland and President-Elect Teri Manyak.

Commissioner Pulcini recognized Pastor Mark Hattabaugh and Pastor Paul Volan for Boxes of Hope to over 2,000 City of Cooper City families.

Pastor Volan shared Boxes of Hope will be held on November 20[,] for pickup this year. Residents can request a box online at <u>coopercitychurch.org</u>. He also shared details of the Advance Camp they will be hosting in December for at-risk young men.

PUBLIC SPEAKING

Open Public Meeting

Paul Higdon spoke on the reconsideration on the two employees. Spoke on the morale of the city employees.

Ariel Bendor, 3510 NW 94th Avenue, apologized for his behavior at the Special Magistrate meeting. Wants Commission to make an amendment for the "Sugarland" area, trimming trees, and landscaping pickup. Mayor Ross responded.

Susan Stewart thanked the Commission for trying to make the city beautiful. Spoke on the morale of the city employees.

Brenda Kezar, 4979 SW 90th Way, noted she was going to miss Ms. Sims. She also asked Joe to rescind his resignation.

Cheryl Ellett spoke about the reconsideration of Bill Ellett's position with the City. Mayor Ross reiterated the item has been deferred but will be addressed later.

Andrew Gross, 5010 Regency Isles Way, spoke on the amazing work by Mr. Napoli and said it would be a shame to lose him.

LAND DEVELOPMENT MATTERS

Resolution 21-51 (Community Development Department)

City Attorney Horowitz read "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, APPROVING THE CONDITIONAL USE PETITION #CU 6-3-21, FROM SPG COOPER CITY II TR (OWNER) AND DIANE FERNANDEZ (PETITIONER) FOR THE APPROXIMATELY 8.5 ACRES OF REAL PROPERTY GENERALLY LOCATED AT 12399 S.W. 53rd STREET, SUITE 102; APPROVING AND AUTHORIZING THE USE OF THE PROPERTY FOR A VOCATIONAL EMPLOYMENT AND LIFE SKILLS TRAINING CENTER FOR ADULTS WITH DEVELOPMENTAL DISABILITIES; PROVIDING FOR CONDITIONS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE" by title.

Mayor Ross asked the Commission for Disclosures.

Commissioner Green has none.

Commissioner Pulcini has none.

Commissioner Meltzer disclosed he was at the Planning & Zoning meeting on the 1st.

Commissioner Shrouder disclosed the applicant reached out prior to submitting an application and he referred her to Community Development.

Mayor Ross disclosed he attended the Planning & Zoning meeting and spoke to Ms. Fernandez prior to the application.

Assistant Director Jason Chockley gave the staff report.

Diane Fernandez, applicant, stated Mr. Chockley gave a precise report.

Commissioner Green expressed his concern on parking, specifically guest parking spaces. Ms. Green noted all visitors are by appointment only and scheduled ahead of time, so she does not anticipate any concerns with the number of visitor parking spaces.

Commissioner Shrouder asked the City Attorney to mark exhibit "A" appropriately.

Commissioner Meltzer spoke on his preference for this parking staying with the business and not with the property.

Mayor Ross opened to public comments.

Susan Stewart resides close to the area and expressed concerned about traffic and non-residents roaming around their neighborhood.

Commissioner Meltzer explained that the traffic is not going to be too bad.

Commissioner Shrouder explained that this is a special-needs facility and will be good neighbors and they will not be out roaming the neighborhoods since they require close supervision.

Mayor Ross noted when you look at future predictions you can only look at history and Ms. Fernandez was a good neighbor at the last place.

City Attorney Horowitz mentioned the condition that the Planning & Zoning Board placed upon the conditional use.

MOTION: Commissioner Pulcini moved to approve amended resolution to include condition recommended by Planning & Zoning regarding the conditional use. Commissioner Shrouder seconded the motion which prevailed by a unanimous roll call vote (5-0).

Resolution 21-52(Community Development Department)

City Attorney Horowitz read "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, GRANTING THE REQUEST FOR VARIANCE PETITION #V 6-5-21, ATTACHED HERETO AS EXHIBIT "A" AND INCORPORATED HEREIN, FROM SPG COOPER CITY II TR FOR THE PROPERTY GENERALLY LOCATED at 12399 S.W. 53rd STREET, SUITE 102 IN COOPER CITY, FLORIDA, TO DECREASE THE REQUIRED PARKING RATIO FROM 1/100SQ/FT (147 SPACES) TO 1/450SQ/FT (32 SPACES) AND TO INCREASE THE MAXIMUM ALLOTED PERCENTAGE OF COMMUNITY ASSEMBLY FROM 25% TO 36%; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE " by title.

Commissioner Meltzer spoke about the assembly use increase of 44% and not 11%.

Commissioner Shrouder offered if traffic issues do arise, the applicant will resolve the issue as prescribed by the City on a timely manner.

Commissioner Green expressed concern about some of the findings to include in the resolution because they are presenting hypotheticals.

Mayor Ross opened to public comments. No public comments.

Mayor Ross asked the Commission for Disclosures. No disclosures.

Commissioner Shrouder inquired whether this variance was specific to the applicant. Attorney City Horowitz confirmed it is not, but it can be added.

MOTION: Commission Shrouder moved to approve Resolution 21-52 with modifications to the resolution to include the findings and that the variance is specific to the applicant. Commissioner Meltzer seconded the motion, which prevailed by a unanimous roll call vote (5-0).

MOTION: Commissioner Meltzer moved to approve the minutes of the consent agenda. Commissioner Pulcini seconded the motion which prevailed by a unanimous roll call vote (5-0).

REGULAR AGENDA

Motion to approve agreement with Mueller System, LLC for software and services associated with the City's advanced metering infrastructure and electronic water meters – Utilities

MOTION: Commissioner Green motioned to approve the agreement with Mueller System, LLC for software and services associated with the City's advanced metering infrastructure and electronic water meters. Commissioner Pulcini seconded the motion which prevailed by a unanimous roll call vote (5-0).

Cooper City, FL

Mike Bailey spoke on the priority software and services from Mueller. He confirmed it's necessary, is budgeted this year, and cost \$59,341.

Motion to Approve Purchase of Sewer Cleaning Equipment – Utilities

MOTION: Commissioner Meltzer motioned to approve purchase of the sewer cleaning equipment. Commissioner Green seconded the motion which prevailed by a unanimous roll call vote (5-0).

Items 10-16 deferred.

Motion to add a Technology Deputy - Commissioner Shrouder

MOTION: Commissioner Shrouder motioned to approve the deputy funded by ARPA with an amendment to the BSO amendment that the position thereafter is charged in accordance with contract language and approved budget payroll.

Mayor Ross asked if it could be paid by LETF funds. City Manager Napoli noted it would be prudent to use ARPA.

Commissioner Shrouder explained why it is good to have this position.

Captain De Giovanni noted, on a regional level, no other city has this position. This position will allow a more efficient and strategic response with technological strategies throughout the City. He noted any information that is gathered is a matter of public record and FDLE guidelines protects that personal identifying information.

Commissioner Green expressed concerns regarding the \$175,000 compensation coming out of the City's budget after the ARPA funds are spent.

Commissioner Green asked if BSO currently has the capability.

Captain De Giovanni confirmed they have the capability on a regional level.

Commissioner Green expressed concern that other districts will want to utilize the Technology Deputy as a regional asset.

Captain De Giovanni responded the contract protects that from happening. He also reminded the Commission they can remove or amend the position at any time.

Commissioner Shrouder explained the ARPA funding allows this position allows fill a gap of the four law enforcement positions that were cut during the pandemic.

Mayor inquired whether there is grant funding that can be identified post the three-year ARPA funding for this position.

Captain De Giovanni answered the COP grant is the largest one and he is willing to gather information and discuss with the City Manager.

Commissioner Green clarified with the City Manager Napoli that position will be paid from ARPA funds and not the City budget for three years.

City Manager Napoli responded yes, provided the Commission appropriates it that way. He noted it's pro-rated this year and then full funding for FY23 and FY24.

MOTION: Commissioner Shrouder motioned to adopt the amendment. Commissioner Pulcini seconded the motion which prevailed by a unanimous roll call vote (5-0).

REGULAR RESOLUTIONS

Resolution 21-50 (Utilities)

City Attorney Horowitz read "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, APPROVING AND AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE A WATER & SEWER DEVELOPER'S AGREEMENT JORGE FORTICH, 3541 NW 96 AVENUE, ROYAL PALM RANCHES, FLORIDA, 33024 ATTACHED HERETO AS EXHIBIT "A" AND INCORPORATED HEREIN; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE" by title.

MOTION: Commissioner Meltzer motioned to approve Resolution 21-50. Commissioner Green seconded the motion, which prevailed by a unanimous roll call vote (5-0).

Commissioner Meltzer asked if Commissioner Shrouder's concerns have been met.

Commissioner Shrouder replied yes.

Resolution 21-53 (Finance/Public Works)

City Attorney Horowitz read "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, APPROVING AND AUTHORIZING THE EXECUTION OF THE SECOND AMENDMENT TO THE INTERLOCAL AGREEMENT WITH BROWARD COUNTY FOR SOLID WASTE DISPOSAL SUPPORT SERVICES" by title.

MOTION: Commissioner Pulcini motioned to approve Resolution 21-53. Commissioner Green seconded the motion, which prevailed by a unanimous roll call vote (5-0).

Commissioner Shrouder asked about the decision date.

Gabriel Guerrero noted they need to notify Broward County know by November 19 and County must make decision by January 15, 2022. He noted there are currently 19 participating cities.

Commissioner Shrouder noted there is an assumption the City is getting a better rate as being part of the Interlocal Agreement. He would prefer to know the rates.

Discussed ensued about the benefit of a cooperative agreement.

Item deferred to November 16th meeting.

Commission asked Mr. Guerrero to find out how much the non-participating cities are paying.

ORDINANCES ON FIRST READING

Ordinance 21-25 (Finance)

City Attorney Horowitz read "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING ORDINANCE NO. 20-9-3, ADOPTED ON SEPTEMBER 23, 2020; PROVIDING FOR AN AMENDED BUDGET FOR FISCAL YEAR 2020-2021 FOR THE CITY, ATTACHED HERETO AS EXHIBIT "A" AND INCORPORATED HEREIN; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE" by title.

MOTION: Commissioner Green motioned to approve Resolution 21-25. Commissioner Pulcini seconded the motion, which prevailed by the follow roll call vote.

NO: Commissioner Shrouder

YES: Commissioners Meltzer, Pulcini, Green, and Mayor Ross.

Commissioner Meltzer asked if this would include the payment to the debt service.

Ordinance 21-26 (Commissioner Shrouder)

City Attorney Horowitz read "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING CHAPTER 6 OF THE CODE OF ORDINANCES, ENTITLED "BUILDINGS AND BUILDING REGULATIONS," TO CREATE ARTICLE VIII, TO BE ENTITLED "VACATION RENTALS;" PROVIDING FOR THE REGULATION OF VACATION RENTALS AS DEFINED HEREIN; PROVIDING FOR DEFINITIONS, PROCESS FOR ISSUANCE OF VACATION RENTAL PERMITS, REQUIREMENTS, REGULATIONS, AND STANDARDS FOR VACATION RENTALS, COMPLIANCE INSPECTIONS, SUSPENSION AND REVOCATION OF VACATION RENTAL PERMITS; PROVIDING FOR PENALTIES AND ENFORCEMENT; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING AN EFFECTIVE DATE" by title.

MOTION: Commissioner Shrouder motioned to approve Resolution 21-26. Commissioner Pulcini seconded the motion, which prevailed by a unanimous roll call vote (5-0).

Commissioner Shrouder noted they thought short-term rentals only affected beach communities and have found out it is not true.

City Attorney Horowitz noted the State law does have several provisions that address and limit a municipality's ability to regulate short-term rentals. The City cannot ban them and cannot regulate duration and frequency. He confirmed this ordinance is consistent with Florida law, enforceable, and with the purview of the Commission to consider.

Commissioner Meltzer agreed this is step in the right direction.

Mayor Ross spoke about the legislation in Tallahassee. He indicated he is not opposed to this.

Commissioner Shrouder suggested incorporating the municipal prosecution process in the penalty provision.

CITY MANAGER REPORT

City Manager Napoli thanked staff for the Halloween events.

He advised they will be coming back to the next meeting with additional information some of the ARPA projects.

He asked for some guidance on the Public Safety Advisor. He proposed to go to a third party for an assessment. Would like direction to move forward.

Commissioner Pulcini noted they should follow the procedure provided by the City Manager from the Department of Justice, which shows how to open a Police Department.

Mayor Ross noted the first step is a feasibility study.

Commissioner Meltzer wants to make sure there is a separation between whoever is conducting the study and the position.

Commissioner Shrouder advised the financial aspect is the most important part.

City Manager Napoli noted Kathryn Sims' last day and thanked her.

CITY ATTORNEY REPORT

City Attorney Horowitz spoke on the BSO Confiscation Funds and his outreach to two specific attorneys. Both were able and ready to take on the assignment but not on a pro bono basis.

He also spoke on the modification to the settlement agreement for the confiscation funds.

Commissioner Green would like City Attorney's office to work with BSO to come to an agreement.

Commissioners Pulcini and Meltzer both agreed with Commissioner Green.

Commissioner Shrouder noted he was originally looking for something less formal from the attorneys and agrees with Commissioner Green today. He asked whether they could provide the attorneys the documentation that was provided to the Mayor and see if they can provide an opinion on whether they have a case or not. They are not asking for a written opinion.

City Attorney Horowitz does not have any problem with that direction.

City Attorney Horowitz continues to search for head hunting firms in pursuit of the next City Manager. To date, he has reached out to a dozen Florida firms and is waiting for proposals from two firms.

Discussion ensued about the City Manager and succession plan.

City Attorney Horowitz explained the City Charter does provide for an Acting City Manager, in the event of absence or disability but does not include any provision for an Interim City Manager. It requires the current City Manager to designate, by written designation, to the Commission, who that individual would be and is subject to Commission approval.

MOTION: Commissioner Shrouder motion to approve Mike Bailey as Acting City Manager. Inaudible seconded the motion, which prevailed by the following roll call vote.

NO: Commissioner Green **YES:** Commissioners Shrouder, Meltzer, Pulcini, and Mayor Ross

POLICE CHIEF'S REPORT

Captain De Giovanni thanked Mayor Ross and the City Manager for going to the memorial today. The Department received recent positive feedback about school traffic mitigation. He spoke on the unfortunate bicycle accident on Stirling Road and the recovery of the victim. He spoke on the continued code enforcement efforts in the Timberlake Plaza.

In the crime update, he noted they installed a solar license place reader in Flamingo West Park. He noted burglary and package thefts increase during this time of year. He provided a reminder about Operation Front Porch, which allows residents to have their packages delivered to the local police station, beginning the week before Thanksgiving. He spoke on a recent stolen vehicle and how residents are leaving their spare key FOBs in their center console.

Captain De Giovanni spoke on the relaunched Police Explorer's program. To support fundraising efforts, the Police Explorers will be responding with personalized letters to any kid who drops off a letter to Santa at the Police Station. Every Thursday, they will deliver Santa's response to each child.

There is a suggested donation to the Police Explorer's program. They are also collecting new unwrapped gifts at the Police Station.

Captain De Giovanni advised he has two vacancies.

Commissioner Shrouder asked a question about fines from the special magistrate meeting minutes.

City Attorney Horowitz read the Code and reduction of fines.

Commissioner Shrouder wants consensus on changing Ordinance 13-73 with a modification that make any fine mitigation over \$5,000 would be approved by the City Commission.

City staff will bring back more information and data about specific criteria regarding to the Ordinance.

Captain De Giovanni recommended an effective date for the Technology Deputy position as January 15, 2022. Commission reached unanimous consensus.

Commissioner Pulcini thanked the Captain and his staff.

City Manager Napoli noted tomorrow is the Marine Corps birthday and wished the Captain a happy marine's birthday.

FIRE CHIEF'S REPORT

Chief Bishop thanked Kathryn Sims. He reported call volume is up 9% from last year. He shared Rescue 228 is out of service due to mechanical. Rescue 28 was involved in a minor accident but no damage. At the last Commission meeting, he reported the platform was in service but the next day it was out of service due to mechanical and has been replaced with the spare aerial device. Hydrants training is on track because ISO will be next year.

Mayor Ross asked if the increase in the 9% is because of the first-available ILA that was recently signed.

Chief Bishop responded no. That ILA has not gone into effect yet. He anticipates that closer to the first of the year. In 2020 they had 12 rollovers. This year is 16. They had 173 medical alarms last year. This year is 193. They had 176 accidents with injuries last year. This year is 179.

Commissioner Pulcini asked about the special fee structure for ALFs and how much has been collected for non-transport calls.

Chief Bishop advised the non-transport calls have greatly reduced this last year.

COMMISSIONERS' CONCERNS/REPORTS/ITEMS TO BE PLACED ON NEXT AGENDA

Commissioner Green noted a good meeting tonight and thanked Ms. Sims. He asked City Manager Napoli to rescind his resignation.

Commissioner Pulcini thanked Ms. Sims, the staff, and the City Manager.

Commissioner Meltzer thanked Ms. Sims. He expressed concern that the Business Expo vendors don't have the ability to submit applicant online and vendor payment online. City Manager Napoli will see about using RecTrac.

Commissioner Shrouder advised being one step towards the 20th century with Technology Deputy. He suggested more adding strategic planning session to January's agenda. He asked when the strategic plan will be presented. City Napoli responded it will be presented on November 30. He asked if HR will be posting the City Manager position online.

Discussion ensued about the application process.

Mayor Ross thanked Ms. Sims. He also thanked Captain De Giovanni for a recent response. He also spoke on the Veterans Memorial. He inquired about an update on the traffic study. He mentioned City Manager Napoli can rescind his resignation or extend his resignation date as well.

ADDITIONAL PUBLIC COMMENTS (2 MINUTES)

Jim Federici spoke about traffic challenges on Hiatus Road, Embassy, and Stirling traffic lights. He asked if there was funding allocated to redo the ball fields. Staff confirmed ARPA funds are being used to address drainage issues at Bill Lips. He also noted there is significant draining issues at Suellen Fardelman fields. He wished Ms. Sims good luck.

Cheryl Ellet asked for clarification on Item 20. Staff confirmed it is budget ending FY21.

The meeting was adjourned at 9:37 p.m.
